AN ACT to amend the Excise Tax Rate Act 1984 ("Act").

[4th July 2023]

BE IT ENACTED by the Legislative Assembly of Samoa in Parliament assembled as follows:

1. Short title and commencement:

- (1) This Act may be cited as the Excise Tax Rate Amendment Act 2023.
- (2) This Act commences on the date of assent by the Head of State, except for Columns 5 and 6 of the Schedule to commence on the dates as specified in the Schedule.

2. Schedule amended:

The Schedule of the Act is amended by the Schedule of this Act.

3. Consequential amendments:

The Schedules of the Customs Tariff Act 1975 is amended where relevant by the amendments brought into effect by this Act.
