AN ACT to amend the Excise Tax Rates Act 1984 ("Principal Act"). [21st March 2018]

**BE IT ENACTED** by the Legislative Assembly of Samoa in Parliament assembled as follows:

#### 1. Short title and commencement:

- (1) This Act may be cited as the Excise Tax Rates Amendment Act 2018.
- (2) This Act commences on the date of assent by the Head of State.
