

EXCISE TAX RATES AMENDMENT BILL (No. 2) 2018


Explanatory Memorandum

1.0 Object and reasons:

- 1.1 The Bill seeks to make amendments to the Schedule of the Excise Tax Rates Act 1984 by replacing rates for tariffs for certain items with new tariff rates.
- 1.2 The object of the Bill:
- (a) is to increase the excise tax rates for local produced spirits to 100% from the current excise tax rate charged following the government's revenue review completed in 2016; and
 - (b) to limit the content for all alcohol to 40%.

Clauses:

- Clause 1: - provides for the short title and commencement.
- Clause 2: - provides for the amendments in the Schedule.
- Schedule: - provides for increased excise tax rates for local produces spirits to 100% and to limit the content for all alcohol to 40%.

AN ACT to amend the Excise Tax Rates Act 1984 (“Principal Act”).

BE IT ENACTED by the Legislative Assembly of Samoa in Parliament assembled as follows:

1. Short title and commencement:

- (1) This Act may be cited as the Excise Tax Rates Amendment Act 2018 and shall be read together with and form part of the Principal Act.
- (2) This Act commences on the date of assent by the Head of State.

2. Amendments to the Schedule:

The Schedule of the Principal Act is amended in the Schedule of this Act by:

- (a) repealing the descriptions in Column 2 of each of the tariff items in Column 1, and inserting the new descriptions under Column 4; and
- (b) repealing the Rate of Excise under Column 3 for the same tariff items in Column 1, and inserting the amended Rate of Excise under Column 5.
