**Afioga Hon FAUMUINA TIATIA FAAOLATANE LIUGA:** Mr Speaker I move a motion, *That the Central Bank of Samoa Amendment Bill be read a second time and I will clarify on it.* 

Seconded by the Deputy Prime Minister, Minister for Communication and Information Technology and Minister of Women, Community and Social Development.

MR SPEAKER: I call upon the Hon Minister for his clarification speech.

Afioga Hon FAUMUINA TIATIA FAAOLATANE LIUGA: Mr Speaker and the respective members of the House it is well known that our coins; \$2, \$1, .50cents, .20cents and .10cents were changed in the year 2012. The law at the moment states that there is no time limit imposed on the returning of the old coins to the Banks. Therefore, the amendment will place a due date for this process so that it will speed up the process of old coins coming in. The process of changing these coins to the new ones are very difficult and so these coins must be brought in immediately. Furthermore it is so these silver coins may be transported back to Australia.

MR SPEAKER: The floor is open for debate. The Amendment Bill is not very big, it is merely about the returning of the old coins. I would like to greet the Leader of Opposition, you may stand.

# Central Bank of Samoa Amendment Bill 2014 - second reading

Afioga Hon Palusalue Faapo II (Leader of Opposition): Mr Speaker, I thank you for this opportunity. With all due respect I stand to make a very brief statement towards this very important Amendment Bill.

The amendment given states that there will be a cessation on the old coins being brought in and the exact date should be clearly stated. At the moment I believe that the Amendment is clear on the due date for the old coins to be handed in.

Mr Speaker our main concern is the peoples right to their money. It is not easy to come with these coins only to be notified later that it is too late. Where are the peoples rights and how are their interests protected when they find out too late? It is not easy to earn money, for our electricity bills and for the necessities of life only to find out it is too late and will no longer be accepted.

Mr Speaker we recommend the Hon Minister consider the people of Samoa and what they will be faced with as a consequence.

MR SPEAKER: I understand your concern and queries. I call upon the Hon Prime Minister.

Susuga Hon Tuilaepa Fatialofa Lupesoliai Aiono Neioti Sailele Malielegaoi: Mr Speaker I would like to clarify something. I am shocked that you would hold on to your old coins for so long. It has been nearly ten years since those old coins ceased to be used. However there are still a few coins here and there that have not been brought in. I myself have maybe \$1 still lying around and these coins are not used to pay your bills. I am surprised because it has been long ceased by the Central Bank.

Perhaps the only people who would still be in possession of these old coins would be the Business people overseas wanting to hold on to them.

The business people believe that if you hold these valuables for a long time by the time you return it the value would be great. Our people do not have these large sums of money anymore and we must think of the politics, these are very old politics.

Mr Speaker these monies are old and are no longer valuable.

MR SPEAKER: I call upon the member for Faleata West.

Tofa LEALAILEPULE RIMONI AIAFI (Faleata West): Mr Speaker I fully support the Amendment Bill. However there is just one recommendation to the Hon Minister of Finance with regards to the small size of these new coins. The old coins were nice and heavy, and even though there was not that much money in my pocket, the tinkering noise in my pockets assured me that there is indeed money in there. But with the new coins it seems like there is nothing there.

## Central Bank of Samoa Amendment Bill 2014 - second reading

That is why I query the Hon Minister if there are any other plans to try and thicken the size of our new coins. If it were possible to make these coins a bit bigger.

MR SPEAKER: I believe I understand what the member is concerned about. We have already made these new coins so the request to make these suggested alterations cannot be addressed. However the main purpose of this Amendment is to set an official date for all the coins to be returned to the bank.

I call upon the Hon Minister for a response – I beg your pardon Hon Minister there is a question from the Leader of Opposition.

**Afioga Hon PALUSALUE FAAPO II:** My time has not finished Mr Speaker, with all due respect.

MR SPEAKER: Leader of Opposition please be brief.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker I would like to clarify the reasons why people tend to hold on to their money rather than bringing it in. As the Hon Prime Minister has stated people believe the longer you keep money the higher the value. This is why people are hesitant; they also want to keep it as a souvenir. But what about now? You come with your \$100 and it is no longer valuable. That is something the Hon Minister should consider looking into.

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MALIELEGAOI: Mr Speaker I wish to elucidate that this is not practiced here in Samoa. It is only practiced overseas with countries like Britain and America. They place great value in collecting old money from all over the world.

There was once a man I with a quarter in America and it was worth close to \$1 milion. This is not done here. What idiot would do that here?

The important thing is to take out these old coins because it has become a nuisance. Notices were given out a long time ago for them to be brought in and yet people are still sitting around with it. The only people who will keep this money are the very wealthy ones like the Leader of Opposition, the member for Falealupo and the member for Faleata West. These two are not talking and I suppose they are letting their leader talk for them. The only member who is sounding more accurate is Leala even though he is being foolish.

**Afioga Hon PALUSALUE FAAPO II:** Mr Speaker I will not dwell on the topic any further. I simply wish to remind you of the peoples rights to their own money. The country is listening in.

# Central Bank of Samoa Amendment Bill 2014 - second reading

MR SPEAKER: I call upon the Hon Prime Minister.

Afioga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MALIELEGAOI: I was talking about the rights of a person with reference to the Leader of Opposition and the member for Faleata West and member for Falealupo. If you bring in \$1 tala the amount you will receive is still \$1 tala before the closing date. But for you two, you can take your money to America and hopefully get \$1 milion in the next 200 years or so.

Mr Speaker I feel sorry for the people because that is the real issue here. There are no people wanting to do this. Like I said before, there is no use for this money. I found \$1 in my desk this other day and I threw it away because it no longer has any value.

Afioga Hon FAUMUINA TIATIA FAAOLATANE LIUGA: Mr Speaker I am very thankful for the Hon Prime Ministers clarification.

Money is supposed to be saved in the bank; not in the house. The Communist uses this system of storing their money in their house, or in their pillow cases or sometimes digging a hole in the house to store their money. The reason why they do this is to avoid paying taxes.

The matter which the Leader of Opposition raised with regards to the peoples rights is inappropriate considering the reasons for this amendment. We are considering the peoples rights to be notified, giving them the opportunity to exchange their money before it is too late. However if a person wishes to keep it as a souvenir then that is good, that is their right.

The recommendation by the member for Faleata West with the size of the new coins is that it is cheaper to have them weigh less. The heavier they are the more expensive it will get. Nevertheless these changes are better for we have pictures of our beautiful country on and also the picture of our Head of State. Thank you to the respective members of the Parliament.

**Tofa LEALAILEPULE RIMONI AIAFI:** Thank you. I wanted to query clause 5 with reference to Communication. Chairperson, please clarify the correction please. At the moment the reports being tabled in Parliament are both in Samoan and English. So my question is whether the communication amongst Government Ministries will follow suit in order to simplify things. For instance I had thought that reports would be in a, e, and i but instead they are still in a, b, c. That is what I wanted to know Chairperson. Thank you.

### Samoan Language Commission Bill 2012 - consideration in detail

MR SPEAKER: I call on the Chairperson.

Tofa LENATAI VICTOR FAAFOI TAMAPUA: Thank you for the question. The subject which is being questioned on the usage of a, e, and i in our Bills is very difficult to alter because as we consulted the Attorney Generals office, their records state that the English must still be used. That is all I will say for now. But the matter being questioned; it is clear that it is the Samoan language and the official language. It is not saying the Official Language. Both languages are available to be used. Thank you.

Tofa LEALAILEPULE RIMONI AIAFI: Mr Speaker ...

MR SPEAKER: I call on the member for Faleata West to stand again.

Tofa LEALAILEPULE RIMONI AIAFI: I had hoped that the Chairperson would explain the actual reason why the English a, b, and c are still being used. The Bill clearly states that the Samoan Language be the Official Language. However when we ask, you claim that the Official Language and the Samoa language should be used. So I am wondering which the official language is; Samoan or English. I had always thought that the Samoan Language was the Official language. Thank you.

MR SPEAKER: I give the opportunity to the Hon Minister, perhaps he knows more about it because it is his Ministrys Bill. Hon Minister please stand.

Afioga Hon MAGELE MAUILIU (Minister of Education, Sports and Culture): When this Bill is approved the Official language would be Samoan. The communication amongst Ministries as questioned, use both the Samoan and English languages.

I write my letters to other Government bodies in Samoan and they sometimes respond in English. However this Bill is so that no one else can come later on and change it; to make the Samoan Language Official. Thank you.

**MR SPEAKER:** Thank you. I believe we are in full understanding. I give opportunity to the Hon Prime Minister.

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MALIELEGAOI: Mr Speaker I would like to elaborate more on the Chairpersons statement. This is the first time that a Bill has been passed to legally provide for the Samoan language and utilize it since our country became independent.

### Samoan Language Commission Bill 2012 - consideration in detail

The history of this bill began when the our citizens traveled to New Zealand, Australia and America with our language and over the years it has become a language that is being taught in those Communities. So a thought came to mind on the origin of the true Samoan language. Where should the accuracy of the Samoan language come from? Furthermore, various conferences were held by those who are known as the *Lauia* or foundation of the Samoan language on the teaching of the Samoan language in countries like New Zealand, Australia, American Samoa, Hawaii and also America. The Samoan language is being taught in those places which poses the question on whether this is right or not. Conferences were also held in these countries and resulted in a bid for a Samoan language Commission.

The conferences were more of a way for these members to waste time and have a vacation from the South and North of New Zealand to have a vacation in either American Samoa or sometimes Hawaii. Members suggested for the Samoan language Commission to be established in American Samoa or Hawaii because they have the funds necessary for meetings. I assume these meetings have been going on for 20 years.

Moreover, there was one maybe two meetings held in Samoa and so they invited me to attend and make a short statement. From there I understood. These members were trying to establish a language commission but without the involvement of the Government or the Ministry of Education. They held simple beliefs that they are more than qualified. So at one time, when the conference was held in Safotu, Savaii where delegates from New Zealand, Australia and America came and they once again invited me to come along.

The meeting progressed and it was made known that a Commission cannot be established without the consent or knowledge of the Samoan Government the place the language originated from. It would be illegally invalid. So therefore, it must first be approved by the Independent State of Samoa.

The Samoan language should come from the Samoan community where the language and culture is rich. That is why discussions were held to try and establish this Commission. However there were conflicting mindsets with regards to the most accurate Samoan which is founded in the Bible. The usage of the word *o le* and then reference it back to the Bible whether that is the right way of writing it. There are numerous ways that the language has been altered through the years and so experts have been trying to unearth the truth. The Commission hopes to support the Bill.

The teachers overseas have long been awaiting this Commission which should only be in the country which is rich in its culture and language.

Mr Speaker this bill has just been brought forth because it is a huge bill in the history of the Independent State of Samoa and its application and guidance for the future.

And that concludes my two cents on the merits of this bill.

**MR SPEAKER:** Thank you Hon Prime Minister for that clarification. I call upon the member for Faleata West.

### Samoan Language Commission Bill 2012 - consideration in detail

Tofa LEALAILEPULE RIMONI AIAFI: Thank you for now I fully understand because at first I had always thought that this was the way things had always been, because the Samoan Law states that the Samoan Language should originate or come from Samoa. Nonetheless I am wondering on the conflicting notions as mentioned by the Hon Prime Minister. It appears that there is a difference between the Ministry of Education and the Samoan community in the rural area and with the little funds that were available for accumulating the research. So I am wondering whether that would be the case because even with the new Samoan language coming about, it is insanely different from the correct language. Nevertheless I fully support our reference back to the Bible...

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MALIELEGAOI: Mr Speaker...

MR SPEAKER: The members concerns are well understood. I call upon the Hon Prime Minister.

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MALIELEGAOI: Those reasons are exactly right. If you listen to the new language being spoken you could easily notice the vast difference. For instance the word *nafa* and *gafa*, I was shocked to learn that there are two words when there was only one word which we were born using.

The true Samoan language uses the 'g' and not the 'n', the 'k' and not the 't' in speaking and otherwise. It was only altered when Missionaries established the Papauta School and began to divide the language from there. This is why when people speak in such a way, we often hear 'She is speaking the Papauta way' because only those educated at Papauta were taught this way. When a Catholic pastor and a Reverend converse in jest, one would say "we were taught the Samoan alphabet" and the pastor other would say, "we were also taught the Samoan alphabet fa, fe, fi, lo, lua."

Mr Speaker those are just some words to enhance our bill but I believe it is clear.

MR SPEAKER: Thank you Hon Prime Minister for the clarification.

It appears that this needs to be clarified. And may I suggest that there should be members from the Ministry of Education, the National University and representatives of the various religions should all have a link to the Commission to clarify the bill. So please explain this a bit further.

Thank you.

MR SPEAKER: There are amendments yet to be made and perhaps you will understand more once it has been approved.

There is hope that when the Commission is established they will be able to discuss further the implementation of their work and how to raise money for carrying out their work.

As I understand the Director is the boss and the director.

My question is that it should be visible and clear in the bill that if the Manager is the Manager than that is how it should state, or a Clerk. However if the bill is stating that a person is a Director and Manager too, then I am in need of further clarification of how this is so, because it is very confusing.

**MR SPEAKER:** I believe that is exactly how it is suppose to be. I call upon the Hon Prime Minister.

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MALIELEGAOI: Mr Speaker there is another Organization of the Government that is the same as this one, like the Public Service Commission. It is not anything new; it is a continuous practice, so not only is a person a CEO but also an Assistant.

Mr Speaker that concludes my brief statement on the concerns raised.

Afioga Hon TUITAMA TALALELEI TUITAMA: Mr Speaker I move a motion, That the Medical Practitioners Amendment Bill 2013 be read a second time and I wish to clarify it.

Seconded by the Minister of Finance, Minister of Women, Community and Social Development

MR SPEAKER: I call upon the Hon Minister of Health.

Afioga Hon TUITAMA TALALELEI TUITAMA: Mr Speaker this bill is very short. This Bill is to make provisions for the speedy registration process of Doctors from overseas assisting with health issues in our country. This Bill will ensure that the assistance offered by these medical practitioners are able to be carried out without restrictions to the process of registering. That is all Mr Speaker, thank you.

MR SPEAKER: Thank you. I call upon the member for Faleata West.

**Tofa LEALAILEPULE RIMONI AIAFI:** Mr Speaker I wish to make a brief statement on the Bill. I always assumed that matters like this were very simple and efficient since we are at the time of numerous accidents and so forth. Things were done smoothly at the time.

On the other hand I notice that now things must be firstly approved by the Council before a response is made, or in this sense an approval. But in the past the Hon Minister had the authority to approve these things so that the approval allowed practitoners three months or more to work and assist in the country but what of those who wish to extend.

Therefore Chairperson, can you please explain a bit further on this, because I thought that that was how it was being done, so that things would be efficient and accomplished well. However with this new formality of applying to the Council for approval first and awaiting whether there is approval or not is bothersome on the part of these helping workers assisting in the country. It would be better for the Hon Minister or the CEO to have authority of approving these practitioners to work.

**MR SPEAKER:** Thank you. I believe we are in full understanding of what the member is trying to voice. I give opportunity to the Hon Minister for his response.

P.P. 2013/2014 No. 30, The Finance and Expenditure Committee Report on the P.P.2012/2013 No.92, Corporate Plan of the Office of the Clerk of the Legislative Assembly 2013-2015 - Consideration

Afioga Hon TUITAMA TALALELEI TUITAMA: Mr Speaker the member is referring to doctors who come here to work for a whole month or six months a year. On the other hand, this provision refers to doctors who come inland for a shorter period or maybe one week to perform their assistance to those in need of medical attention. And these services are very expensive but they are performing it free of charge, for example operations on kidney stones and gallstones for which patients are taken overseas to be operated on. The aim is to minimize the costs. So a list is made and then patients await the surgeon to come for only about a week to operate and then return. To illustrate more, tomorrow a team from Australia headed and maintained by one of our own Samoan doctors returns after a week of surgical operations on dialysis patients. They have completed their work operating on 13 patients. And if we consider the cost of the operation on each of these patients the price would be very expensive, but these surgeons are doing it out of their helping hand. Therefore Mr Speaker these are the practitioners that this provision is referring to and not the ones coming inland for a lengthier amount of time.

MR SPEAKER: Thank you. I believe the matter is settled.

This cannot be altered because each member has a copy of the full Report, and if the citizens need a copy there is one available. **Afloga Hon Palusalue Faapo II:** Mr Speaker, I still wish to understand. Do you mean that a motion to amend cannot be made pursuant to our Standing Orders?

MR SPEAKER: No, Leader of Opposition. We are beating around the bush with our work. There is no returning to amend the things we have approved in the past. It has been explained and you are all aware of the normal procedures in regards to consideration of the Parliamentary Papers. So there are no more alterations to be made because that is the final decision. I call once again on the Chairperson for the reading of the Recommendations and the Resolutions.

What are you going to gain from these mere recommendations? Completing work and ensuring development is what is important. The clock is about to strike 13:00 o'clock and yet we are still going on about meaningless considerations. I was anxious to hear this Report because I had thought it would have teeth but all it has is considerations and recommendations. Mr Speaker I move a motion to approve this report.

**Afioga Hon Palusalue Faapo II:** Mr Speaker may I clarify a matter. This is exactly what I was talking about earlier.

- 8.9 That Government takes note of an efficient organizational structure and the administration of the Samoa Land Corporation, and in particular, its responsibilities and objectives that constituted its establishment. The Committee believes that a Sports Authority has already been established to be responsible for grounds and all sporting facilities belonging to Government.

The Committee believes that the provision of an actual plan at the beginning of the Tender process, gives the notion that this is the same job that will be carried out, with all the contractors witnessing, and in that respect, all the contractors will have equal opportunities to offer their bids. With this in mind, that will make things easier and the final decision of the Tender will be very transparent.
- 8.11 That the Government Tender's Board to ensure effective and efficient scrutiny and procurement of any project infrastructure in future to prevent additional variations and costs incurred. The Committee believes that this is also a disadvantage of the design and build concept.

# OVERALL VIEW OF THE COMMITTEE

The Committee believes that most of the deficiencies identified by the Audit Office are management failures, although they should ensure that all employees understand their roles and responsibilities to meet corporate objectives.

The Committee firmly believe that effective and efficient outcomes can only be achieved if proper internal controls and financial procedures are in practice. These working principles should be consistent, well managed and monitored on a timely basis. Government Ministries and Public Bodies should also comply with their reporting obligations and submit Annual Reports to Parliament at the end of each Financial Year, which the Committee feels it is valid and would significantly improve transparent operational controls and account for public resources.

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MAILELEGAOI: Mr Speaker it is exactly 12 o' clock now and perhaps it is time we should take a break. But before we break and approve the report, I would like to thank the Chairperson.

The Findings mentioned in the beginning of the Report of the Auditor clearly stresses the importance of carefully considering the letter known as the Management Letter which outlines issues that the Ministry can address with the CEO. A copy of the Letter is delivered to the Minister and myself every time whereby I would write to the Corporation to consider the contents of the Letter.

This is one of the Duties and Responsibilities of the Auditor. After the audit, they prepare a Management Letter addressing issues to be resolved. Once that is complete a recommendation is to be written up as we have heard the Chairperson reading out the completion of all these works.

Mr Speaker this is how Government works and it is important for me to highlight this because this is the process which the Government takes in all its matters. A letter is received, recommendations are made and then it is put into action. An Audit Report was brought forth in the year 2001 which was also very serious and I remember standing before the Parliament and saying ...most of the CEOs are of the opinion that most of the recommendations have been implemented, but the Letter is important as a reminder'.

Therefore I stand to express my gratitude to the Chairperson on the lengthy Report that was read out while in the end it stated all was complete.

Mr Speaker that concludes my speech and I move a motion to approve the Report.

MR SPEAKER: We have come to the hour of our recess; however there is a matter of concern as mentioned in the Report and has raised questions from the public. Nevertheless I feel that we should set aside proceedings of Parliament until we meet again.

Furthermore as we arrive at our time of recess, I give the opportunity to the Hon Prime Minister for his speech to conclude this Parliamentary session.

## STATEMENT BY HON PRIME MINISTER

Susuga Hon TUILAEPA FATIALOFA LUPESOLIAI AIONO NEIOTI SAILELE MAILELEGAOI: Mr Speaker I believe that our next Parliamentary Proceeding will be on March 18th and this is the fourth day of our session this month. It has not been an easy Meeting for the Government and also the Opposition, whereby very crucial opinions were voiced. Therefore I would like to extend and express my gratitude to the Leader of Opposition and Deputy Leader and that side of the House. Lest I forget this side of the House, to the Ministers and their Associates who fully support the work. Samoa is listening in and observing our ways. Our views and opinions ushered in the Parliament are very crucial and life changing. Our thoughts are not held back because the right is the most important element and the main intention is to uphold integrity in the works that we do. The Opposition ensures that by questioning and criticizing every detail, to make sure Government assets are being utilized efficiently. That is the spirit in which we carry out our work because in truth we too need your criticism and advice on alternatives to govern and develop our country. Even though it may seem that at times we oppose and not acknowledge your comments, the truth is that it is truly appreciated. This is the norm of our duties and calling. Our arguments may reach the moon and sky sometimes. That is the way life is, the only difference is that we have different approaches.

There is a joke that I usually tell and perhaps this is a good time to do so again. There once was a leader of an Ecclesia that proclaimed that all Jews be banished from their country. So the day came around for the instructions to be carried out and to debate on the matter. The problem is that the Leader is the only judge of the matter and whose word is the final decision. He is not only the Judge but he is also a well educated individual. He is the smartest of the country. So on the day of the debate, the members gathered and the Leader stood up and stopped them.

Statement by Hon Prime Minister

The debate was carried out by using of hand gestures instead of words. So the debate began first with the Leader of the Ecclesia waving his left hand upwards and toward the right side. The Jew pointed to the ground three times. The Leader waved his hands three times and the Jew waved back. Next the Leader of the Ecclesia reached into his bag and got out an apple, while the Jew took out his sandwich. That was what happened in their debate; just signs and hand gestures. In the end the Jew won and the Leader of the Ecclesia said they could stay.

They separated and one man asked the Leader what exactly they were up to. The Leader said, remember the Jews have different beliefs and they are awaiting their Messiah to return and lead them in defeating the Arabs. That is why I waved and said I know the Lord rules all of the Earth and the Heavens, and he says three times that I am forgetting that Satan rules Hell. Therefore I said there is only one God, and he said one God but three persons. So I thought to myself, it might be best that I move away from Biblical matters and move on to another strategy of science, maybe that will get him. That is why I lay my apple on the palm of my hand questioning him whether he thinks the world is round, and he lay out his sandwich saying that in the Bible, it says that the world is indeed flat. That is when I realized that this Jew is very smart and he won.

On the other hand the Jews gathered around the Jewish man who was in debate with the Leader of the Ecclesia and asked him what they were doing. The Jew said the Leader is a terrible man. They asked, 'what did he say?' He waved his hand saying, Jews get out of here. So I pointed to the ground and said, no way we are not leaving the place where we were born. So he said I am being very cheeky, and I said to him you are being cheeky too. Did you not notice how rude he was? He says it is now 12 so wait there while I have my lunch, so I said okay I am going to eat my sandwich too.

Therefore, there are different interpretations of how a person interprets things like the Leader of the Ecclesia and the Jew. The same applies to our situation. There is a huge difference from sitting on your side and observing the work we are doing and us the Government actually involved in the work and its implementation. For that reason honorable members of the House, this meeting has been very fruitful with the various Bills we have approved. The three important Bills we have approved which have strained us from 9am to 7pm will ensure matters be settled soon. The first bill being the Supplementary Appropriation Bill and the other, the Samoa Language Commission which is very important as it will address the state in which our Samoan language has deflected over the years, due to people who presume they know better. The third bill is the Constitution Amendment which we approved today.

The Constitution Amendment is being questioned by the people on what the alterations of the Bill have been about; the Amendment is merely to address the duration of the Term of the Governments Controller and Chief Auditor which has been extended to 12 years. The post was left until the appointee reached the age of 62, however due to some events happening over the years, the HRPP changed it to 3 years. Nevertheless the Governments principles maintained such posts to be 12 years.

There are two aspects that judge and determine the independence of a Chief Auditor; first is the length of his or her post in office and the second is the direct presentation of his/her report to the Parliament making sure that the Government does no read it first. This is in the auditing principles around the world.

The Auditor shall not have fear of reporting what is right, and should not be afraid to make investigations and report directly to the Parliament. When the 12 years is over, the Chief Auditor resigns and does not work for any other Ministry of the Government. This Amendment is very important because it hopes to ensure good governance is being maintained, and reflect transparency and accountability at its finest. Therefore this Amendment is important and it is well that all 46 members have agreed on this matter. It shows that your side and this side of the House all want what is best and what is right.

I would like to offer my sincere thanks to the Chairperson of the Committee for all the hard work and the effort put into your work. Whatever issues you may raise whether offensive to me or other Ministers, which is the way of the Parliament, and if we respond aggressively at times, I assure that we are only looking for what is right and just.

As I have mentioned many times before, the Cabinets duty is to manage and assess the progress of each Ministry to maintain accountability and transparency with reference to the Auditors investigations. Our country is not a country that does not have a 100% working population. We are responsible and no matter how true or honest one may be, there are faults in all of us.

However it should not entitle a person to be continuously degraded due to one mistake they have made. Samoa is not like that. We are a country founded on God. We should also not let the young reporters of the Observer sway our decisions and duty. As I also mentioned numerous times before. There are often criticisms of my comments that our callings are from God. What of the Bible that we read and the sermons of the servants of God? If your occupation is a Secretary and all you do is type all day and nothing else then that is your calling.

Your calling as a leader of the country in the Parliament is indeed your calling from God. If we look at David and how many times Saul attempted to kill him? Saul tried countless times to kill David, but the Lord delivered David twice. They came while the armies were asleep, passing the personal guards unnoticed. What did Joab say? David, kill them. But David said, 'would you kill a king who was blessed by God? Do not lay your hand on he who is blessed by God. Yes. We are believers who read the Bible for guidance. It is our way of living.

If God creates the opportunity for a person, then God also determines the fate of that persons misdemeanors. Whether it comes in the form of the Law, then the Law it shall be, because God gave us rules and regulations. God is not different from the Law. However the words that the elder ladies used to mock the Lord, I say to you to remember the Lords words, "He who denies me before men, I will also deny before my father who is in heaven."

Mr Speaker every time we come to the Parliament we make decisions. When you come to the Parliament, be ready because everything good and bad will be upon your shoulders. There are times when there will be more bad than good. It comes with the duty and responsibility of our calling. When one decides to question or criticize they do it freely. The best thing we can do is to have patience and forgiveness through and through. The highest Law God has given us is to love thy neighbor. However you cannot accomplish that if you do not forgive, if you have hatred for your brother or sister. If you cannot forgive thy neighbor then it is useless and meaningless for you to pray the Lords Prayer because the Lords Prayer is fueled by the whole heart. The Lords Prayer encompasses everything including forgiveness, so when you pray the Lords Prayer saying 'forgive us our trespasses, as we forgive those who have trespassed against us,' without actually forgiving your brother, that means you have intentionally cursed yourself in front of the Lord Almighty.

That is why I was very happy yesterday when the Deputy Prime Minister decided to forgive the Leader of Opposition and vice versa. It is also why I humbly asked Faumui to forgive Papalii. That is the way a Leader of the country behaves, as a Christian.

Mr Speaker I pray and hope that no member shall have a heart of retribution because the Lords teachings are clear on these matters. To be kind to those who hurt us and not to praise thy self, because every time you are kind to those who hurt you, the Lord will curse those who hurt you.

In conclusion Mr Speaker, I would like to say that whatever hurtful words or statements may have been ushered from that side of the house to this side should be forgiven. We forgive you and I hope you extend the same courtesy. Our job is 100% towards the betterment of the country. Samoa, we your Parliament pray for your forgiveness. We fall short at times

**Tofa Hon Tuuu Anasii Leota (Siumu):** Mr Speaker I would like to clarify something before the Parliament dismisses. I am not the Leader of the Ecclesia which was mentioned by the Hon Prime Minister, or a Saul or David because the Hon Prime Minister was pointing at me while he was telling his story. With due respect.

**MR SPEAKER:** Do not worry; there are other members flanking you that the Hon Prime Minister is probably referring to since his speech was general.

I believe we have come to the end of our session and with the speech of the Hon Prime Minister, I trust our thoughts may be renewed and calmed. What has happened in words of anger and distort; let us all forget. Praise the Lord and give glory to him for his presence in our work and what humble service I was able to provide as it is my duty; I return the praise to the Lord for his ever loving guidance in our work. I hope and pray that the words of the Hon Prime Minister may lay solid in our hearts and begin anew so that our work in this New Year will be fruitful and great. I express gratitude to our distinguished Parliament and all its honorary salutations. I believe Samoa listened and observed the success of our meeting.

Lest I forget the Clergy and their hard work in praying day and night for the future and success of not only our meetings but also for the future betterment of all Samoa. I acknowledge your hard work and pray that the Lord continue to bless this meeting and its members. Pray we meet in good health on the date upon which we will adjourn to.

Before departing, I call on the honorable Reverend, a member from Salega, Tofa Tapuai Toese Ah Sam to lead us in prayer to end our meeting.
