THURSDAY, 20TH MARCH 2014

MR SPEAKER: I am truly grateful this new morning for we have met once again in good health. I find the respectable members of the House in good health and spirit, the Hon leader of the country, the Deputy Prime Minister and Cabinet and this side of the House, the Leader of Opposition and dignified members in its honorific salutations. Such is the basis of this morning. The main thing is gaining strength in body, mind and soul for us to resume our tasks.

I also wish to acknowledge Samoa's support upon your leaders this morning as your Parliament is set to embark on today's set duties. May you hold onto that trust and support today. Parliament will now proceed with its work as per usual.

As pointed out yesterday, today's a new day and the Minister is prepared to discuss the bill. Today we will deliberate the Counter Terrorism Bill 2014. This bill must be clearly addressed and clarified as it deals with the safety and security of the country from global terrorist attacks.

The world is still looking for the aircraft that went missing. We cannot afford these problems. If there are terrorists imitators, then this bill was made to avoid these illegal acts from happening. Let us commence with today's orders. The Hon Minister stood a motion last night.

Afioga Hon Palusalue Faapo II (Leader of Opposition): Mr Speaker....

MR SPEAKER: I call upon the Leader of Opposition.

Afioga Hon Palusalue Faapo II: Thank you for the opportunity with respect. You have given praises as we assemble once again this morning. Let His name be glorified as our duties and toils are greatly supported by the country.

Therefore your honor, this side does not forget the duties of the Hon Prime Minister whom you should have mentioned in your prayers this morning for the sake of Samoa. Nonetheless, we share our sincere prayers to the Hon Prime Minister and his health on behalf of the Opposition and this Parliament. We pray for his speedy recovery so that he is able to resume work with us in Parliament.

The country is supporting our tasks as this was not mentioned in the prayer this morning. That is the wish as the Prime Minster is leader of the country and the leader of this side. May God's love...

Decision by Mr Speaker

Before we adjourn proceedings this evening, I call upon the Hon Minister of Women, Community and Social Development who has recently returned from overseas to conclude our session with a prayer.

Prayer.

Proceedings of the Legislative Assembly were adjourned at 11.02pm until 9.00am Thursday 20th March 2014.

MR SPEAKER: I understand thank you. The opinion of the leader of Opposition is now fully clear but if you know something then pray secretly. As for my prayer I was praying for the country as a whole. I was praying in general. The Hon leader of the country is not sick he is taking a break. That is the Christian way if you know something then pray secretly instead of publicizing the Prime Minister's illness. We also held a special prayer for the good health of the country which covers the Prime Minister. As of today if you want us to offer a prayer for the Hon Prime Minister then so be it but not for the general public. Everyone is praying silently and you too are not looking well.

That is the entire spirit, let us pray for our health and please do not question my prayer. Everyone prays and I have covered everything in my prayer if anyone wants to obtain a copy from the Hansard. Hence we shall not argue but bear understanding. I call upon the Deputy Prime Minister.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo (Deputy Prime Minister): Mr Speaker I move with utmost respect this morning. Your clarification is true, your prayer this morning was fine with me. It was a 100%, so not a worry. The Prime Minister is well he is just away for business but let us hope. He might join us sometimes today.

Afioga Hon Palusalue Faapo II: Mr Speaker, this is now a big mistake. Why hide it, the country is praying? He is the leader of the country, do not lie.

MR SPEAKER: I beg tolerance to the leader of Opposition to take your seat.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: The Prime Minister is well and there is nothing wrong. We all appreciate the offering you gave this morning your honor, hence I have been praying since last night. Thus now we have seen the leader of Opposition has regained strength from the eye disease. Hence this is 100% status. But there is nothing to be anxious about hence let us proceed with our work as the Hon Prime Minister is fine.

MR SPEAKER: In case my prayer is posed with several queries when everything is running smoothly. Pray silently if your love is true but do not question my offering which is the not the basis. I plea incase you take it wrongly as the support of the country is crucial.

I call upon the Hon Minister of Police and Prisons to provide a clarification on the bill and acts of terrorism.

COUNTER TERRORISM BILL 2014 – continued debate on the second reading

Afioga Hon SALA FATA LISATI PINATI (Minister of Police, Prisons & Fire & Emergency Services): Thank you for the opportunity on such a fine, clear skies which has guided the House upon His spiritual love and kindness.

During our deliberations last night, the Deputy Commissioner advised me that the leader of the country was resting. I confess wholehearted, the Hon Prime Minister is not sick. He only needed a rest which is why he left the House.

This gave way for some police officers to escort and protect our leader. That is the announcement with all due respect. I really wanted to clarify this last night nonetheless, everything is fine Samoa. Let God's name be glorified as He has guided our Parliament today in good health and spirit.

In relation to the Counter Terrorism Bill 2014 before us this morning which has repealed the Prevention and Suppression of Terrorism Act 2002, it is also linked with the Finance Department Act, Aviation Office and the Revenue Office Act.

We are aware of these problems today. Looking at the aircraft that's gone missing (Malaysia airline) we have to ask the question of why are these terrorists in this world, why do people hijack planes, why do they kidnap and demand ransom money? All these link to terrorism that is covered under this bill.

Last night we deliberated the urgent SIFA Trusts Bill in relation to overseas millionaires securing their funds in the country with the incentive that Samoa does not implicate terrorism problems, because we are a peaceful nation. Hence the Counter Terrorism Bill 2014 and Citizenship bill relate considering the protection of our people from things like money laundering and the like. We should also consider the bigger picture and our involvement with the bigger nations or united nations not something that is drawn for...yes this is to protect and safeguard our people and visitors.

The bill involves unlawful acts involving missing aircrafts, kidnap hence we need protection from the outside world of violence and abuse. I agree that Samoa is free from terrorists. Hence the only thing I know is that sometimes there is the selling of marijuana for a bottle of beer. When the seller is caught, he is jailed. But some suggests that selling marijuana is due to being poor when not. These sayings are mere assumptions because Samoa is very lucky. Samoa is founded on Christianity although problems do arise at times such as the problem happening in Ulutogia where there is so much evil. So why go to church and pray when you are not praying truthfully. Hence one should say 'Lord forgive them'. The truth is everyone has evil inside them, including myself because I too feel angry at times and say horrible things.

This bill is thoroughly clarified and clear to viewers and members of the House. The government has chosen a Committee to foresee these arrangements for the upcoming SIDS conference hosted by Samoa this year. Perhaps this is one aim which is to protect us from the attendees of this conference.

For the sake of the members, I have before me a thick security plan for the SIDS conference to which I am the chairperson. So I have prepared a copy which I will handover to all the members and Cabinet Ministers with the idea that you are all informed about the preparations by our sons and daughters whom we have entrusted with this task. I wish to disseminate a copy of this plan to all members why? This is the House of Samoa where we decide and report to, it is a collective effort for the government of Samoa. Such is the clarification for the information of everyone the arrangement of school children and their assistance. This duty has been delegated to Fauono. Fauono whom I now call is the Commander in Chief with good qualities. We are lucky, for clarification of the House Fauono is one hero of our country. Please with respect because some have not seen you. That is Fauono (members showed appreciation with applause)

MR SPEAKER: Thank you Hon Minister for the uplifting comment.

Afioga Hon SALA FATA LISATI PINATI: How is the service of our children done? All have been well prepared. Our meeting with the security Committee involves Interpol, Australia, New Zealand and USA in terms of sharing intelligence on potential targets. We also have the assistance of other organizations like JICA, SHAPAP that have suspicions on such unruly behavioral people. But if you would like me to read out everything (in this report) we would be here all evening but if you want me to read just a bit....

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: Mr Speaker, I move with respect, that I...

MR SPEAKER: Pardon Hon Minister, but I give the opportunity to the deputy Prime Minister.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: The speech given by the Minister and his clarification on the bill is much appreciated, although I do not wish to interrupt your discussion except for the matter mentioned on security measures for the SIDS conference, If the issue of security is in relation to SIDS, can you ask your Commander in Chief one more time if its appropriate for these details to be revealed?

This information should not be revealed in case the terrorists get a hold of your list and then you might not be able to find your Commander in Chief? That is the case with due respect.

MR SPEAKER: I call upon the Hon Minister. I think what the Minister wants to make public are public awareness programmes whereby our Parliament can assist in terms of security but I think the Hon Minister is holding on to confidential information.

Afioga Hon SALA FATA LISATI PINATI: Thank you. I thank the Deputy Prime Minister. I believe the matter raised by the Deputy Prime Minister is related to terrorists inside the House. There are no terrorists in the House. For example, is Levaopolo a terrorist? Is Leala a leader of terrorists? Or Ifopo from Aiga I le Tai? The answer is no. I am relaying this information from a pure heart. Some of these sections are in Samoan and there is no specification of confidential information in some parts. These preparation will ensure the security of Samoa and the people involved in the Conference which consists of...three Conferences Official Meeting, a total of 3,000 delegates are expected, and a large number of media personnel will cover the Conference.

Afioga Hon Palusalue Faapo II: Mr Speaker a point of clarification.

MR SPEAKER: What is it do you wish...Pardon Minister but I will allow an opportunity to the Leader of Opposition.

Afioga Hon Palusalue Faapo II: I feel for the Hon Minister because he doesn't' seem to know the aim of the Ministry. Another reason is that this political party supports the bill; your bill is significant as it caters for the safety of our conference. As viewed, the Hon Minster is prepared to read the entire bill when it is based on the state of urgency?

MR SPEAKER: It is clear Leader of Opposition, an opportunity is given to the deputy Prime Minister.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: Mr Speaker I am fully aware of the safety precautions and measures discussed by the Hon Minister. We are talking about security and that's in line with this bill. We are talking about protection from terrorists. That is the intention of the Hon Minister when Im advising him that there are parts that shouldn't be revealed to Palusalue and their side in case they know as they are similar to terrorists. These plans should be revealed until after the meeting.

Afioga Hon Palusalue Faapo II: Mr Speaker a point of order.

MR SPEAKER: I call upon the Leader of Opposition.

Afioga Hon Palusalue Faapo II: For the sake of our listeners, this side has been compared to terrorists, do not....have these words be withdrawn from our Parliamentary records because the Opposition are respectable members of the country and constituencies' representatives but if these are the deputy Prime Minister's intentions then alas, although he is trying to be humorous but it goes to show how weak he is, for the sake of our listeners, they are giving support and yet we are being called terrorists. Remove these words your honor.

MR SPEAKER: Your opinion is clear. I call upon the deputy Prime Minister.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: If you read this bill carefully and you look at the meaning of the word terrorist, it doesn't just refer to people who detonate bombs. It also includes people who create conflicts with words like what you are saying. So the word terrorist has a broad meaning and yet you're only thinking about what we see on TV and the news. You are right because you've got no bombs but terrorists can use thoughts and conspire to defeat the other side. All those are terrorist activities. Look into it.

MR SPEAKER: Very well. I advise the Hon Deputy Prime Minister to withdraw the word 'terrorist' and replace it with 'tourist' to maintain peace in our proceedings.

I call upon the Minister of Police & Prisons, Fire & Emergency Services to resume clarification of your report.

Afioga Hon SALA FATA LISATI PINATI: Mr Speaker you should be thankful and thank the Hon Minister for the information shared with you. Why? Because there is belief that we are brothers and we should not be mistreated. We may have different views and different decisions, but the main thing is that we have to stand up for each other, Samoa for Samoa.

This is the reason why you must be aware of our government's plans. The meeting will hold up to approximately 6,000 travelers to Samoa. The arrangement of security integration began in September last year. The security Committee started with its implementation plans as soon as the Ministry of Police started receiving assistance information from overseas safeguards. Since December last year, the Security Committee has been collecting information. We are working with the Customs, Immigration, SPA, SSC, Marine, Health and others.

The importance of the Ministry of Health and other Ministries is in case there might be a disaster and these organizations can prepare them for mass evacuations. The duties faced by the police department and other....

MR SPEAKER: Pardon the Minister of Police & Prisons, I give the opportunity to the Minister of Health. I call upon the Hon Minister.

Afioga Hon Tuitama Talalelei Tuitama (Minister of Health): I do not wish to interrupt the Ministers discussion, but matters pertaining to the Ministry given that they will face emergency cases should the need arise. What I want the House to be aware of is that these are not the only terrorist activities that could endanger the lives of people in an organization, like this meeting. Another terrorism method is secretly bringing disease with the idea of spreading it among people in a public place. This is one of the areas the Ministry is looking at. These sort of terrorists do not care about anything, the only aim is to introduce these diseases to the public so that the people are affected. With all due respect.

MR SPEAKER: Thank you for your assistance on this bill. I call upon the Minister of Finance.

Afioga Hon Faumuina Tiatia Faaolatane Liuga (Minister of Finance): Mr Speaker, let us give some rest for our brother, the Minister of Police and Prisons and the tabled bill. He has clarified shared information. Security information has different classifications of security information to safeguard people from being attacked. Some of this work involves devising security plans according to my past experience. These are strictly classified incase others are aware of them and they would set up a plan ahead. That is the assistance to the bill.

MR SPEAKER: Thank you. I call upon the Deputy Prime Minister. Tofa Hon Fonotoe Nuafesili Pierre Lauofo: It seems that the statement I issued earlier on security methods is confirmed by the Hon Minister of Health and Finance. If the Minister is addressing the leader of Opposition who is affected by a pink eye disease, then simple; he is the leader of the terrorists. The Minister of Finance has also spoken about security plans on various levels. And it seems the leader of terrorists is now aware of the security plans but I will leave it with the Minister of Police & Prisons to control the dissemination of this information.

MR SPEAKER: I give the opportunity to the Leader of Opposition.

Afioga Hon Palusalue Faapo II: Mr Speaker with utmost respect, you are so rude deputy Prime Minister. I am not a leader of terrorists. The other thing is, (there are so many voices in your party) what's happening to your side? You are all over the place, what happened? Have you got no leader? It seems as if the Minister of Police & Prisons does not understand the bill. What is your understanding?

MR SPEAKER: I beg your pardon leader of Opposition...

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: Mr Speaker, a point of order. This is not being rude. Consider it?

Afioga Hon Palusalue Faapo II: Your given views are different but the bill should be discussed in Cabinet. Do not be rude, this has gone too far.

MR SPEAKER: Pardon leader of Opposition.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: It is not rude.

Afioga Hon Palusalue Faapo II: I feel for my country.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: If we look at the rules of debate, there are no interruptions during clarification of the bill but the Opposition is interrupting. This is the reason for taking the floor. Let the Minister finish before you submit your queries.

Afioga Hon Palusalue Faapo II: He was the first one to interrupt Mr Speaker.

MR SPEAKER: Pardon the leader of Opposition.

Tofa Hon Fonotoe Nuafesili Pierre Lauofo: Do not disrupt proceedings. You are being continuously rude.

MR SPEAKER: Let us work together in carrying out our orders this morning. This is the reason why I give the opportunity to the government to respond and give clarification matters that requires clearance. That is the correct clarification for our bills which is government owned. The Cabinet can also assist with the Minister's clarification. Look at the opportunity granted when it shouldn't be given according to the rules of debate. And whatever humorous remarks said do not be alarmed, this is just for amusement. This involves you being leader of terrorist when in reality you are not, its just amusing remarks.

That is the spirit but do not take it seriously. Let's keep it together as the day is still new. The Minister of Police and Prisons is also assisting with this matter. This Minister is fair minded on sharing information. I am also giving respect. Hence we must support the bill for the prosperity of the nation and Parliament. Hence with security plans, there is a saying that goes, prevention is better than cure.' We must be protected otherwise we will encounter unnecessary problems. Therefore we should not point fingers. But the recommendation is for the respective Minister to consider our general views for our protection.

I call upon the Minister. Thus I give the opportunity to the leader of Opposition.

Afioga Hon Palusalue Faapo II: Mr Speaker with great respect, since we are blamed for interrupting the clarification of statements. There is nothing provided for in the Standing Order which restricts the immunity of querying clarifying statements.

MR SPEAKER: Pardon me as I will now decide. Are you questioning my duties?

Afioga Hon Palusalue Faapo II: This is the reason why I constantly rise because of the way you manage proceedings, it must be questioned and corrected.

MR SPEAKER: Hon leader of Opposition, listen closely. If the Minister is clarifying the bill we must wait until we are open for debate. That is the Standing Order, hence there is no debate at the moment. The bill will be open for discussions once the Speaker permits. Do not question me for I am trying to maintain peace and order. This is the basis of my endeavor. I have also granted you frequent opportunities out of respect which should not be the case. I call upon the Minister to continue with his clarification on the bill.

Afioga Hon SALA FATA LISATI PINATI: Thank you. I recall a saying by one old man, "Good families are known for quarreling as peaceful derives from within." God is present in quarrels and so as peace. We do not argue over negative thinking. Not all fights in Parliament are respectful. It is done out of respect for the sake of our listeners. We are leaders. Hence we must rely on God as leaders. Also whatever unruly statement given, sincere appreciation to the Minister of Finance and Deputy Prime Minister because if our security is alerted we should be worried. But with our assistance upon an undertaking praise God as nothing is hidden which is the essence of this House to discuss and revisit our decisions.

That is the spirit and I pray for patience upon the Opposition leader and its deputy. If a person or prisoner is bounded by the law, they are sentenced for 15 years imprisonment, police or civil aviation officer also holds warranty to arrest such prisoners before they are submitted to the Attorney General's office for investigations. I totally support this bill that is appropriately submitted for the protection of our society today with the assistance of the police force. Have a blessed meeting. Soifua.

MR SPEAKER: Thank you Hon Minister for the clarification, I believe that the bill has provided its clear purpose and this is a good chance for members their submissions and recommendations to achieve this very important bill.

I call upon the member for Gagaemauga No.2 to elaborate upon the bill.

Tofa LEVAOPOLO TALATONU (Gagaemauga No.2): Thank you your honor for this grand opportunity this morning. I believe you have offered our thank you prayer for God's divine mercy in order for us to resume our duties for today.

At this hour there are a few grey areas pointed out by some Ministers as essentially, the Hon Minister of Police and Prisons was chosen for a reason, which is unbelievable. The only disappointment is your intentions on the bill which seems to be directed to the conference instead of the security and safety of Samoa as a whole. Although I am pictured as one of the terrorists in today's Observer, but that is just a joke as you said.

However, just a word of advice your honor, there is still issue that is affecting our residents living abroad whom are prosecuted as terrorists and are deported back home pardon the listeners. That is one issue that should be clearly specified under this bill, the attitude of our returnees' citizens bringing home trouble costing the lives of our local people.

Secondly, our preparation for the SIDS conference with emphasis is centralized on the venue. You honor, please note the entry points at the airport and wharves incase...problems may occur when a delegate is being followed by a terrorist here thus affecting our shores and marine zones if we are not mindful of these impacts. The question is do we have enough facilities and patrolling boats to secure our seas and airport surroundings? Because according to the information provided, this is under the supervision of the Samoa Airport Authority. Hence this should've been spearheaded by the Security Committee and seek foreign assistance so that we are fully prepared for this event.

We also had a \$2million Iron Scan machine at the Customs office utilized to analyze cocaine and other drugs which requires experts to carry out this specification.

Lastly your honor, we also have our Statistics office that will assist greatly with providing efficient and effective information which is one....the releasing of information is specifically stipulated under the Statistics Act.

Lastly the Minister of Health is right; one act of terrorism is the attracting diseases like the pink eye disease into the country as witnessed elsewhere due to a result of not enough preventive measures. Hence this is the message for everyone, we must work together. With utmost respect Mr Speaker, thank you.

MR SPEAKER: Thank you. Well Hon Minister there are a few members who wish to speak on the bill, it is best to give their submission and respond later.

I call upon the member for Faleata East.

Tofa AVEAU TUALA LEPALE NIKO PALAMO (Faleata East): Thank you your honor, Minister and the Ministry of this bill. We have been debating all morning about the terrorist terminology – and it seems like everyone has their own definition of this term. Despite the member's view and concerns, everything about terrorist is defined under Clause 3.

Therefore this expensive is in line with the future vision of government Ministries which envisions the future happenings of Samoa. Because I don't think we are prepared to implement this bill. We should have initiated training programs for returned qualified experts to execute the following act. Are there any resources available for this undertaking or is it going to lie here and not make it into good use. For instance, the bill stipulates section on bomb explosion. Do we have a bomb detonator expert in Samoa? As seen in movies, there are specialists on...Are we prepared for this? This is one large section under the bill.

Another section of the bill implicates crimes and offences which contains imprisonment for life. One of the least offences is the sentence period of less than 12 months. We should also be working closely with the Immigration office. Have a look at the visa permit of 60 day period for foreigners to enter Samoa. The main thing to look out for is the validity of their traveling documents. The 60 day permit and warrants is not specified, whereas the bill stipulates a list of names and organizations affected by terrorist attacks under the Commonwealth nations. We should consider all sections of this bill including all Ministries involved. The only recommendation is the effect of the bill on non-terrorists considering the definition of terrorist and the penalties incurred. Such is the plea to the Attorney General and the government to reconsider the general meaning to clearly define the section to such Acts which stipulates a person being charged from a normal crime or offence that we have nowadays.

The warrant of arrest is another significant section of the bill that not only specifies the reason for conviction but also warrants your protection from the court. Another vital contributor is the Shipping sector. This should be enforced within...which I am sure its enforced, but must ensure that we obtain enough containers supply...as some of these chemical supplies is found in the country hence is the need for additional weapons to the list for our protection. This is reflected in past incidents where culprits would hid drugs in envelopes and are sent amongst people affecting the innocent. This marijuana leaves is available in the country.

Hence is the request to the respective Minister to consider our submissions and incorporate them into the bill for future generation. As of the current as reiterated by the Minister, terrorist has not yet reached our shores but its good to prepare.

This is also crucial for the safety of the conference attendees and delegates from abroad. I feel that we are not fully prepared as we this plan involves a lot of experts that hasn't yet been incorporated. I am thankful that the Ministry has commenced the undertaking of security measures on areas like kidnap, ramson and the like which requires special agents on this mission. Those are the concerns but appreciation to the Minister and the Ministry for this very essential bill which concerns the protection of our people. Have a blessed meeting.

MR SPEAKER: Thank you for your assistance and recommendations upon the bill. I take it that members are very alert on the matter beforehand particularly the Hon Minister, let the opportunity be granted to the member for Faleata West.

Tofa LEALAILEPULE RIMONI AIAFI (Faleata West): Thank you honorable Speaker. I greet our listeners and the dignified House. I also wish the Hon Prime Minister well wishes and good health from God.

Thank you Hon Minister for this bill which focuses on terrorist. This term involves a lengthy definition according to the bill but in the Samoan context, a terrorist is about bomb detonator, destroying properties and offering oneself to die over killing others. In reality we have no such thing as terrorists here in Samoa. The bill also emphasizes readily available finance to fund experts on this field to assist us should the need arise.

The only concern is that our country may be targeted as a hiding place for harboring terrorists. That is the aim of the Ministry is that there are over 14 criteria under the United Nations Conventions on terrorism including us. One of these requirements is for Samoa to establish an act in relation to returning harboring terrorists particularly when Samoa is preparing as hosts for the SIDS conference at the end of the year. This is the main aim of the bill where it involves government agencies such as the civil aviation, shipping, police and Immigration office.

These international events are not new to Samoa considering the many preparations undertaken although it is a global threat that can affect us. Hence the requirements stipulated by the United Nations Convention must be complied with and so as this bill.

I wish to acknowledge the Ministry of Police although it has been a while now since they are without supervision but sincere appreciation to the gentlemen who are overtaking this responsibility. The Minister has already given his acknowledgement, and the new term for police sounds good – CIO instead of CEO, Commander in Chief is good to uplift their standard.

The bill though Hon Minister seems to attract everyone. It was not long ago did we pass the Chemical Weapons Bill. All these acts leads to our protection. What we should priority is our front liners or the ones with potential expertise in these areas such as a tourist visiting the country when he is here for a different purpose. This requires special training. Hence it is important to be well prepared and stay alert for the protection and peaceful living of our people.

With respect thank you.

MR SPEAKER: Thank you, I give the last opportunity to the member for Falealili, Tofa Tusa Misi Tupuola before the Minister responses on the bill.

Tofa TUSA MISI TUPUOLA (Falealili): Thank you your honor for the opportunity. You have given our offering this morning, praise be to His Almighty name for guiding the members of Parliament.

I move with utmost respect to make a submission on the important bill before Parliament. This is preparation for tomorrow and Samoa's bright future which is my belief.

I thank the Hon Minister of Police and the Ministry for initiating this bill. I have seen this bill a long time in Parliament and based on its significance, Parliament is now deliberating this morning. But your clarification is well taken to safeguard our country from terrorists. Based on truthful views in the past, Samoa is a peaceful country, filled with hospitality, and welcomes all visitors, except for terrorist attacks from entry points such as our ports, wharves at Fagalii and Faleolo. All these can lead to terrorist entrance into the country and is well planned by the Ministry of Police. The Airport Authority, Ports, Agriculture, Fire Emergency, Health Ministries have been well trained for the upcoming conference in September this year.

I do not have much to say but just a few recommendations on security plans given my past experience with the Minister and the Ministry as this common issue during operations of these plans producing false information when the tied should be calm and keep running things smoothly. The chairman of the SIDS security unit is well aware of this matter. If force is exercised problems arise leading us to the unexpected. But that is our plea, let us rely on God and everything will be made possible. Those are the views, Have a very blessed meeting this morning. With utmost respect, thank you.

MR SPEAKER: Thank you. I call upon the Minister for his responses on the bill before we proceed with this bill.

Afioga Hon SALA FATA LISATI PINATI: I wish to convey deep gratitude to all members for their submissions in preparing Samoa forward for the SIDS conference. I will start with terrorists entering the country. We have arranged for our specialist crew or arms offenders who will be in charge of safety measures. We also have our search and rescue team. The marine monitoring has our diving crew around the coast and harbor area. America has also offered assistance through its maritime surveillance coast guard who will be patrolling the coast once the cruise ship arrives together with the assistance from New Zealand. There is also a special offenders' crew or special scrap crew from New Zealand.

All these arrangement commenced since September last year. Up to date, the collaborating efforts from Immigration, Airport Authority, Customs, SPA, Samoa Shipping Services, Samoa Shipping Corporation and other various ministries have all been given to make the workload easier. These preparations is given 1000 percent effort not 100 but 1000 because our people are well set on their duties with the best of their abilities to ensure that nothing will occur. The aim is to make sure that everything goes according to plans whereby the assistance of chiefs and villages are much appreciated in monitoring each constituency and welcoming the motor gate.

It has been issued that only Apia is now prepared, no. For your information, we have 24 hours a day, those 24 hours fully used by the employees at the airport. The Shipping Corporation has offered 50 students to be employed who studied sailing and maritime to assist with the work of the police. There is also a truck that will be brought in from Australia called armored guard I believe will arrive soon, this truck when hit by bullets bounce. I believe it will be the first time this type of vehicle will be seen in Samoa unless the UN has one; there are also motorcycles that will be brought in, in consideration of the motor gate.

MR SPEAKER: Pardon me Minister but I will give the opportunity to the interjection of the member. I call upon the member for Faleata West.

Tofa Lealailepule Rimoni Aiafi: Thank you Hon Minister for the clarification. I wish to know more about this individual armored guard considering the many arrivals and whether it will be returned after the meeting. We have already prepared everything on an international standard, if 100% then good. If you say 1000 percent then it is uncertain. Therefore I really want to understand more about this armored guard.

MR SPEAKER: The issue mentioned by the member is now clearly understood. I call upon the Minister to continue with his clarification.

Afioga Hon SALA FATA LISATI PINATI: Thank you Lealailepule for your service. Lealailepule is a man that can do anything, a prominent member for Faleata. Thank you.

I have mentioned 1000, what is the reason. The essence is given to confirm and verify this side on the belief, to lend us your trust and faith. There is not a single duty that goes without an error. As with the shared information it is complete with the assistance of our children. We should be appreciative of those working day and night while the whole country is asleep. These are the people who are tasked to protect Samoa. Yes.

The armored guard given our weak economic status, but if the Commander in Chief does well, I guess time will come when New Zealand will say to AFB leave the armored guard vehicle for Samoa If this is the case, then the member for Faleata West will be first to ride on it. As for the concern of the member for Gagaemauga No.2, everything is well in place. Overseas technology has been given to assist us with that matter. The Immigration, Customs, Quarantine and the Police will be working 24 hours, together with a special police squad, who will monitor the entire area 24 hours nonstop until after the delegates departure, then their services will be de-activated and they are free to go.

As for the poisoned gas chemicals, this will be executed by the specially trained canines.

MR SPEAKER: Pardon the Minister as the opportunity is given to the member for Gagaemauga No.2.

Tofa Levaopolo Talatonu: Mr Speaker just a point of clarification on our airports, is it just Faleolo where these services are provided in case you forget Fagalii airport where easier access could be made

MR SPEAKER: I call upon the Hon Minister.

Afioga Hon SALA FATA LISATI PINATI: Thank you. I forgot to mention this, which is very true. Everything has its doubts...there will always be something that can ruin the... I apologize for not mentioning this but what's done for Fagalii is also done for Faleolo. The monitoring of wharves involves Shipping, Immigration, Quarantine, and SPA. If they were allowed to carry... these Ministries will be armed with guns. Although this fire arms are prohibited in the country at least we are protected at all times. Whoever is suspected of these activities is sent immediately to Tafaigata or before for me to decide before a ruling is given.

We also have our partnership with the Statistics Office as raised by the member for Gagaemauga No.2 at the airport. As stated, everything is complete. Everything is in place for the country's security and statistics officials will be present at every entry point. Has the response satisfied the member for Gagaemauga No.2? Thank you my fellow member.

Tofa LEALAILEPULE RIMONI AIAFI: Mr Speaker, if this is the Chairman's response, I am satisfied, but I needed clarification. But it does not affect me, although the bill should've been flexible according to the bill depending on the age of a person, and the relationship between the chairman and the Minister, but never mind, with due respect.
