MR SPEAKER: I announce the resumption of the Proceedings of the Legislative Assembly.

Well, greetings to you all this in new morning. I believe that we have gained strength to continue our work for this week.

SUPPLEMENTARY APPROPRIATION BILL (NO.1) 2020/2021 – second reading and Debate on the Bill – Day 5

MR SPEAKER: Before Proceedings of the Legislative Assembly adjourned last week, the member for the District of Faleata East was speaking.

In the utmost respect, I call on the honourable member to continue your speech.

Afioga SALAUSA JOHN AH CHING (Faleata East): Thank you Mr Speaker for the opportunity. I also express salutations this new morning with good wishes as the sanctity of this Parliament have gathered today. Although yesterday was the funeral of one of the members who served in our Parliament in the past, but it does not diminish our faith in our God. As Jesus said, "There is plenty of room in my Father's house for us to live in". Therefore, may his soul rest in the loving arms of our Most High God in heaven.

As for this new morning, I would like to address my constituency of Faleata No.1. Just like I mentioned last time, there are two separate villages in this constituency, but there are 13 sacred villages and communities within this district of Faleata No.1.

My village of Vaimoso in all its honorific salutations. As well as my beloved village of Lepea in all its honorific salutations.

These are the sacred villages of this district, starting from Moamoa, Moamoa-fou, Moamoa-tai, Moamoa-mauga, Sinamoga, Alafua, Vaitoloa and Fatipule, Pesega, Lotopa, Tuanaimato, Seesee, Tuaefu and Ululoloa. It is where the kings and nobles of the country reside, with the presence of the retired church ministers and their wives.

And it is also the residents of the sanctity of the Cabinet, the Hon Prime Minister and some Cabinet Ministers, as well as some of the male and female members of this House, it is also where the Tama a Aiga and his Good Lady resides. It is also the residents of the male and female Judges of the Judiciary of Samoa, including the male and female doctors, lawyers, engineers and grant writers, as this is one thing that is needed by our constituencies, the grant writers. It also includes CEOs and ACEOs of our Government, businesses and private Ministries, it is also where businessmen and those responsible for large contracts reside. The principals and teachers, and all of the public servants of our Government, and some staff of private businesses, but most importantly the support of the elderly men and women and the sanctity of this constituency.

Well, those are the sanctities of our mighty district of Faleata No.1. It will be a while before I address the special demands of our district. But at this time, I would like to express the essence of congratulations and thanks to our constituency for these years that we have been together. When I was appointed to this position, I was uncertain of the outcome, whether this journey will be calm or rough. However, starting from the time when I met with my district, it was a very warm relationship; it is also a relationship that is very friendly and mutual. And maybe this is also the reason why it is easy to set up policies to develop the district.

This is the first policy that is firm in the district, the Constituency Development Committee. These are the conditions that were instigated by our Government; especially the Ministry of Women, Community and Social Development, and it has enveloped all the constituencies of our country, except for the one district in Savaii, since the resurface of the Covid-19 virus, we were unable to implement it. But this is another policy that I know is very good and perfect for the development of our country.

I mentioned in the past the issues that the United Nation is discussing, the sustainable development goals, or the needs or the expected goals of development that needs to be continued. And it is in this situation that Samoa can achieve this objective and achieve the goals of the world that we have already signed.

Another very important thing is the district development plan or the guide for the development of villages and communities....

MR SPEAKER: I implore the member that is speaking as the member for Salega East is upstanding, is there something you wanted to interrupt.

Tofa Olo Fiti Afoa Vaai (Salega East): Mr Speaker, it is something I want to understand. Thank you Mr Speaker. I sit and observe the conditions of our Assembly, because it is understood when asked. Mr Speaker, I want to ask because I would like to understand, in term of our Standing Orders. If you notice last week, the duration for the speeches by the members is 2 to 3 hours long. Whether our Standing Orders have been set aside for 30 minutes given to discuss the context of the Budget and public addresses, or is it just being neglected.

Well, that is the question Mr Speaker, because I want to understand, or perhaps we are doing our maiden speeches again. Well, this part seems to be new from my observation Mr Speaker. That is the reason for the question. With all due respect.

MR SPEAKER: Thank you very much. Well, first of all, perhaps as witnessed in your speech, there was no interruption or interference, and your suggestion shown on behalf of your constituency was complete, well, these are your final statements to the observation of the constituencies. The issues that were raised and debated in the Parliament for the development of the districts in different areas, and also the opportunity to thank those who put their trust in you, for electing you as their representative to voice their opinions in Parliament through Government policies.

These are the opportunities, but we keep to our normal time. But like many of the speeches that have been made, as Tutuila and Ape are read differently like the words used in the brotherhood of Aana, because of the interventions and corrections and explanations by the Government who are also standing to correct and hijack and thus prolong the speeches of the honorable members.

But the respectable members are speaking to use their foresight, so I implore that you uphold our Standing Orders. The conditions of our Standing Orders are not being neglected or set aside, but speak with regards to our Standing Orders, this is the case for these 5 years, but you are already aware that the speeches must be 30 minutes long. Well, because this is one area where the Speaker is being observed, saying that.... I will just say it directly, cutting down on your opportunities. Well, but no. The question raised by the Member is very good, but that is the case, the members are free to speak and..... It is the discipline, not the Standing Orders, but discipline is better than the Standing Orders.

Well, that is the situation in order to please the observation of the district. This is the case Olo, but.... well, Salausa, adhere to the suggestion made by Olo as....

Tofa Olo Fiti Afoa Vaai: Thank you very much Mr Speaker. But that is what we considered, we also prepared a lot for our speeches, but we limited it with regards to the Bill being administrated by the Hon Speaker, which is also the reason why we shortened our speeches and our statements. Well, we just wanted to state the obvious as you have already made it clear, thank you for the opportunity. Because for many of the members this is the first time, they are making their speeches, but they did not make any speeches in these past 5 years. But it seems that they are misusing this opportunity because they are worried that the Parliamentary Term is coming to an end, but they have yet to make any statements. With respect.

MR SPEAKER: Well, that is the situation, but show some sympathy towards the fellow members who are worried, but bless you for you are not anxious, since you are a senior member, but some of these members are quite distressed. See, they have become thin with distress. Yes. They are starting to wander around restlessly, and you can see them talking to themselves alone because they are very anxious.

Well, I ask the Member for Faleata to speak, limit your speech to half an hour. Yes, it would not be good if I keep reminding you.

Afioga Hon Lautafi Fio Selafi Purcell (Minister of Commerce, Industry and Labour): Mr Speaker...

MR SPEAKER: Well, I ask the representative for Development and Private Organizations to stand.

Afioga Hon Lautafi Fio Selafi Purcell: Mr Speaker, thank you for clarifying the conditions on how our Assembly is administrated, it is clear. Olo is also well aware of it. But I stand because it was stated in the speech made by the member for Faleata West, as the speech by Faleata is quite wonderful, in all its complete conditions and his point of view of his district, as well as the Ministry of Women who are responsible for the development of each of our constituencies. Since my constituency was mentioned in the statement made by the member last week, saying that there were some youths who approached them with questions, perhaps this was when the Ministry went to start discussions on these district guidelines.

So the reason for my emergence because my constituency is listening in, now there is a guideline, and I am holding it in my hand now – Satupaitea District Development Guide 2019/2029, and the issues that were stated by the member are all in here, to develop my constituency. Well, in the near future the Constituency Committee will meet as mentioned by the member and then these developments will continue. And with all due respect.

MR SPEAKER: Thank you. Well, it is associated with the guidelines of my village, as stated and addressed by the Hon Minister, but thank you to the Ministry for introducing these good practices so that villages and communities can be developed. Thank you.

Well, I ask the member to stand and continue your speech. Base your speech on the motion that Olo stated.

Afioga SALAUSA JOHN AH CHING: Well, thank you, I will speak according to the motion moved by Olo. Now I am addressing my constituency, and I am also concluding my speech.

But I have mentioned these District Development Committees, because the whole thing has a lot of impact on the Budget and the progress of the country. Yes. This results in good management.

This is what is important to me with this current District Guide, with this, the districts are being asked directly to speak, to express, to convey, what do you need for your development? That is the most important thing.

MR SPEAKER: I implore the member, as I call on the Prime Minister to stand.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi (Prime Minister): Mr Speaker, we are discussing the Guideline. Our Parliament also has a Guideline. Please Mr Speaker, are there any Guidelines for members arriving late to our Sitting not only for coming late but also not attending the Sittings due to dishonesty? If they do not want to attend the Sitting, what should be done? We are nearing the end of our Assembly, and yet things like this occur, the members are not faithful to their oaths, but they have been in this House for a long time and now they are not attending the Sittings, or they arrive late, and then they come and raise issues that have already been discussed here? But not only is it reflecting their lack of understanding, but it also misrepresents the proceedings of the Sitting to the country. Please, would it be possible to indicate these Guidelines for us in this Parliament?

MR SPEAKER: Thank you very much. Well, the usual Guidelines, a reminder for the Parliament, you possess two Bibles, well, pardon the language concerning the Book of God, there are two worldly bibles that are distributed when you are appointed. When elected to be an honorable member, the Constitution and the Standing Orders. Those are the first books given to us. But the question that was raised by the Hon Leader of the Government, first of all, our Oath of Allegiance to carry out our work in this Assembly. What is allegiance? Being active in our Parliamentary Sittings and adhering to our time. That is the first level of allegiance, if they are not active, then it means that they are not honest representatives.

Secondly, they must inform the Hon Speaker.

Thirdly, if they do not attend the Sittings for three consecutive Sitting days, the decision will automatically be made to remove them, they will no longer be politicians, retired from the position of representative. Yes. But it is done in a formal way of discussion.

That is the reason for my concern, our Standing Orders will always be utilized, but there is also consideration for our cultural values, the mutual respect, but none of the senior members are like that, as if... well, in case the Chair is blamed, but you are all aware, the member who is... because senior Aeau, who is 80 or 90 years old, but still... although it is raining this morning, but the Hon Aeau is present here today. As for the other members, it is true they are senior members, but they are young, but when they come, they arrive 1 or 3 hours before our Sitting ends. Well, I refuse to say it in case I mention their names, but that is it.

That is the response to the question raised by the Hon Prime Minister, but that is the case.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker, the reason for my emergence is because ever since I entered this House, I would usually see members like this, they only attend the beginning of the Assembly so that their names are written in the attendance records, and after less than an hour they would leave and never return to the Assembly. But the issue that is transpiring in here now, we are making our appeals to our constituencies, so that we can be re-elected and return. But what has happened? It is still ongoing. They do not attend Sittings, or they just come to write down their names and then they would leave and never come back.

MR SPEAKER: Well, just... I beseech the Hon Prime Minister...

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Therefore, I am happy that I raised this issue, since our Assembly is being broadcasted on television, so that the districts can see the dishonest behaviour of their members. That is why when they make statements in here and outside of this House, they talk about issues that they do not understand, because they did not attend and listen to the proceedings of our Sitting.

MR SPEAKER: Well, I apologise to the Hon Prime Minister...

Susuga Hon Laauli Polataivao Leuatea (Gagaifomauga No.3): Mr Speaker an opportunity.

MR SPEAKER: I implore the member of Gagaifomauga No.3, apologies to the Hon Prime Minister, because it seems... I do not know who to blame, because it was... it is Fiame who is acting like this. I am now addressing this directly or delivering it with respect, but now I will say it straight, the Hon Sao Faapito Fiame. But I also criticize you Hon Prime Minister in these 5 years and the ten years that Fiame was Deputy Prime Minister, but you should have given advice. Advice the Hon Sao Faapito at the time when.... because this was the exact behaviour that was observed during the time of being the Deputy Prime Minister.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker, you are well aware of the situation, when she left, she said, I am free, but at that time, she was restricted under the oath of allegiance. Well, what are they going to do now that they are free? It is not a good situation, especially now that all the work of the Chief Executive Officers of the Government is put on hold so that they can attend and observe the condition that the Leaders of the country are in, but they are disloyal to their duties, and this is not a good image that is being shown to the country tuning in.

MR SPEAKER: Thank you. She was also free during the time of being the Deputy Prime Minister.

Susuga Hon Laauli Polataivao Leuatea: Well, Mr Speaker, a chance to say something with respect.

MR SPEAKER: However, we will end this matter in case the Hon Speaker gets accused for...No, it is in the essence of clarification, since I have mentioned the name of Aeau, the remaining senior member of the House, as we can see the weather outside is harsh, but he is able to attend today. For this reason, I had to say something about the senior members, because these two, the Hon Prime Minister and the Hon Sao Faapito, they are the two longest serving members of Parliament, that is the case.

Anyway, well, Laauli is there anything you want to address before this matter is set aside?

Susuga Hon Laauli Polataivao Leuatea: Yes, I speak with respect, and I appreciate your speech this morning. I have been listening carefully to the importance of the speech made by the member for Faleata who is currently speaking. Unfortunately, Mr Speaker, I am unhappy with the Hon Prime Minister, the issue being discussed is very different from the issue he is raising. I implore you to not criticize the country in our presence. Yes, none of us are perfect, sometimes we do not attend the Sittings, other times we would attend. But I beseech the Hon Prime Minister, as the Hon Sao Faapito is unable to attend due to some family and district matters, as well as the Hon Leatinuu. But I implore you since the country is listening as you stand up unannounced to insult and slander us for not attending the Sittings, but you the Hon Prime

MR SPEAKER: Well done. Pardon the member as I ask the Hon Prime Minister to stand.

Minister and Mr Speaker possess the wisdom.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker, Point of Order. This is not an insult; we are talking about our Standing Orders and our Guidelines. We are we not talking about the Guidelines? The Standing Orders and our Guidelines. And now I am standing to discuss our Standing Orders.

The reason why I am talking about these things, unfortunately there are a lot of false ideas being uttered outside of this House. But these are matters that should be discussed in this House with the observation of the country. We rise to discuss issues so that our Sitting progress smoothly.

These are the other things that are prioritised, like our Guidelines, but when they are outside, they slander the House, slander the Hon Speaker in the process of the Sitting. So, what can be done? It is best to attend the Sittings to listen to the speeches made by the members so that we can understand the things that are implemented for their constituencies. As for us, we are just observing carefully, since we are the ones who will be implementing the requests of our members in this House.

Mr Speaker, which is the reason for my emergence, in those days you were also part of the Cabinet, and attended our House Sittings, and I would call for our meetings before we came to this Assembly, what were the words you said? Please try to attend before the Assembly begins. I talk about everything, every single time; we must attend before the Assembly starts, ensure that we are present before the bell rings and a call is made for members to complete the numbers needed, because if the quorum is not met, we cannot proceed with our Sitting. In the previous Parliamentary term, the bell would ring every time.

Mr Speaker, if the member wants to tell the people what to do, they should lead by example, try to avoid the issue of saying, do as I say, but not as I do.

MR SPEAKER: Thank you. Well, I implore you Laauli...

Susuga Hon Laauli Polataivao Leuatea: Mr Speaker, I speak with respect...

MR SPEAKER: Laauli I beseech you with the utmost respect...

Susuga Hon Laauli Polataivao Leuatea: Yes, I beseech the Hon Prime Minister, stop looking down on us and continue saying we are dishonest. Please Hon Prime Minister that is enough, we have a few weeks left before our Parliamentary Term ends. That is enough because we are overwhelmed.

MR SPEAKER: I beseech the Member, I think... I beg your pardon because... Our Standing Orders, since our Standing Orders were questioned, it is a violation, and it is not appropriate with the Standing Order for another member to stand up, such as the Hon Laauli who stood up. It is unsuitable with the Order for a member to interrupt the interruption of another member. The intervention and the correction and the Point of Clarification is the reason why the Hon Prime Minister stood up, to explain and clarify some things that the Hon Member for Faleata said.

But now your interruption is made towards the interruption of the Hon Prime Minister, another speech was referred to the intervention of the Member for Faleata. I think, this is why I said to end this matter here.

For the audience of the country, I apologise, as the intention was to explain and clarify the things that have been raised in this Parliament. Just like the question raised by the Hon Prime Minister, on the Standing Orders I am adhering to. Now I am presenting it before you all. Therefore, I ask the Hon Member for Faleata to conclude your speech.

Afioga SALAUSA JOHN AH CHING: Thank you. The importance of the guidelines of each district. Given this new system, now the constituencies are being asked first. What do you need for your development? Because the ways that our country used in the past, mostly when we received funds from overseas, it is then distributed to our constituencies. This is the program that should be implemented; unfortunately, it was not suitable with the needs of the districts. Such is why when the funds ran out that program also ended. It seems that it is not a system that provides what we need in terms of the sustainability of programs. So now, the development programs for our constituencies should be sustainable, because these are the needs that our districts requested, that is the importance of these things. I also pray to each Ministry, which is involved and have partnerships in this development, to value the needs of the districts. The guidelines have been presented, and that is how we will proceed, from 2019 to 2029.

Now the District Development Committee of Faleata No.1 has been established and is currently continue....

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker, Point of Clarification regarding the Sustainable Development program. I stand to give a clarification, since we are being too eager, but the country is listening and asking what this is. This program originated after the guidelines for programs for major developments and for all the countries of the United Nation was presented. This was after the agreement was signed in 2015 in Paris, the capital of France. It is a guide that involves the whole world, as it is a fight against the enemy that the world is facing, climate change. Because of climate change, it has made it difficult for various developments to continue, due to hurricanes, tsunamis, fires, and more. As for our country itself, we have already passed it. It really affected Samoa. There were a lot of dry coconuts sent overseas. What has happened? There are no more shipments of coconuts overseas because it is not possible to continue.

Our coconuts were loaded and taken to Britain, Germany and other countries to process for coconut oil. There was a year when I travelled to Germany, and I went to the big city of Hamburg which has large ports where large ships would dock. It was here that the big cargoes of coconut and cocoa from Samoa would arrive, and I was given a huge logbook which records the arrival of these large ships. It also records the coconuts and cocoa beans that are exported to Samoa. Samoa is also one of the 14 countries that produced high flavoured cocoa. This is the greatest cocoa, which is still available today, and it is very much needed in the production of chocolate in Holland, England, Belgium and more. We had a lot of cocoa. There were cocoa factories, there were large machines used to dry the cocoa. There is cocoa that is taken as a whole and sometimes only the cocoa bean shells are delivered, since the cocoa bean shells are mixed with the cocoa.

So where is the cocoa now? There is no more cocoa. Also, for the banana, we reached a million-dollar worth of banana crates that were sent to New Zealand in the year 1960. Since only Samoa and other countries of the Pacific provided New Zealand with banana. But when the bananas were affected by the wilt disease, it stopped the distribution of bananas to New Zealand. So, these three major products were affected, the cocoa, the coconuts and the bananas. And then a plague broke out in the month of September in the year 1994, and it affected the taro. I remember at the meeting that was held here that the plight emerged. I remember that year, because that was the year that the first antigovernment strike was launched, and it used two things. First is the scarcity of taro due to being affected by the plight, and secondly the VAGST. It started a protest march in 1994, protest march in 1995, 1996, 1997, and 1998. This would have caused conflicts within the country due to these protest marches. Why? No taro, we earned \$10 million dollars a year from the exportation of taro to New Zealand. Once the taro got affected, we were unable to produce anymore taro. It has been almost 10 years or more since taro became unattainable. But was the country hungry? No. We had other different foods to replace it.

Mr Speaker, this meant that Samoa depended on these 4 food products, coffee was also moderate. When we talk about Sustainable Development, we can also discuss the continuation of developments that we depend on. That is why the world values developments that need to be continued. Because Samoa is not the only one that is affected by these things, the whole world is affected and is suffering from the emergence of diseases.

Because Samoa is not the only one affected by these things, it affects the whole world and it will suffer, from all these diseases. This is why countries around the world do not undermine, Sustainable Development. What we are trying now is to try and find any type of banana, so that we can have the banana we first had before it was diseased, the banana bears fruit, and a bunch is centimetres long. The bananas in the past bore fruit without diseases, before it was damaged.

The member of Vaimauga East is listening. The reason why I mention these things is because I am old. I was also a farmer that grew banana and carried bananas, perhaps this was before you were born. That is the way it is, it bears fruit, ripens, grows long before it falls to the ground. At that time, there were no diseases, but once the disease came, all our bananas suffered.

That is the importance of talking about Sustainable Development. We have come from it, we have suffered, which is why this announcement is so important. Therefore, I take the floor to remind everyone of the riches given to us by God. But where is it? All these diseases and disorders afflict us. That is why the Government is not sitting still, we are looking at other developments, when other things fail another can suffice, in order to continue the well-being of our people.

MR SPEAKER: Very well, thank you. I call upon the member of Anoamaa East, Afioga Lufilufi.

Afioga Alaiasa Muagututi'a Moefaauouo Malagaitutogiai Sepulona Moananu (Anoamaa East): Mr Speaker, this is just a clarification in relation to the member speaking. The speech conveyed by the member last week was wonderful where he talked about the people's children, and everything in his speech. But there was something that I heard. It was mentioned that there are Corporations that distribute money to the constituency, when the money is gone that will be it. Since my constituency is listening in, in case they might think the member is just sitting here and not doing any programs where money is distributed to the rural areas. Mr Speaker, if we look at this some already have the intention to distribute a million each. It has misguided the constituency, but I want to ask the member, which of the Corporations was the source of the money of his constituency. With respect on the matter that I wish to understand.

MR SPEAKER: This is a good question; I call upon the member...

Afioga SALAUSA JOHN AH CHING: Thank you for the opportunity, I am also grateful for the interruptions that further clarified some of the issues of ongoing developments. This is the gratitude that I would like to say to our constituency because the development committee has been able to implement it well. At the same time, the constituency now meets every 2 months. And we have two more meetings left, we also have an account, at the moment there is \$2,700 in the constituency's account. This money is the contribution of the constituency, the villages that participated gave in \$200 each to register. The person that comes to the meeting, makes a contribution of \$5. If we find a sponsor, they get a \$10 fare. These are the efforts of this constituency, not only is it a big constituency, but there are many villages which is hard to organise. One of the...

The matter mentioned by the member, on some organisations from overseas that take money. This is exactly what we note from this development, it is unsustainable, because of certain circumstances. But it is in the interest of the current development committee that the demands expressed by the constituency, are not from overseas. The needs that were voiced by the constituency, those are the guidelines of the constituency. The second thing I am grateful for to my constituency, is the women committee which is almost organised. It is almost organised; majority of the villages have cooperated but only a few are still in the process of coming together. Once the women committee is formed, these will be the two areas on which the development of the constituency is based. The constituency development committee and women committee. This is where the benefits for the district should come from, as well as liaising with our Government, for developments and programs that need to be done. That is why I would like to commend and thank our constituency, because of the plans that we have come up with, let us keep trying since it is not easy. Therefore, I want to thank the village, Government and women representatives for their coordination.

Mr Speaker these are some of the needs of this constituency, the rivers, as seen in the recent floods. Most of the flooding that occurs in the western part of the town area, is due to this constituency, the rivers situated there are too strong. The river in Vaimoso is strong, since this is where all the rivers from Moamoa, Sinamoga and Alafua flows through in one channel. Once it cannot contain it, it overflows at the back of SMI, through Fugalei and Savalalo. The other river source is at Vaimoso-uta which leads to Taufusi, which floods the road in Taufusi. This is the same with the waterway at Fuluasou, it has reached our house.

Perhaps it is 50 to 80 meters between the river that is at Fuluasou and our house, but it still flooded our house. This is what we noticed in the inspection that was carried out in the constituency, the drains are crooked, also shallow, and the edges of the drains are very low, too low. Majority of these areas are almost level with drains and riverbanks also with adjacent lands. If we look at the existing drainage system, it is filled with sand. Most of the sand is settled in the centre. When you look at the cement bridge in Sinamoga, you will notice underneath the bridge is bent, it is curved in...

MR SPEAKER: The time of the member is finished.

Afioga SALAUSA JOHN AH CHING: Perhaps as much as 2 feet...

MR SPEAKER: I call upon the member...

Afioga Faumuina Asi Pauli Wayne Fong (Urban West): Mr Speaker, I note that the beautiful speech by my fellow member of Faleata is nearly at its conclusion. But it is just an idea, since the ideas of the member are quite interesting. Therefore Mr Speaker, I move a motion to add another 2 days for the speech of the member, his ideas are very interesting. With respect thank you.

MR SPEAKER: Very well. The Chair will not accept such irrational matters. Do you think the Chair is stupid?

Afioga Faumuina Asi Pauli Wayne Fong: Mr Speaker, this is a humble opinion. Since the member has been speaking for 2 days, which is why I conveyed this opinion.

MR SPEAKER: Be patient, sit down, while I convey a statement. You just came in maybe 5 minutes ago, but you have stood up and interrupted the House with such nonsense. Show some respect, there is a difference between a new matai and an old matai. It is measured upon culture, respectable manners and relationship. Likewise, I call upon the member to conclude his remarks.

Afioga SALAUSA JOHN AH CHING: Thank you for the interruption this is good, I will try for another 2 days. The river is the reason, this is why I request the Ministry and Minister to review this matter.

I know that there are already reports being submitted by the constituency on some of the areas destroyed. Not only with cyclone Gita, but also other areas damaged by the recent floods. This has been added to the report, and other things and a request for an engineer, to try and find a solution, on what can be done to resolve these things.

I also think, these are things that are not easy, talking to the constituency it is not easy to try and fix these crooked drains. But perhaps this is the era of innovative thinking and innovative designs by engineers to solve this problem. Because it seems these problems will continue to happen every year, like an annual event. And the flooding will not cease as it will only increase each year, it is comparable to the celebration of the Teuila every year, and the floods will be an annual event. As for long term plans, this is left to the Government, such plans and a resolution is needed right now, in digging of the canal. I mentioned the cement bridge at...

MR SPEAKER: I just want to remind the member, with reference to the situation, to just voice your concerns to the Ministry of Works, to be heard by the engineers and Ministers who will take note of it. Because your time is being taken up by trying to clarify the matter in detail, but you do not have an engineering degree, only medical degree. Leave the matter to the Minister, recommendations are important, but it is taking up our time, because that is the duty of the Minister, hence the Chief Executive of the Ministry is also listening.

Afioga Alaiasa Muagututi'a Moefaauouo Malagaitutogiai Sepulona Moananu: Mr Speaker...

MR SPEAKER: Are you taking the floor since your query has not been answered, or...

Afioga Alaiasa Muagututi'a Moefaauouo Malagaitutogiai Sepulona Moananu: Mr Speaker. Pursuant to Standing Orders since it has been mentioned. I move another 5 minutes for the member to continue and conclude his speech. As for the drains mentioned, I believe the water here is less than the ones seen in our constituency. But the reason why it overflows is us, even though we can the river, but we still set up lands beside where the river usually flows to the sea. But once people started developments, they reclaimed the land building it higher, blocking the water which ends up flooding other families. This is the assistance since I have some knowledge regarding flooding. But I propose another 5 minutes to conclude the speech of the member. With respect.

MR SPEAKER: I appease the member, but a decision has already been made. The member of Faleata also moved additional time for the member, for 2 days. We do not have any provision to move for 2 days, it is a pun, this is why. There are times when the Chair is not an angel, when a word voiced is to make fun of the situation, this speaks to the Chair that it is being challenged. Nonetheless I give the opportunity to the member to conclude. Leave the matter to the Ministry of Works, there is also a lot of work on that side, but the Ministry should look into a solution for problem.

Afioga SALAUSA JOHN AH CHING: Thank you. The statement voiced is honest and true, I have no intention to pursue hence it is left to the Ministry and the Engineers. The only request that is needed now, is to dig out the sand from in the drains, which is making the drains shallower. The bridge at Sinamoga, perhaps there is probably 2 feet left between the sand and the arch that is on the pavement of the road, before the drain is blocked by sand. This is why I request, since we have more rain coming as reported by the Metrology office. This is the reason for this request with respect.

MR SPEAKER: I call upon the Hon Minister, pardon the member.

Susuga Hon Papaliitele Niko Lee Hang (Minister of Works, Transport and Infrastructure): The doctor engineer has already given a letter regarding the matter he is sharing. For the sand mentioned, it has been done, thus the Ministry and management are also listening in, and they will go oversee it later, I was instructed to overlook this matter recently. Because there was a lot of sand in the drains and whether any work was being done. But this matter is being noted, thank you.

MR SPEAKER: A clarification has been given by the Hon Minister but conclude with your remarks.

Afioga SALAUSA JOHN AH CHING: Thank you, thank you an answer has been given, because it was just last night that I had a conversation with the men of the constituency. They also gave their opinion, if the Government agrees, whether it is difficult or late. Whether families living nearby can be allowed to remove the sand.

To move the sand from the drain, but since the Minister has responded, perhaps we will now await the Ministry.

The access road of this constituency, there are a lot of internal roads between houses. Perhaps most of these roads are about 50 meters it is not long but there is a lot. We do not know what system to use. I sent an email to the Chief Executive of the Land Transport and Authority because of some new methods, which I found on internet, using old car tires, with respect to the House, to construct these roads. They are cut off the sides, put together and then buried inside. It is buried with either gravel or dry coral, which is hard, it is very sturdy. This also makes it hard for the water to move it during the rain, because it is stuck in the car tire. These are a few new ideas, or innovative thinking and design to try these things. Because they do not know what to do, I also informed the constituency during our meeting to start collecting car tires so by the time Galumalemana and the Land Transport Office come around, we would have enough tires to do the work. That is the situation even with the roads, it is difficult to control the water, and I humbly request the respects of the constituency, to the village councils, Chief Executives, engineers, doctors, lawyers residing within the constituency, to let us work together. Whatever you can do to help, and support the development of the constituency, we welcome with gratitude.

Afioga Fuimaono Teo Samuelu Teo (Falealili East): Apologies Mr Speaker. Since there was a mention of gathering tires, but we should remember that this is where mosquitos breed, however the only I want to understand, whether it will be a good development or what exactly is the use of these tires we will await the Ministry. Also, what is going to be done with this pile of tires whether it will bring about another disease with the tires that will be collected by the constituency? With respect.

MR SPEAKER: A pile? Pile of tires? The member understands the query.

Afioga SALAUSA JOHN AH CHING: It is true, well there is nothing in this world that is perfect. When we try to do something good, there is always a problem that follows. Just like the car tires mentioned by the member, he is right, car tires usually store water, which becomes a breeding ground for mosquitoes.

But the thing is, if tires are collected, it should be ensured that it does not store any water. Find a way, like covering it with tarpaulin so that no water will be stored within the tires. Then wait for the time LTA gives the okay, then it can be used for our roads, we can roll it around...

Susuga Mulipola Leiataua Laki (Aiga i le Tai): Mr Speaker...

MR SPEAKER: Very well thank you. The answer for the matter has been voiced. Is there anything else that you want Aiga i le Tai?

Susuga Mulipola Leiataua Laki: I stand with respect, Mr Speaker since Faleata is in need of car tires, but our constituency has a lot of tires, if you need it, we are happy to give it to them to assist with their tire collection. With respect.

MR SPEAKER: Perhaps the member means well. I call upon the Hon Prime Minister.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker, Faleata has just now mentioned tire-built roads, but it has long been used by Saleufi where I lived going to school. Saleufi is mostly a swamp area. The tires are laid out then gravel is used to fill the inside of the circular space to keep it in place, you step from one tire to another. Beside the line of tires is a channel, where small fishes live. If mosquitoes do want to breed in the channel they will be eaten by these small fishes. These type of fishes like eating mosquitos. That is why it is also important to save these fishes, any mosquito that lays eggs there will be eaten by the fishes. This is a brief explanation on the idea stated by the member, this technology has long been implemented by the village of Saleufi.

MR SPEAKER: Very well. Aiga I le Tai do you now understand how it is used? On the significance of how it will be used regarding the member's intention.

Susuga Mulipola Leiataua Laki: Thank you. It has been noted.

MR SPEAKER: Thank you. I call upon the Hon Minister of Works, Transport and Infrastructure.

Susuga Hon Papaliitele Niko Lee Hang: Mr Speaker, with utmost respect I do not wish to interrupt the speech of the member. I take the floor since the Prime Minister has stated that the tires have been used for years. The matter is, we should not be using such methods anymore, the development of Samoa is moving forward, if we use tires again, this means we will go backwards. But leave the matter with our engineers who will overlook a solution on how to use these tires. Now Manono wants to give away their tires, piling it up over there. With respect.

MR SPEAKER: We have all heard the response of the Minister, we do not want to go back, also I humbly ask the member to not use these tires, since we have progressed forward, the Ministry of Works will come by and oversee what should be done. I call upon the member.

Afioga SALAUSA JOHN AH CHING: Thank you. I want to thank the Hon Minister who has clarified this matter. I also thank my fellow member from Manono, but no, leave your tires in Manono.

MR SPEAKER: The reason why I mention this respectable member, is to assist, as stated by the Hon Prime Minister, if we look at Saleufi the area which was owned by Grey, now where Bluebird and the market is at, that road was mostly made up of car tires before independence. From 1962, 1963 up to 1970. What now? Majority of this area has now been developed by Government, and we do not see this anymore. Therefore, the Hon Minister has stated, the member of Faleata be considerate, as the Ministry will come by, but I advise not to use those things, since we no longer use such methods nowadays.

I call upon the member...

Susuga Mulipola Leiataua Laki: Mr Speaker, no I made the statement in good faith to assist with the gathering of tires of the constituency, unfortunately it has been rejected, but I was going to give to him for free. Nevertheless the tires of the constituency will be left as it was, since it has not been accepted. With utmost respect, good luck with our Sitting.

MR SPEAKER: Thank you. Well leave your things there, also you will not be coming back in the next elections, maybe you can later make use of it with your time.

Susuga Mulipola Leiataua Laki: Perhaps this will be given to you since we are close to each other.

MR SPEAKER: I call upon the member, also refrain from the mention of tires regarding the interruption from the member.

Afioga SALAUSA JOHN AH CHING: Thank you. When there is a lot of demands in the constituency, well the member will act on it, and the demand of the constituency is overwhelming, because there are a lot of roads, small roads, but we do not know what to do with it.

Therefore I have been doing some research on what to do, and this idea was proposed to the constituency, also we should not be reliant on anyone but should lead in what should be done. If we help ourselves, our Lord will assist us as well with our needs. We need to help ourselves first then the Government will show compassion later and the Minister with what we do. Yes. This is the spirit. It is also the reason for trying to find solutions elsewhere, but since the Minister has responded, we will change it then, and await the assistance we hope will arrive soon. Thank you.

One of the other requests of this constituency, are the lawn-mower contractors. It was raised in the meeting for development of the constituency a proposal for the aumaga, for a lawn mower contract to be given to the constituency so the untitled men can receive the financial benefits.

Remember I mentioned last week that the *aumaga* is the strength of the village, they are the ones the village council is dependent upon, also for the women and development of the village, they cannot go and find full time work, but if there are such contracts, the village has already submitted a letter for consideration by the Minister and Ministry. If mowing contracts can be awarded for the development of aumaga in the constituency.

Susuga Hon Papaliitele Niko Lee Hang: Mr Speaker...

MR SPEAKER: I call upon the Minister of Works, Transport and Infrastructure.

Susuga Hon Papaliitele Niko Lee Hang: I thank the member for raising this matter. The Land Transport Authority has long discussed the situation in order to conduct a survey of communities that want to use their youth to carry out this work. I am not sure how the research is going but a comparison will be carried out on contract work whether it will be cheaper to be performed by the constituency mentioned by the member. This has been included in future plans of the Land Transport Authority. This is important to assist with constituencies and villages to make use of the youth who are unemployed and earn money if there is to be a benefit for the community who are willing to do this work. The member has already made a request on this matter, and I have already explained it to him, and I told him to leave it with me since there are other constituencies who have submitted similar requests. The Ministry and Authority are currently carrying out a survey, to oversee whether it is cheaper for villages and constituencies to carry out this work, and not give it to other small businesses who are doing this work of lawn mowing, who are bidding for it. With respect.

MR SPEAKER: Very well. I call upon the member your time is over.

Afioga SALAUSA JOHN AH CHING: Very well, thank you. I will now conclude.

Our constituency, the speech of your member is now going to conclude. There are a lot of challenges faced by the constituency, however let us be patient. Those who are patient, will receive a good blessing later. This constituency of Faleata 1 is new, and we have only been together for a while, and I believe our journey is off to a very good start. Our ship is beautiful, the crew is kind and friendly, well-mannered and orderly. Any purpose in this life can only be achieved if the foundation is good and solid. And I believe the foundation of our district is solidified by our current developments. I hope we would be able to complete some of the projects that we are trying to do for our constituency. Looking at the course of Government and the work of the country, I now understand the Government's policies to implement its developments. Now I see the reflection of the light of the road, I also can see the shadow of the door, and can see the man standing in the doorway.

Therefore, my constituency, we all want to get there. We all want to reach the end of the road, we want to open this door, and I want to talk to this leader, for the needs of our constituency moving forward. This is why my constituency whatever decision you make in the upcoming elections, if you want me back to continue with these developments, that is your authority. If our constituency has a different opinion, I will not complain, I will not say anything. However that is my desire, and the motto this member lives by is, live to serve, live to serve.

But I wish the best with our Proceedings, blessing upon the House. Soifua.

Members of Parliament showed their appreciation by applauding after the speech of the member of Faleata East.

MR SPEAKER: Thank you. I call upon another member. I commend the member for his remarks, I believe the constituency is pleased with the developments and commemorations for the guidance for the development of the district for now and future. Thank you to the member.

It is now time for another member. As we all heard the member of Faleata has prepared a lot, however in keeping of our time, we should share it equally. However if this is the case, trying to persuade members to take the floor, then let us consider another situation.

I can see one of the members is upstanding, unfortunately we have arrived at our recess time. I was hoping to know the member so that when we return, we can start right away. Alright I can see now it is the Deputy Speaker. Thank you. Well I believe when we return from our recess, the Deputy Speaker will start our sitting.

I announce that the Proceedings of the Legislative Assembly will be set aside for its usual recess.

Proceedings of the Legislative Assembly were suspended for its usual morning recess at 10:35 am and resumed at 11:25am.

Debate continued on the second reading of the Supplementary Appropriation *Bill* (No.1) 2020/2021.

MR SPEAKER: I announce that Proceedings of the Legislative Assembly now resumes.

I applaud you all for your attendance. I would think that you have all gained energy to continue with our business.

Before we went into recess the member for Gagaemauga No.3 had indicated his desire to speak. I call on the Deputy Speaker for his remarks on the Supplementary Appropriation (No.1).

Tofa NAFOITOA TALAIMANU KETI (Gagaemauga No.3): I am of the view that refreshments provided were enjoyed by the Speaker, the Prime Minister and distinguished members. In saying that I convey appreciation to the Clerk of the Legislative Assembly for the preparations this morning.

Mr Speaker when there is excitement in the air here at Tiafau so it should be as the defenders of this court will not accept actions of impropriety. We are approaching the end of our 5 year term. We have all had exposure to the weather extremes in the name of service. We are now at a time when the merits are awarded. We cannot alter our fate as God provides and taketh away. We will not forget your contribution when we entered in the previous term, and you always spoke first. I pray that you find your place in the Kingdom of Heaven eternally. I express my condolences to your wife and children and the constituency. May your journey be filled with the grace of God.

Mr Speaker, you maintain order and decorum in the House. There is no one before or after you in that capacity. So I am grateful for this opportunity to contribute to the Supplementary Appropriation (No.1) 2020/2021. I must express the official commendations on behalf of my constituency of Gagaemauga No.3 which has now been referred to as No.2. For the upcoming election. That is from all the people of this constituency near and far thank you for your support during this 5year term. Samoa stretches from the court of Malaefonoa towards the sacred grounds of Tonumaipea defended by Alataua. With its principal orators and meeting places all determined. It is said that when the hunters at Manua prepare for their games they would firstly mark the Tuimanua's birds by identifying their feet with seashells to distinguish them from the great number of birds.

I vividly recall your statement and blessings when the constituency were all present during the upgrade works to our hospitals, "may the continuation of your representation of the community be blessed". My intention here is that our community continue to reside in harmony and order. When I think back at the day when I presented food and such during my traditional gift (o'o). I prioritise Falefagamalo to ensure the dignity of the constituency is upheld and complete. My intention today is that we remain in peace.

Susuga Hon Laauli Polataivao Leuatea: Mr Speaker I seek an opportunity please.

MR SPEAKER: There is an interruption. Perhaps the Maiava clan will take a breather. Thank you for the respect you have accorded to the Mataia clan and also Mauigoa the half man half demon.

Susuga Hon Laauli Polataivao Leuatea: I rise with respect.

Tofa NAFOITOA TALAIMANU KETI: I do abide by our Standing Orders. So, unless you instruct me to resume my seat. The speech of Matautu will continue if the member interrupting does not get an opportunity. No one hardly interrupts the speech of Matautu as I hold a spear in one hand and my colleague knows very well what I will do with it.

Susuga Hon Laauli Polataivao Leuatea: Mr Speaker it is the reason I am trying to join the debate as I am keeping to our mutual relations. I did say to the member at the beginning of the term that Gagae and Gagaifo is a family. But it seems this morning that the member is intimidated and concerned. Mr Speaker I am referring to Standing Orders.

Tofa NAFOITOA TALAIMANU KETI: I am sorry to say Mr Speaker, but I am not sure whether this is an interruption or a reprimand. After all, Standing Orders is at your disposal.

Susuga Hon Laauli Polataivao Leuatea: Standing Orders provide that someone intending to contest the elections is not able to respond. Nafoitoa! Do display vision, our village are following proceedings. I had also advice Falealili on the same note. Let not your anxiety cause a stir between the people. The senior deacon has not given a response to his decision to run. With your comment well it does exude power and all. You can come to me with power and the sword, but I will come to you in the name of Jesus Christ.

Tofa NAFOITOA TALAIMANU KETI: Thank you I understand the interruption now. Thank you, Mr Speaker.

Susuga Hon Laauli Polataivao Leuatea: Exercise sagacity since the senior deacon cannot respond. Our Standing Order stipulates that. Do not create provocation amongst the community.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker what the member should do is to get up and state, point of order before resuming his seat. But going on and on and on, and the reason behind these developments is him. He is provoking people. Mr Speaker, instigating provocation and then getting up to stop other people statements. Mr Speaker that is the point of order against the member.

Susuga Hon Laauli Polataivao Leuatea: Hon Prime Minister, does the truth hurt? Do not provoke the country, we are trying to counter your actions on television day and night, Monday to Sunday.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker a point of order. This is the exact reason why he got up. He was hurt by the speech of Matautu. That is what you get for interrupting unnecessarily.

Susuga Hon Laauli Polataivao Leuatea: I beg tolerance of Matautu. I was directing my remarks towards you. You understand the support I have given you during this term. Do not forget, and despite your saying that we have no connection, well we do. I am saying I beg tolerance of you, but it is the senior deacon's right to run.

MR SPEAKER: I beg tolerance of the member.

Susuga Hon Laauli Polataivao Leuatea: All my relatives within the constituency are listening in and they know where I stand.

MR SPEAKER: I beg tolerance of the member...

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi: Mr Speaker, he has done this too often breaching orders.

MR SPEAKER: I beg tolerance to the Hon Prime Minister.

Afioga Sulamanaia Fetaiai Tauilili Tuivasa: Mr Speaker a point of clarification. I wonder if an opportunity can be given to Vaimauga.

MR SPEAKER: I will allow the member for Vaimauga, to see whether his contribution could solve the problem.

Afioga Sulamanaia Fetaiai Tauilili Tuivasa: This constituency of Vaimauga East does not wish to interrupt the speech of Matautu. You know this Mr Speaker and members. My colleague here is regarded by people as my brother. The only difference is the member for Vaimauga is handsome than him. The statement he made that no one could interrupt him. Well let me say that this land Vaimauga we are on is subject to the authority of Tuisamau. So please, I am here, and I will speak because this is my land. So Matautu it is only Vaimauga which you should show consideration. Only I can interrupt you. I thought I will say that Mr Speaker, I wish Matautu and his remaining remarks come out well.

MR SPEAKER: The member will know its fault and contempt of proceedings. The member will continue, and I advise that your remarks focus on this world we are in.

Tofa NAFOITOA TALAIMANU KETI: I will address the point made by the member for Gagaifomauga No.3. God knows what you said and yes, it is not wrong. It is the reason people are criticising me for that day. Why? The tears I cried were said to be running mucus, well it is not. That is how I feel, and I do express my appreciation. God's justice cannot be omitted when carrying out my duties as the representative of Gagaemauga No.2. Your statement Laaulialemalietoa that I should switch over to you guys, well no I will follow the justice of God.

Susuga Hon Laauli Polataivao Leuatea: Mr Speaker a point of order, Nafoitoa I did not say such thing, not even a word. You have already drawn the line between us, let us go to the polls on that note. May you have courage and prepare to buy loads of towels in preparation for your battle with the senior deacon.

MR SPEAKER: Thank you.

Tofa NAFOITOA TALAIMANU KETI: Laauli! You are too arrogant with what you say. Do not forget that Gagaifo seeks counsel from Gagae. Regarding what you said, well you prepare yourself for the elections.

Susuga Hon Laauli Polataivao Leuatea: Let us have it that way. Mr Speaker the only point I was trying to get across is that my colleague is unable to respond hence my suggestion to tread carefully. Leave it up to our constituencies, our families will decide.

MR SPEAKER: Since you are gearing to go at each other. Leave it at that for it seems that each of you intend to counter every word being said at each other. That is not a sign of wisdom. The wisdom of seniors is such that you have control of your heart. That is counsel to focus on with regards to exercising wisdom. Being in control of your heart will not make one lose points. In the eyes of the seniors and the world, ahhh that person has wisdom. So we will leave it at that and the member will continue, come now we are...

Afioga Fuimaono Teo Samuelu Teo: Mr Speaker I seek an opportunity.

MR SPEAKER: I beg tolerance Falealili is it something to assist in the matter...

Afioga Fuimaono Teo Samuelu Teo: The member interrupting mentions me for no reason. When he should direct his point of interruption to the member having the floor. Mentioning my constituency when that matter was resolved on the day. Regarding claims of provocation, well let me say that the member should not make it a habit to make this claim when he is the one responsible for such act of provocation.

MR SPEAKER: I beg tolerance of Falealili for you are bringing up this matter again. I do not understand which constituency you are referring to. I call on the Deputy Speaker.

Tofa NAFOITOA TALAIMANU KETI: Thank you Mr Speaker I will not contemplate on trivial matters. With the comments from Laauli, well I will say no more, as I was merely addressing my constituency. Gagaifomauga have no say in our relationship and the protection of Falefagamalo our principal meeting place. I shall continue and Matautu is a village of combat...

MR SPEAKER: Laauli, do not interrupt the speech of the Deputy Speaker please.

Tofa NAFOITOA TALAIMANU KETI: No one can ally with Matautu. My village thank you for your consideration. Let us go forward and strive for success. I commend the support of my community. I do not doubt you and I often say that we are one we have the same salutations, the same messenger which is Sua ma Faalea.

We pray, for blessings from God upon you and all our people who are living in the 4 corners of the world, to find success for families, village and the works of our God.
