# SUPPLEMENTARY APPROPRIATION BILL (NO. 2) 2015/2016 ANDAPPROPRIATION BILL 2016/2017 –debate on second reading

MR SPEAKER: Pursuant to Standing Orders 132 debate on the two Bills will progress and we should speak directly towards the Appropriation and the growth of Samoa and to any provisions related to the Appropriation. This is also the opportunity for Members of Parliament to speak directly on the budget now tabled. May I also add that your remarks shall be known as maiden speeches? I advise you to keep it short for we have other matters to press on. I now call on the representatives of this Parliament to take the floor while the country are tuning in to proceedings.

Afioga TOLEAFOA KEN VAAFUSUAGA POUTOA (Lefaga & Faleaseela): First I want to convey a word of thanks to the Chair for the praises voiced for another new day through the love of our Heavenly Father.

MR SPEAKER: Very well. The member is taking the floor for the first time since it is his first term in Parliament, respectable member for Lefaga and Faleaseela. I call upon the member for his maiden speech.

### MAIDEN SPEECH

Afioga TOLEAFOA KEN VAAFUSUAGA POUTOA: First of all, I commend you Mr Speaker for the prayers this morning to our Almighty God. For his grace has enabled the Hon Prime Minister, Cabinet and Members to be here on this glorious morning.

Mr Speaker thank you for the opportunity accorded to me to address this House on behalf of my constituency of Lefaga and Faleaseela to submit our contribution on the Appropriation tabled before the House and the concise statement by the Minister of Finance.

Mr Speaker with the Appropriation now before us, I extend my appreciation to the Minister of Finance, for he is new to the calling but is very familiar with duties. I am satisfied with his address in allocating our capital and appropriating it properly according to our fiscal policies. I have gathered that you have prioritized Health and Education. This constituency supports your decision because the future success of a Nation depends on healthy educated people, this is important when it comes to the interaction with colleagues from abroad. I also understand that the Appropriations is our guide in the development of Samoa, it is a Strategy for Samoa, which begins now and the next four years 2016 to 2020. I am of the view that if something is well organized and it is equally implemented and it is transparent to the public it will eliminate criticism. I advise that if issues may surface do not be discouraged for our Father in Heaven will never forsake us.

The objective of the budget is to spent wisely in order to have control of the economy. We must have vision for the future and courage to continue with our developments for the prosperity of Samoa. This XVI Parliament is well under way, so I will now come to the demands of my constituency. My request to the Hon Minister of Health is a proposal for a medical sub center for my constituency which will be convenient for my constituents' medical checkups. A doctor and nurse can travel from town daily as its happening in other parts of the country.

My appreciation to the Minister of Education, Sports and Culture for the new school building currently under construction at Savaia Lefaga and Faleaseela thank you for distributing. There is one thing I would like to bring to your attention a request from a parent at my constituency. This is about allowance for students at our National University whom are receiving local scholarship. I understand that the allowance is received at the end of the term. Is it possible for the students to receive this money early to meet the cost of registrations, course materials and their fares? Some families are struggling with the fees, it is really hard. My point is that they will be able to complete their studies. I will leave it to your discretion.

Hon Minister of Works, Transport and Infrastructure of the Government, we have put forth our proposal and we do have several roads that need maintenance. We are giving priority to Tafagamanu and Faleaseela, reason being there is no access road to escape inland when a possible natural disaster strikes like the Tsunami of 2009. Hon Minister if you look at the map of this area you will notice the danger that the people of these two villages would face due to the poor road condition. Thank you for the new roads at the villages of Safaatoa, Savaia, Gagaifo, Matautu and Matafaa all it needs now is maintenance. I understand that you have visited Faleaseela and Falelatai road, travelling down towards Falelatai is ok but the outback road at Faleaseela is bad. Would you consider maintenance for this road? This road is always busy with people from Apia travelling towards the airport. It is also popular with tourist and the public making round trips along this route.

I also request a modern tar sealed pathway or bridge for the Liua le Vai o Sina stream at Faleaseela to preserve this natural beauty, moreover when it overflows it becomes a traffic hazard causing delay in travel. I humbly ask the Hon Papalii to consider our constituency when distributing funds.

Hon Minister of Police, Fire and Emergency Services, Prisons and Rehabilitation Services, allow me to extend my appreciation to your Ministry for your service, we are aware of the Government initiative for the new Prison to Tanumalala. I am very concern about this as it will be within my constituency. When elections takes place it will be covered in our electoral boundaries. My concern is pointless as this is underway. I will advise though to really look at the issue of safety for the villagers nearby. I recommend that the structure should be like the prisons overseas and there should be a sufficient number of staff. For instance if there are 200 prisoners there should also be 200 guards to avoid prisoners breakout.

I want to mention the oil tanker that caught fire at Matautu. Thank goodness, if this had spread it the township of Apia would be wiped out. I am glad that the fire truck from the airport had a special chemical which contained the fire quickly. I think there should be a similar truck here in Apia since there are a lot petrol and diesel tanks as well as gas reserves within the town area. We must take this incident as a lesson.

I want to thank the Hon Minister of Agriculture, Scientific Research of Samoa and Fisheries for the bonuses made available for cocoa farmers. Would you please look into our taro, tomatoes, cabbage and other farming products to be covered by this initiative? In reality, the quantity of a farmer's production depends on its own financial source. Now if the government can assist in terms of a bonus schemes it will surely increase our production capacity consequently we will be exporting these products minimizing our imports of the same.

To the Minister of Natural Resources and Environment, the International water day that took place at at our village of Faleaseela. There are just two villages of my constituency that needs seawalls, Faleaseela and Gagaifo Lefaga. I want to remind you of our request for access roads for Tafagamanu and Faleaseela. I would really like for this to be done as soon as possible because of the looming possibilities of natural disasters due to climate change.

To the Hon Minister of Women, Community and Social Development thank you for the assistance in promoting of weaving of fine mats. I ask that the program will continue so as to encourage this wonderful tradition.

To the Hon Minister of Communication and Information Technology, there are areas of my constituency which do not receive television signal. This area is from Liua le Vai o Sina right up to Faleaseela. I humbly ask that this area be revisited for further development.

Mr Speaker these are some thoughts of this member on behalf of my constituency on the Budget. I beg tolerance if I may have uttered any disrespect especially to all of Samoa listening in this morning.

We are gathered here today in good spirits and good health due to the grace of God in which our country is founded upon. The salutations of our Lord Savior shall be accorded to his chosen servants, the clergy. I will now voice my contributions on the theme of today deliberating the developments for my constituency and the country as a whole.

I respectfully applaud His Highness O Le Ao o le Malo and his Good lady for your service to the people of Samoa. We salute your patience and vigorous determination in your duties. We admire your leadership for our economy has improved and our standing in the world is elevated despite setbacks and negativity over the years. As the bible says, "the male lion may be short of food, but the person who fears the Lord shall not be deprive of anything" God is the source of wealth. He will fill your vision and provide you conviction. I pray that the Lords spirit be with you during your tenure.

This is perhaps the right moment to congratulate the Hon Minister of Finance for the submission of this wonderfully prepared Budget. For it indicates a drop in expenditures meaning our economy is improving.

Mr Speaker and Hon Prime Minister I will now state the needs of my constituency through te Ministers of Cabinet. Afioga Papali'itele Niko Lee Hang, the Minister of Works Transport and Infrastructure with the utmost respect I would like to bring to your attention our roads. I do not need to stress the importance of this to the travelling public. It has been four months since work began on parts of our road. We are confused as to what has happened to the construction company. Since then our community and the public have faced dirt road dust which affects our health. My concern here is that our local community has resorted to sea water to contain the dust and consequently affecting our assets. Secondly Minister is our access roads, this is vital to our farming projects, and our school children when walking to school in the morning, and the senior people of my community. I understand that it is a huge undertaking but it has been 30 years since any maintenance work has been done to it There are two access roads at Lalovi at the east end it is next to Fua'iloloo, at west end it is next to Satuimalufilufi. Our road at Apolima Mr Speaker is really causing damage to most of our motor vehicles from the pot holes and bumps. Faleu Lepuia'i and Salua all have access roads. I respectfully submit to consider these roads for our developments.

Thirdly Mr Minister is our drinking water. I appreciate the service of the Ministry. Your contribution to service to the country and its developments is massive. However, the water supply to my constituency is scarce. With a lot of areas within my constituency, the water only comes late into the night when water usage becomes minimal at that time. It is only families alongside the main road and those living 60 to 80 meters inland.

My community at Manonotai do not have water supply, accept for a few water tanks that our people are using to counter the drought. When there is no rain our local people will travel to Upolu. They have to find a boat a motor vehicle, there is preparations for going back and forth to the island.

This is the difficulties and costly reality experienced by my people at the island. I request the installing of water pumps at my constituency to improve this service. Sir it is a fact that water is plenty at the inland area of my constituency of Aiga i le Tai which is supplying Aggies Resort. I am only asking you kindly with no intention of instructing you.

My fourth request is a reminder for a wharf to serve our community and the general public. The current state of the wharf and the building on the site is poor. The cement is showing cracks and is no longer safe for the travelling public. There are several good tourist developments at the island but the problem faced by these developers is the wharf. While on this note I ask you Mr Minister there is a need for beacons as guides to the boats direction to ensure safety. I recall there were beacons in the past when travelling to school, and now there is no more. This is vital to direct the correct path for boats and to indicate the shallow areas to ensure the safety of the travelling public.

Before I voice my sixth request I want to accord through your good self my commendations to CEO of the Electric Power Corporation for the lights at some of the small wharves. The thing is there are more wharves so there is a need for lights at these areas to light up the area for the public. Problems will prevail when daylight savings starts again. We support the daylight saving concept if lights are in place.

MR SPEAKER: I do not wish to interrupt the member since it is your maiden speech, however I do note that you have quite a bit to cover. I beg tolerance of you, so I advise to keep it short in case you will not be able to say everything within 30 minutes allocated. Besides, it will make it easier for the Ministers to make note of what you have prepared.

Susuga MULIPOLA LEIATAUA LAKI: Thank you Mr Speaker but I will now conclude.

My other request to your Hon Minister is the state of the seawall alongside the road at both east and west ends of the Methodist Ministers home at Lalovi which has no seawalls. The seawall at the other end of my constituency is complete but not this end which is a concern as the water level is the same as the road. When the tide is in it affects the road and the community living around this area.

Another request is to the Hon Deputy Minister Fiame Naomi Mataafa, Minister for Natural Resources and Environment. I am grateful for the numerous projects completed at Manono. I want to point out this government's catchphrase, "what is good for Upolu is good for Savaii" I feel that what is good for Upolu and Savaii is particularly good for Manono.

The seawall right around Manono is in a dire state, since most of the land area is eroded and consumed by water. The community is doing their part by piling rocks to protect our land area. If a tsunami strikes these rocks will become objects of destruction to assets and lives.

We had also requested land for our constituents to cultivate and as you are aware Hon Minister our land area inland is next to lands that belong to you. The people of my constituency will also have a place to relocate to in times of flooding and tsunami.

The Hon Minister of Justice, Courts and Administration, Electoral Commission, we humbly request consideration for another representative for Aiga i le Tai, since our electoral roll has reach 4035 in the previous election.

Another important matter I want to raise, now with all due respect to the Minister of Communication and Information Technology Afioga Afamasaga. I suppose my conviction will evoke a solution. I feel that the village of Satuimalufilufi should be within my constituency, the reason being is this. Paepaela within Mulifanua is next to the new settlement of Satui, then its part of Mulifanua again. Then another settlement of Satui next to Apolima and another settlement of Satui neighboring Manono. I feel that it could perhaps simplify the operations of the Electoral Office when dealing with these two constituencies

My last request is to the Hon Minister of Health Tuitama Talalelei Tuitama, would you take into consideration a Hospital for the Island of Manono. It's really difficult to find a boat, a vehicle especially in bad weather. Normally by the time transport is sorted the condition of an elderly man or woman has deteriorated. The Hon Prime Minister, Cabinet Ministers, all respectable Members, all of Samoa listening in, and all clergy. That is the contribution of Aiga I le Tai. If I may have offended anyone I beg tolerance.

May our Lord bring blessings upon His Highness O Le Ao o le Malo and to the Members of Council of Deputies. I wish the Speaker of the House wisdom in his role. I extend the same to the Hon Prime Minister, Cabinet Ministers, and all respectable members. I pray blessings upon our people and my constituency for their support. Soifua and God Bless

**Tofa AUMUA ISAIA LAMEKO (Falealili West):** Mr Speaker and Members of Parliament. I want to site the legendary Ana's successful fishing expedition. It is a fitting metaphor to describe the completion of our general elections. We are gathered here today in good health and fine spirit through Gods compassion.

Mr Speaker I acknowledge His Highness Le Ao o le Malo of Samoa, Afioga Tui Atua Tupua Tamasese Efi and Good Lady, the Chief Justice and faletua, Hon Prime Minister and faletua, Cabinet ministers, Associate Ministers, all the esteem Members. I also extend my commendations to the leaders of all Christian denominations in Samoa. I appreciate the presence of the Heads of Government Ministries, Chief Executive Officers, and the whole of Samoa.

I must also acknowledge the Government of American Samoa and Manua, with their Governor and Lieutenant Governor and the honorific salutations pertaining to them. We must then exalt the glory to God Almighty for his love has brought us together today to deliberate matters concerning the country.

To my constituency of Falealii West from the village of Saga to Sapunaoa, I have the highest regard of the honorific salutations of Falealii West. I appreciate the support of my constituency in this year's election. I will keep within my heart the honor you have granted. I must applaud the respectable Members of Falealii from the previous term, Tusa Misi Tupuola and Tuiloma Pule Unasa Alaimoana Lameko, for initiating the goals for our Constituencies developments. Thank you, for a job well done.

I will now state my views on the Appropriations now before the House. After reading through the Appropriation for the year 2016/2017 I have noted that our revenue has jumped by 3.1% compare to the year 2015/2016. In saying that, I like to thank the Hon Minister of Revenue and the Ministry for their role in collecting this capital to develop our country.

Secondly, grants have increase by 76.5% compared to previous financial year. This does assist our people on seasonal work overseas. It also provides benefits for tourism industry and employment, it also boost our exports. Mr Speaker, the truth is, the government is still prioritizing the following, appropriations for the Ministry of Education, Sports and Culture has increased by 10.2%, Ministry of Health by 9.7%, Ministry of Finance 8.5%, and Ministry of Works, Transport and Infrastructure by 5.2%. Mr. Speaker I wish to put forth the proposals of my constituency.

To the Ministry of Education, Sports and Culture, we propose an improvement in children numeracy, and guidelines must be set with the provision of textbooks for children at primary and particularly those at college level. The capacity of teachers should be encourage and develop. On that note, I congratulate and commend the Hon Minister of Education, Sports and Culture, the CEO and staff of the Ministry as well as the Vice Chancellor and staff of the National University of Samoa.

To the Ministry of Health, the Hon Minister we reiterate our request for a specialist doctor to be at Poutasi Hospital once a week. To the Ministry of Works, Transport and Infrastructure we humbly request electricity and drinking water under our community service obligations for the inland settlements of the villages of Sapunaoa, Matautu, Malaemalu and Satalo.

I want to record my gratitude to the Hon Prime Minister and Cabinet for tar sealing of our access roads at the villages of Vaovai, Satalo and Sapunaoa. On the other hand several access roads are of tar seal. For instance in Saleilua access roads number 3 2 and 1. Poutasi, Matautu, Tafatafa, Malaemalu and the one at Piu and Sapunaoa. We wish to request the construction bridges for the rivers at Satalo and the one at the sub village of Piu in Sapuanoa.

To the Ministry of Natural Resources and Environemnt, I respectfully remind you of our proposed project of growing mangroves at Sapunaoa, Satalo, Malaemalu, Vaovai and Poutasi. The implementation of the seawalls for the villages of Iliili, Saleilua, Matautu, Malaemalu, and Sapunaoa neighboring the river of Salesatele. Thirdly, is the tarsealing of tsunami roads at Poutasi, Satalo, Faleulu in Sapunaoa. To the Samoa Tourism Authority I request the application of tar seal to the roads of the roadsleading to the tourist spots at Iliili in Saleilua, Poutasi, Tafatafa. There are 3 very good roads at the moment towards these tourist attractions and the new road at Malaemalu.

To the Ministry of Agriculture and Fisheries, we recommend the promoting of our marine conservation. Secondly, we request farming materials for the replanting of coconuts, koko and coffee using the stimulus package. Thirdly, boost the provision of relative materials for the growing of the Salani talo, Fusi talo and Tanumalala talo. This will assist farmers to achieve record production for exports and sufficient food supply for our people ensuring food security.

To the Ministry of Communication and Information Technology, with all due respect there is no mobile services coverage at the seaside settlements of Falealili west, from Iliili towards Sapunaoa. The only point where you will get good reception is at the main road when you go inland. We also request that the laying of the cable line for the internet be continued.

To the Ministry of Commerce, Industry and Labor we humbly request the promotion of equal opportunities with employment for degree holders from universities and non-degree holders. The Apprenticeship program should continue so as to encourage those without qualifications but have skills and experience in different trades eventually creating a successful business. Fourthly to seriously look at equal opportunities and reintroduce Government Exports Guarantee Schemes for entrepreneurs in farming, fisheries product manufacturing and garments to promote export at the same time improving their personal economic status.

We also urge the Public Service Commission to engage in dialogue with public servants in regards to the policies relating to benefits stipulated within the Labour International Act and particularly our Constitution.

I conclude with the Office of the Electoral Commission, we request for the division of Falealili West as there are currently 10 villages, Iliili, Saleilua, Poutasi, Vaovai, Matautu, Matavai, Tafatafa, Malaemalu, Satalo, and Sapunaoa for the upcoming election.

I wish to take this opportunity to render my apologies if I may have been out of line in any way. To the Hon Prime Minister, Cabinet, Associate Ministers and Members I wish you all the best of health in carrying out our duties. Soifua.

MR SPEAKER: Well said, this is what I call a complete speech detailing the demands of the constituency. It is not necessary for me to praise the member with his statement.

Tofa ILI SETEFANO TAATEO TAFILI (Aana Alofi No. 2): Mr Speaker thank you for the opportunity. You have already glorified our Lord for love and grace. Which has brought us all here today in good health?

To my beloved village of Nofoalii in all glorious salutation, thank you for your endeavors. With this victory, let the glory be to God. For our existence is meaningless without him. I am in awe with the trust you have granted this humble

person.

I also want to use this opportunity to pay my respect to Tofa Tolofuaivalelei Falemoe Leiataua who had contested this seat. I am grateful to God for things have returned to normal. Our differences and negativity is a thing of the past. I congratulate you on your services to our constituency whilst you held the seat. Whatever projects that need be done I ask for your support and I will say now that I will make it a point to see that it is complete. To my constituents, render me your support, for the magnificent of Rome was not built in one day or within a year.

Mr Speaker I will now proceed to voice the request of the needs to improve the

state of my constituency.

Hon Prime Minister and Cabinet Ministers, I would compare your administration to a lake in which all rivers and streams flow to, it is like a burning fire which members of this Parliament turn to for light. In terms of matters that concerns our people. I believe that the one who keeps knocking will eventually be attended to.

Mr Speaker and to the Minister concern here, I would like to bring to your attention the access road for Nofoalii. It has never been smooth or tar seal. This submission is not only for my villagers but there are government assets along this very road. Which are two water pumps and a water reserve tank which is property of the Water Authority? There are also power lines done by the Electric Power Corporation. I am sure once the road conditions are improved travelling will be more pleasant and convenient, and the transportation of materials for projects will be made easier.

My second submission to the Government and Cabinet, concerns the sub-village of Vaialua next to Fasitoouta. The seaside area is a real concern with the rising sea level. The safety of those living along here is in jeopardy. This is also the location of the traditional residence of His Highness the Head of State and Afioga Tuimalealiifano. Papaliitele, you are at the helm of this Ministry, please look into this matter.

My third request is drinking water for my constituency, particularly for those residing at inland settlements. With Leulumoega the distance to the main road is about half a mile. These folks are able to access water, but not the families living further inland close to the cross road from Aleisa. These people depend on rain water. Thank goodness for the CSSP project and the Red Cross which provided water tanks for some families?

I extend the same to O le Ao o le Malo, Members of the Council of Deputies, the Hon Prime Minister, Cabinet Ministers, and the Members of Parliament. MR SPEAKER: This is once again the opportunity for Members to take the floor while there is still ample time, it is best that both sides of chamber take turns.

I call upon the Member for Gagaifomauga No.3, and this is another new member taking the floor for her maiden speech. I wish you all the best.

### MAIDEN SPEECH

Afioga FAAULUSAU ROSA DUFFY-STOWERS (Gagaifomauga No.3): Thank you Mr Speaker. Morning refreshments provided has given us energy. I appreciate this golden opportunity allowed to the member for Gagaifomauga No.3.

I will firstly acknowledge Samoa in all that is sacred to this land and its traditions. I pay homage to His Highness O Le Ao o le Malo, Afioga Tui Atua Tupua Tamasese Efi and Good Lady, Members of the Council of Deputies and their good ladies. My acknowledgment also must extend to the Hon Prime Minister Susuga Tuilaepa Sailele Malielegaoi and faletua, Hon Deputy Speaker, and all Members of the House.

I must also duly acknowledge the clergy of all denominations. Such are the salutations pertaining to the royal families of Sa Tupua and Sa Malietoa, and the oratory group of Tumua and Pule.

It is only fitting that I must mention our brothers in Tutuila and Manu'a and all the prestige of salutations and honor which they hold.

Whilst you remain in your honored places, allow me to touch base with my beloved constituency. I duly acknowledge with reverence my village of Aopo in which my title Faaulusau hails from, and the dignitaries thereof pertaining to Aopo, Letui and Fagae'e.

Whatever demands there may be to enhance or maintain any developments in our constituency. I will say that I am a new member and I believe God will provide us with good health and we can always share ideas with cabinet about developments for my constituency.

I want to address two ministries and such was the case in the previous term where priority went to Health and Education. I believe this government has held this vision for quite some time. Which is application of similar teaching standards for children in Malifa and Aopo? My advice to the Minister is to encourage your staff to create strategic plans and guidelines to ensure that this concept is achieve. This must begin from pre-school level right through to college. My thoughts were, why not set up a National Exam at various levels right throughout the country from time to time and conduct a audit check like system to find out how well the curriculum is being taught in rural schools and the in town.

The outcome of a National Exam would make the ministry realize the capacity of teachers in the rural areas and Savai'i. I think the schools in Apia are fine but the concern is such that I want to ensure that the teaching of the curriculum in rural areas is spot on.

Hon Minister of Health, our district hospital at Safotu does not have the service of a doctor for many weeks. I am hopeful though since there is a proposal for a new health center which I am sure will be of great benefit. I thought I'll remind you of the need for a doctor for Safotu since this hospital caters for my constituency from Aopo right through to the constituency of my old man Faasootauloa at Saleaula. I guess that is all I have to say, and will conclude by conveying my commendations to the Minister of Finance and that I do support this budget. I am sure vision and commitment enabled its compilation. My prayers are that the Lords grace will see to its realization.

Mr Speaker, I pray the Lord may continue to bless you, Hon Prime Minister, Deputy Prime Minister, Cabinet Ministers, Associate Ministers, and all respectable Members. May the blessings of God also be upon our Samoan community listening in, to His Highness O Le Ao Mamalu o le Malo, Member of Council of Deputies. May the good grace of God be upon our proceedings.

### MAIDEN SPEECH

**Tofa LOPAOO NATANIELU MUA (Vaisigano No. 1):** Thank you Mr Speaker for the opportunity to convey the opinions of this constituency. I rise at this moment with the utmost respect and caution as this place is filled with dignity and honor. A slip of the tongue would be disastrous.

I will begin by acknowledging his Highness Le Ao o le Malo, Afioga Tui Atua Tupua Tamasese Efi and good lady, Members of the Council of Deputies, Afioga Tuimalealiifano Vaaletoa Sualauvi II, Afioga Tuiloma Pule Lameko, Afioga Le Mamea Ropati and their good ladies. I acknowledge the Hon Prime Minister, Afioga Tuilapea Sailele Malielegaoi, Hon Deputy Prime Minister Afioga Fiame Naomi Mataafa, Members of the Cabinet Ministers, and Associate Ministers.

I acknowledge also the Speaker of the House, Deputy Speaker, and all respectable Members of Samoa. I greet also the Chief Justice and the Judiciary, and Head of Government Ministries and the government private sectors.

I like to acknowledge also the Clerk of the Legislative Afioga Fepuleai, and staff, especially the anointed servants of God throughout Samoa. For their never ending spiritual support On the same token I sincerely recognize the role of the wider clergy group throughout the world.

My final acknowledgment is my constituency of course; I humbly pay my respects the people of Vaisigano No. and all the honorary salutations pertaining to them. I ask you to give me your support whilst here to deliberate on matters for the common good.

Mr Speaker I like to extend my appreciation to the Minister of Finance for his well-prepared statement on the Appropriation tabled before the House. Firstly, I wish to convey matters pertaining to the needs of my constituency.

Starting with the Hon Minister of Education, Sports and Culture pertaining to...There are times when I reflect upon an English phrase "out of sight out of mind", due to our distant location the government seems to have forgotten us. However since becoming a member, things are looking up. I am glad for that.

At Asau College 80% of its teachers are diploma graduates, and only 20% with bachelor's degrees which is only four teachers. That is not happening here in Upolu. My question then, how these students will become smart if this is the case. How many engineers do we have? How many lawyers? How many auditors from our constituency? We cannot achieve this with the standard of teachers employed at Asau.

Our children will never achieve higher standards with the way things are. As I said earlier, it seems we are neglected because of our distant location.

Mr Speaker if such formation is introduced to colleges, perhaps more quality teachers can be contracted to rural areas and avoid having to attend NUS at a tune of \$15,000 tuition fees. There could be an avenue to hire quality teachers which will boost the number of students aspiring to become teachers. Currently students entering teachers training college are at 10 to 20 marks. The foundation level is 15 marks or so, which means students below are enrolled to become teachers. I certainly do not mean to speak negative of these particular students. After all some has progressed to universities to continue their studies. The point that I am making is to improve the standards of teaching at college level within rural areas. The answer to our financial problems is educating our children for their future. If we do not sort this out we will have problems. I don't know about other constituencies but mine? Well.

To the Ministry of Health thank you Hon Minister for the report. I would like to raise a few things such as the shortage of medicine which has happened to us and the absence of a doctor. Gone are the days of Salausa. When he graduated he went and lived at Sataua. He experienced being bitten by mosquitoes. And was asked by other medical centers to relocate but stayed on.

The treatment and care for patients was very good. The thing is now; they no longer want to stay in Savai'i. I suggest the construction of good standard residential homes for doctors to live, it would be attractive. There are already bible schools within this vicinity. There are also public schools which needs maintenance work done to it.

In the Samoan version of the Parliamentary Papers 2016/2017 No.2 on page 326 there are figures which are of concern to me. The total number of prescription proposed for the year is 356,400 but the number reached was 397,980 with the estimated number of 377,190. Hon Minister I mentioned this only because the shortage of medicine will happen again just like it did last year. My constituency was really affected by this. I have requested the Hon Minister and Ministry for a supply of medicine. The predictable number of prescription proposed exceeded the proposed number and yet it is the same thing again, I have a feeling it will happen again.

With this in mind Upolu is very fortunate because there is more than one pharmacy around, unlike Savaii the only medicine outlet is at the Hospital. I pledge to the Hon Minister to consider the submissions I've made. There are some other things I would like to touch on but considering the time I would ask those in authority to look at these.

To the Hon Minister of Works, Transport and Infrastructure I ask for your consideration of the wharf at Asau, this asset has been ignore for a long time. Quite a few business people approached us about using the wharf to anchor their fishing boats but the problem is there is no water supply. Mr Speaker there is a way to obtain water, but the means to achieve this is inadequate. Beneath the land area of Asau is spring water all over and there is a reason for this. Mr Speaker I ask for your consideration in finding the source of spring water at our village and constituency.

Our access roads need upgrading, it is a fact that this part of the country has a lot of koko and the demand for this at the moment is fairly high. Therefore, we ask that a road way be cleared right up to the hills. It does not need to be tar seal; we are quite prepared to do the rest. We would ask for a road roller and motor grader machines be brought in every 6 months to maintain it. If we do not keep to our end of the bargain, you can stop bringing in the machines. It does not need to be tar seal as it is expensive.

To the Ministry of Agriculture and Fisheries, there are many projects completed under the SACEP, and cocoa is really in demand by our constituents. As you are aware Wildercom is buying cocoa under their partnership with Tofa Saleimoa Vaai and Afioga Aloalii. We have the biggest cocoa plantations, but the feedback from my villagers is that support from the Ministry is inadequate. Some of my people requested cocoa in March last year, it is now June and they are still waiting. In other words if the Ministry would drop everything else for Asau and concentrate on supplying us with cocoa and taro, it would be the solution to the Minister of Finance many problems.

The Ministry of Agriculture has contributed greatly to the economy and so as the farmers. I feel that the problem is the insufficient number of employees. If it has been a year since farmers waited for cocoa to be supplied then I guess their role is not up to standard. I have to say this or we will get nothing.

Looking at the Appropriation from the Minister of Finance we are \$78million in deficit. Whereas \$98 million was borrowed to meet our demands as stated in the budget. Now if the Ministry was receptive to the needs of farmers, this sector would be line to assist with the Minister of Finance.

I like to take this opportunity to congratulate the management of Women in Business, I am aware of the wide range of service provided such as exporting virgin oil and cocoa, and I know if we ask them to acquire coffee next month they would. Mr Speaker and Members, I am not aware of any assistance provided to this kind of organization. I feel that \$2million from the Ministry of Agriculture and Fisheries should be given to this organization perhaps their operations would be a better option in the cultivation of our land, for we have been told the Chinese will teach us to cultivate our land. However, we know how to work our land and the people of Asau are experienced at growing cocoa, but we need the collaboration of the Ministry. The other option is to provide financial assistance to individuals like the matais I mentioned. I still recall hearing Vaai back in the days saying that money can be found under cocoa, bananas, and coconut trees. Indeed his saying is true, and with the support of the Ministry we can realize the Appropriation target of \$98million needed. The \$74million noted is our expenditure over revenue. Which is the reason why we borrowed \$98million? My question to the Hon Minister of Finance is where this soft loan comes from, since it is not indicated in the Appropriation s. I guess then there are other means.

Moving on to the Office of the Electoral Commission, what I will now say is the conviction of my constituency; we are the only Pule district within Salafai without a representative, Asau. It has been very annoying to hear afioga Aloali'I stating the removal of the Asau representative form our constituency. My suggestion is and subject to your discretion of course is to have 1 representative for Asau and another for the villages of Vaisala and Auala. I am coming to the end of my speech, and may I raise the township of Asau. Mr Speaker, I want to share with the government that if we do not have the capital, why not privatize the port at Asau and bring someone to use the wharf before it rots away. There has not been a steam boat there for a long time. There is a company interested in operating our wharf, but we cannot decide on the matter for the government holds the key. We are not asking to allow our village to administer this venture. The Hon Prime Minister understands as everything comes through him. I would think that there are other companies that have proposed the same. Another company that approached us man's 30 people. I am sure you are aware of this, would be kind to consider this for the economy of my constituency. It is the reason why I'm passionate about the development of agriculture and the respective ministry. The objective is to improve the level of prosperity in our district.

To the Hon Minister of Works, Transport and Infrastructure the access roads at Vaisala, Auala and Asau are terrible. They need not be tar seal but apply only the base course so the nice cars of my people can reach inland.

This would also facilitate the numerous developments going on at our constituency. I have a lot more ideas to share but 5 years is a lengthy period. At this stage those are some of our requests for your consideration. Mr Deputy Prime Minister please look at a seawall for one of the villages at my constituency. To the Ministry of Revenue and Tourism some of us are a bit concern and have voiced the suggestion to separate the marketing of Savai'i and Upolu. I mentioned this in our dialogue before; "we can't see the tress through the forest" If this could be entertaining perhaps a lot of people will want to come to Savai'i.

Mr Speaker in conclusion may the grace of God be upon our proceedings, may his love be upon the Hon Prime Minister, Leader of the House, Hon Deputy Prime Minister, Cabinet Ministers, Associate Ministers, and this side of the house. Blessings be on His Highness O le Ao Mamalu o le Malo Afioga Tui Atua Tupua Tamasese Efi and his good lady.

I extend these well wishes to the Members of the Council of Deputies, the Chief Justice and Judiciary, the anointed servants of God, all of Samoa, and my constituency of Vaisigano No. 1 from Asau to Vaisala tuning in may you receive blessings for your fervent support. Thank you.

Members showed their appreciation by applauding the Member of Vaisigano No.1 for his Maiden Speech.

MR SPEAKER: I thank the Member for his speech, I now call upon...

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Aiono Neioti Galumalemana Dr. Sailele Malielegaoi: Mr Speaker since we are bound by our Parliamentary procedures, we cannot interrupt a members maiden speech. I want to notify members on the subject of matters raised concerning Ministries. In due course Ministers will elaborate on government actions which members do not fully understand. The member has raised borrowing that is not contained in the statement.

I want to refer the dignitaries of this House to our thick document on the Budget which concisely accounts on the pages marked in roman numerals, XI, XII, XIII, XIV, XV, XVI accounts for all the developments funded from overseas. It is not just soft loans for our projects, but also grants and the numerous appropriations for Ministries are all mentioned here in detail. It is the reason why our sitting was delayed, to allow members especially the new member's ample time to read through this document. Since we began borrowing right up to now, we are still paying them off. Such is contained on the pages XXI to XXVII.

The reason we do this is because we are guided by the laws of good governance, transparency and accountability. So as to clarify every move by the government, since this kind of publicity spreads to the public and allegations towards the government come up every now and then. What is said outside parliament does not mention some of the clarifications presented here. Members must bear in mind that for one thing is the statement by the Minister of Finance on the budget. The other is this thick document which can be compared to the size of the bible which members have been allowed ample time to read through it. Mr Speaker, that is my contribution before other members take the floor.

MR SPEAKER: Thank you the clarification from the Government on the budget is understandable. To save time, do not address this matter again. The floor is now open for any member to speak.

I call upon the Member for Siumu. This is the members first term so all the best with your maiden speech.

### MAIDEN SPEECH

Afioga FAALOGO IOSEFA SOPI (Siumu): Thank you Mr Speaker for this golden opportunity. I will now proceed to voice the wishes of my constituency.

I will begin by greeting His Highness O Le Ao o le Malo and your good lady, Members of the Council of Deputies, the Hon Prime Minister, Cabinet Ministers, Chief Justice and the Judiciary, Speaker of the House and Members of Parliament.

I extend these greetings to the Servants of God within all the denominations in Samoa listening in. I also acknowledge the Heads of Government Ministries, the private sectors and Organizations.

I recognize also the support of my constituency in all its honorific salutations. I appreciate your support and encouragement, may you continue to put your trust in me in the next 5 years as I strive to do my best.

I extend my appreciation to the Government leaders for the work done in the past 5 years. Thank you for your patience and hard work.

Mr Speaker I will now address the Cabinet Ministers. Let me begin with the Hon Minister of Finance by saying that I fully support the Appropriation tabled before the House.

If only we have adequate funds I probably would not have made this speech. I am reminded of the saying that goes, "if you know what you are supposed to do, but yet you do not do it that becomes a sin". In saying that I will go ahead and state the needs and concerns of my constituency.

Hon Minister of Works, Transport and Infrastructure, Siumu has sent you a letter regarding our public roads. It has been two years since no maintenance had been carried out. Another aspect is access roads; only one access road was completed in the last 5 years. I had asked for a concrete road near the school, due to extreme damages to school properties caused by the water during flooding. The cross island road must be upgraded it would be nice if this could be done within the next five years. This road is convenient for school children and tourist. My other request is street lights, for we only have about four at our area.

Hon Minister of Health its really great to hear that our people will no longer be sent overseas for medical attention. It saves us money and we do now have the expertise in our own doctors.

Hon Minister of Agriculture and Fisheries, I request a ramp since after seawalls were done people can't take up their fishing boats to shore. This constituency is serving the public through fishing. I want to draw your attention to the fact that a lot of my people are growing crops around their homes, instead of using the land in the forest area. Could it be the state of access roads which is putting them off from cultivating their land.

Hon Minister of Education, Sports and Culture you played for Manu Samoa, would you look into the state of our team for it seems we are falling behind a bit. We can't compete with Fiji like we use to. We should all be behind our team against Tonga this Saturday. Would you consider the sports field of our school at Palalaua, it just needs to be level. I think that is the entire request I wanted to voice, perhaps as we go along, I will submit more.

Mr Speaker may the good grace of God be upon our proceedings, and if I may have offended anyone, my apologies, my prayers for the country and our proceedings, thank you.

Members showed their appreciation by applauding the Member of Siumu for his Maiden Speech.

MR SPEAKER: Well said, I admire your consideration of our role, and the manner of a senior gentleman in which you delivered your statement, the representative of the fourth house of Atua.

This would be the time our senior people are tuning in rendering their support. I call on the Member of Safata East to deliver his maiden speech. He is also the former CEO of the Accident Compensation Board. All the best.

### MAIDEN SPEECH

Tofa NONU LOSE NIUMATA (Safata East): Mr Speaker and Members this is my maiden speech. I will firstly record my acknowledgement of our people and my constituency. I recognize with respect His Highness O Le Ao o le Malo, the Council of Deputies, the Hon Prime Minister and all Members of Parliament.

With all sincerity I want to congratulate my running mates that were in the race for Safata East. As the saying goes, "the sun will rise again and the Lord provides opportunities.

Mr Speaker, allow me to extend my commendations on the budget. The main objective of the Bill is to strengthen the foundations in preparation for tomorrow. This means, the projects currently under way and the ongoing ones are indicated in the accounts of revenue, expenditures and borrowing, projects to be prioritize and the percentage of wealth. MR SPEAKER: I announce that Proceedings of the Legislative Assembly resumed. We went to recess while the Member of Aleipata Itupa i Luga was speaking. I call on the Member to continue with his speech.

Afioga AMITUANAI FAGAIVALU KENRICK SAMU: Thank you Mr Speaker. I believe we have regained energy from the refreshments prepared, on that note I extend my appreciation to the Speaker of the House and the Clerk of the Legislative Assembly.

Mr Speaker there is a proverb originated from the sea, which goes "Not all boats take the victory", I extend my appreciation to all my brothers who contested this past election. We have run alongside each other, as the nation makes its decision. The constituency has agreed and has chosen this individual. Grant me your compassion for friendship. To be honest, it is best to have a compassionate friendship without this post, than being friends because of the post and yet there is no compassion. I want to especially thank my families in Samoa and abroad for their support, and prayer during the campaign. Moreover, my gratitude to my committees in Ulutogia, Vailoa and my beloved village of Lalomanu for your support and sacrifice during our preparations. I am not a man of riches and can never repay your time and effort. God will grant you blessings for your sacrifice. With that I am grateful, thank you so very much.

On the morning of Election Day, as I was at Vaigaga to cast my vote, the Member called out to me from inside his vehicle in a teasing manner. May I remind you that this very member did not cast his vote but reported on the guys that were intending to run. Just saying...

MR SPEAKER: I call on the member, do not react to it.

AfiogaAMITUANAI FAGAIVALU KENRICK SAMU: To my constituency, your blessings will bring in a lot of fish in the fisherman's net. In other words, your blessings will bring me success. It will enable me to deliver constructive ideas. I will endeavor to do well as you have bestowed me this honor in which I will relish being your representative. May I be filled with wisdom so as to please you? Above all may the grace of God be with me during this Parliamentary term.

Mr Speaker I take this opportunity to congratulate the Hon Prime Minister and company in your journey in the previous five years. I understand that some have not made it back, but their contribution to the development of Samoa is great. I know this term will bring problems but let us leave things to God for he will guide us in the developing of our country.

Mr Speaker this constituency with delight supports the Appropriations. I believe it is the Appropriations for the ongoing projects from the previous 5 years to the 5 year term now started. I will start with the Hon Minister of Works, Transport and Infrastructure, I suppose I will have to harp the same tune I did during the previous term.

We have had the same water issues since the Tsunami of 2009. I think the Government have laid out plans to relocate people onto higher grounds. Is it not appropriate to lay water pipes along the new road from Samusu to Lalomanu. Since 2009 most of my constituency have relocated inland and are relying on the water truck which does not turn up at most times. Secondly, are our access roads at Ulutogia, Vailoa and Lalomanu. Five years has gone yet nothing. I urge you sir for your consideration for these access roads. The road in Tiavea also needs attention since several accidents have occurred on this road in the past years. Could the Hon Minister look into the time frame and how it can be done. A lot of tourists use this road and their lives are at risk when travelling along here due to the poor road condition.

My third request is for a seawall at the sub-village of Lata in Lalomanu. The tsunami of 2009 destroyed the newly built seawall back then.

With electricity I was glad to hear you state at one time that electricity cost will drop. Will you consider this notion as wind power; a government project is located at our constituency.

I will now come to the Hon Minister of Natural Resources and Environment, the Hon Deputy Minister would you spare a thought for the seawall towards Tapaga at Lalomanu. This is an unfinished project, please consider completing it as a lot of our community reside along here.

My second request to the Deputy Prime Minister is consideration for a rubbish dump location in this region of Atua to save trucks from travelling all this way to collect rubbish. It would also be an advantage to the tourism businesses around d there.

I extend my appreciation and job well done to the Hon Minister of Education, Sports and Culture. The issue we are facing is the limited number of teachers, could you boost the number of teachers at our area. Another aspect is the prevailing number of fights between students in town. I suggest promoting the policy to have students attend schools at their respective area of residence. I ask myself, why is it that this does not happen in Savai'i. There are now colleges in every district, so students should attend their respective college.

To the Hon Minister of Agriculture and Fisheries, my commendations to you, I do however would like to know what the story with our cattle is. A number of my constituency has been waiting for some time for a response regarding their applications for cattle.

Secondly, I appreciate the state our taro production is at, but I wonder if this is not the opportune time to reintroduce the talo Niue. Let us see if the blight is really gone and we can plant this type again.

Now to the Hon Minister of Electoral Commission, I extend my thanks in regards to this past election to the Hon Minister as well as the Ministry and staff. I have noticed a great improvement in the service during the previous election. My submission on elections is this, people should vote at where they reside. I have notice on our roll the names of people who do not live at where we are. In order to move forward I propose the compulsory obligation of voters to register at where they reside. Other than that I applaud your office for your service to the country, for we have notice a huge improvement in the conducting of elections.

My final submission is towards the Hon Minister of Police, Fire and Emergency Services. I appreciate your decision to appoint me yet again to be your Associate Minister. In the same token it is having regards to my constituency. Thank you for the allocation of a police outpost at Lalomanu, I know that in the previous term I had been perhaps annoying with my constant asking for this to be done and you have finally done so.

To our Ministry of Police, my commendations to the Police High Commissioner, and staff for a job well done in regards to your service to our people. My advice is to serve with integrity and you will observe success in your service.

Mr Speaker, I will now conclude, but before doing so I wish to congratulate you on your role as Speaker.

### MAIDEN SPEECH

Afioga FAUMUINA ASI PAULI WAYNE FONG (Urban West): Thank you Mr Speaker for today. I am grateful to our Father in Heaven for this opportunity to gather once again this afternoon to continue our work. Thank you for the refreshments prepared to rejuvenate our strength to continue our work. I am grateful for the opportunity given to this constituency to voice our contribution to our proceedings today.

Before I do so I must convey my acknowledgement to the constituency. I also understand today will be the day that all maiden speeches are to be said.

Mr Speaker, I convey greetings to the Hon Prime Minister and Cabinet Ministers, and members of this Samoan Parliament. I acknowledge also His Highness O Le Ao o le Malo, and the three Council of Deputies. I recognize also the Chief Justice and Judiciary. I recognize also all the Clergy who are constantly praying for a prosperous Samoa in all honorary salutation.

I acknowledge also the Government of Tutuila and Manua in all honorary salutation.

I recognize also my constituency of Urban West. I suppose the constituency of Urban West now represents all of Samoa due to its diversity. Nevertheless the honors of Faleata shall remain. With respect I acknowledge the salutations pertaining to Faleata.

I want to acknowledge my beloved village of Vaigaga, my family at Laloaoa where the Sooalo title hails from. I must also mention my village of Lefaga and the salutations that hold them in esteem. I acknowledge also my family in Matanofo, Falelatai, where Afioga Tuimalealiifano resides.

I cannot forget to omit to mention the many business owners and the Chinese people who live there among us at Urban West. I will now attempt to voice an opinion to the Appropriations on your behalf.

First of all I wish to acknowledge the Hon Minister of Finance for his clear defined work, it is a bit disappointing that there is not enough money to meet the required needs requested by each constituency, but I firmly believe you are a wise. I comprehend also that we are at the beginning of this new term, with most of us requesting needs, nonetheless the funds are limited. Anyhow thank you for the work well done.

Hon Minister of Works, Transport and Infrastructure, I firmly believe you have been chosen because this is our new constituency Urban West, and you are a man of compassion, honesty and courage.

Despite limited funds allocated to you, I know that you have the experience. You were selected because this constituency Urban West is crucial to the Hon Prime Minister. I ask for your consideration into Urban West and the plans in the pipeline for our constituency.

For your information, I will start with Moamoa, which the Hon Minister served for many years. Where people were relocated from Apia to Moamoa and there were no roads and water supply. But I think the law stipulates that roads and water supply should be done first. Hon Minister I humbly ask for your consideration, I know there are funds available, would you kindly consider this situation as there is also the Catholic Church school for lay preachers. We have notice that during heavy rainfall the river overflows its banks and with the old bridge people can't get across and so they stay back at Moamoa.

I had thought with the Supplementary Appropriation and the company responsible for the construction of the road in Faleata, starting from Malifa to Saina, which is great and I thank the Government. We are near the end of the year but the project is incomplete due to the fact that some villages and families assets were affected and there is no money left. My request is that additional capital is provided for the completion of this project which covers my village of Vaigaga where the gate is incomplete.

Now I come to the Hon Minister of Education, your Afioga Toetaufanua the brave one. Your appointment as Minister is perhaps the most appropriate. Would you kindly look into the grants for primary schools currently withheld, much to the school committee's dismay as they do not know where to turn to in funding school projects? They are trying when it comes to fundraising for school buildings. Sir, please consider the situation with these grants if changes could be adopted to meet the school committee requirements, as their hands are tie. I acknowledge the presence of a long serving member from Faleata West, but allow me to voice this matter. There is a parcel of land at Vaitele which has not been use for about 20 years. I suggest a school building to be erected here as smart children is better than grass growing there which nothing comes out of. I urge you Minister to consider this, if your budget can meet this why not the new year and by the end of this term it will be complete and it could be name after yourself.

To the Hon Minister of Health, you sir hold the key to Samoa's survival, at the same time our demise. This is your second consecutive term and so I would think that you are fully aware of the problems faced by your ministry I want to bring up the funds put aside for overseas treatment. Why not consider insurance for employees to allow individuals to prepare for themselves before sickness afflicts them.

If people can pay a small amount whilst the government contributes a bit employees will have coverage and not be hindered to seek medical attention in such cases. Moreover such insurance cover will facilitate cases of those to be sent overseas.

To the Hon. Minister of the Ministry of Women, Community and Social Development, you're salutation is "pae ma auli" meaning you are responsible for putting things in perspective and aligning them accordingly. There are so many problems from village communities stemming from the objectives they pursue. I believe things are looking up since your appointment as the first lady to hold this post. In saying that, I am really excited with your role.

Hon Minister of Police, I know you don't rest but your staff do. This constituency have been stress out with numerous prisoners breaking out. I am really grateful with governments plan to relocate the prison to Tanumalala, it will relieve us of the stress from prisoners escaping. I also support the notion to employ 200 officers to man 200 prisoners to alleviate stress from the general public.

I want to thank the Police Commissioner and staff for a job well done in curbing the drug problem making the public safe from it and also those who have possession of unlawful weapons. Thank you for the job well done. I humbly ask the Hon Minister of Samoa Tourism Authority to assist in this as you have experience.

To my colleague the Hon Minister of Agriculture and Fisheries, we really do not have a lot to ask for as we do not have land to work on. But if there may be minor programs where we could hold competing projects in people's backyards that would be nice. It's great to see you appointed again.

To my other colleagues in Cabinet, I applaud you for your complete effort. You are yet to have faults as you have just begun your tenure ship. I guess as we go along that will eventually happen. I thank you for today.

Thank you Hon Prime Minister for your courage in the appointments you have made, it has given us the same courage to be here on this side of chambers. I want to commend those people who ran this race with me I shall not forget you. Your support has given me the opportunity to be a part of this Parliament of Samoa.

Those are my thoughts, may the Speaker of the House be blessed physically and mentally in the conducting of procedings. I also commend all members for being here. May the Lord bless us in our work to be done. Thank you.

MR SPEAKER: Well done, I acknowledge your preparation. This is another opportunity for another Member who wishes to speak. Thank you once again to the Member of the Urban West.

Thank you, I call on the Member for Salega West. All the best with your maiden speech.

### MAIDEN SPEECH

Afioga TOOMATA AKI TUIPEA (Salega West): Thank you Mr Speaker for the opportunity granted to this constituency to voice our opinions on the Budget Report and Appropriations 2016/2017 tabled before the House. Before I convey my thoughts on the Appropriation, I acknowledge in respect all attending today. I greet His Highness O Le Ao o le Malo o Samoa Afioga Tui Atua Tupua Tamasese Efi and good lady, the Members of the Council of Deputies Afioga Tuiaaana Tuimalealiifano Vaaletoa, and good lady, Afioga Tuiloma Pule Lameko and his good lady, and also Afioga Le Mamea Tuiletufuga Ropati and his good lady as well as Hon Prime Minister and Cabinet.

I recognize the Chief Justice and Judiciary, all respectable Members of the Parliament, Head of Government Ministries, Government Organizations, and Head of private sectors working in partnership to develop the Government of Samoa.

I extend greetings also to the representatives of foreign countries in partnership with us through financial assistance to develop Samoa. I cannot omit to mention the support of our people throughout the Islands of Samoa, Manono, Apolima, Salafai and Upolu in all its honorific salutations. I must not forget to mention our brothers in the Islands Tutuila and Manua, with their Governor, Liuetenant Governor, and Representative of the two House, in all it's honorary salutation.

I must greet my constituency for they are the reason why I am now here in this House of Parliament, Salega West from Fagafau, Samataitai, Samataiuta, Fogatuli and Faiaai in all your honorary salutation.

I recognize also my cherished village of Samataitai and Samataiuta in all honorary salutation. Thank you for your support and respect, in allowing me a servant of little importance to be your mouthpiece in the Parliament of Samoa. I ask for your full support whilst I attempt to convey an opinion on the Appropriations table before the House.

I do not have much to say on the Budget Report for we have a Committee Chairperson, who will further elaborate on the report. But I will congratulate the Hon Minister of Finance, thank you for your courage; I also thank the Chief Executive Officer of the Ministry and everyone who played a part in preparing the Budget. It is not easy as we have very limited revenue in Samoa. We desire so much and then we ask ourselves where we will get the means to meet our demands.

We do not have the economic base in Samoa unlike other countries who have vast sources of wealth. We on the other hand have to resort to appealing overseas for loans to fulfill our needs.

Hon Minister of Finance, you are very experienced at your field and you are familiar in the international arena of finance. You have the experience to sort capital sources to finance our developments. Despite the limited capital available to you, I encourage you to apply your expertise to seek avenues to acquire funds for our country. Once that happens 50% should be allocated for Upolu and the other 50% to develop our island of Savai'i. We do not have a lot of demands although there are serious submissions which I will state.

Firstly Hon Minister of Works, Transport and Infrastructure, I trust the request of this constituency in regards to access roads from Fagafau, Samataitai, Samataiuta, Fogatuli and Faiaai has reached you. I received word you have visited the area. Could you inform me when you do go as I would like to come along to show the affected areas of our community? There is assistance available from the government but the trouble is our community is unable to upkeep and maintains it. There is the objective of HRPP that what is good and beautiful for Upolu is also good for Savai'i. Why not tars seal our roads? Coconuts, taro, cocoa and other crops grow well here. Our community is eager to work, but times have change. This new generation desire to be transported to the plantation. There are cars but only 4 wheel drives can reach the ridge inland. The road needs improvement and to be tar seal to allow all sorts of vehicles to get there.

Another request please to the Minister of Health, I suppose other Members have mentioned the hospitals poor condition. The first problem with our sub-center is medicine shortage at most times and the unavailability of a doctor. I hear that a doctor and his spouse from overseas are there now, but I would think it will not be for long. It is crucial that the ministry try to entice doctors to serve permanently in Savai'i. There are good schools for their children to attend and a good salary package should convince them to stay there permanently.

The majority of the community at my constituency will find at Foalalo ther are no medicine, they would then catch the bus to Tuasivi which is far. By the time they get there the patient is dead. I want to remind you of the strip of road between Taga and Gataivai was known back in the day as poverty road. As long as people keep dying due to the fact Tuasivi is quite a distant to travel, it should then be called death road.

I appeal to you with respect to seriously consider this issue. The wellbeing of my community and the people of Savaii is of importance.

Hon Prime Minister there are times when our community is counted under aids being distributed, but the thing is they have to fill out paper work and apply. Why not distribute these donations to everyone so that all communities are covered.

Hon Prime Minister on behalf of my constituency I congratulate you and Cabinet for your leadership until now. A lot of changes are now visible not only to us here but people from abroad. When we ask tourist if they like Savai'i, their response is, they prefer Salafai than Upolu.

On that note I ask the government to seriously consider the development of the tourism industry in Savai'i. Hon Prime Minister I do not need to praise you but a lot of changes has taken place in our country during your time in office. May you have courage and good health with the strength from God and also to the Hon Deputy Prime Minister, Cabinet in leading Samoa for this next 5 years.

This I say, may the Speaker be blessed, and all respectable Members of Parliament, soifua.

Members showed their appreciation by applauding the Member of Salega West for his Maiden Speech.

MR SPEAKER: Very well, I thank the Member. This opportunity is open to another Member who wishes to speak. That is how our work proceeds with 11 Members who are done with their speech and with the Cabinet to respond to matters raised and to the Minister of Finance to start working on requests put forth. It is why the chair is eager to move our work along.

I call on the Member, who is from one of the strongest family. I call on the Member for Safata West.

### MAIDEN SPEECH

Afioga LEAANA RONNIE POSINI (Safata West): Mr Speaker, firstly I acknowledge and extend my appreciation for this opportunity.

I acknowledge the support of O Le Ao o le Malo o Samoa, Afioga Tui Atua Tupua Tamasese and good lady, Council of Deputies, Tuimalealiifano Vaaletoa Sualauvi II and good lady, Tofa Tuiloma Lameko and good lady, Afioga Le Mamea Ropati and good lady. I recognize also the Hon Prime Minister Susuga Tuilaepa Fatialofa Auelua Lupesoliai Lolofietele Neioti Aiono Galumalemana Dr. Sailele Malielegaoi. "O oe o le siapo na lautele i Atua". Meaning your geneaology in Atua is far and wide. I greet also the Hon Deputy Prime Minister Afioga Fiame Naomi Mataafa, Cabinet Ministers, Chief Justice Afioga Patu Tiavaasue Falefatu Sapolu and the Judiciary.

When Faleata accepts the ava it pours a libation behind for their god, in the same token I recognise our brothers in Tutuila and Manua. With their Governor and his government and the ceremonial addresses pertaining to them. To my admired constituency of Safata West. Despite us being divided into Safata East and Safata West, our status and dignity remains.

I would like to make special mention of my constituency of Safata West from Vaiee, Niusuatia, Lotofaga, Sataoa, and Saanapu in all your paramount ceremonial honors and protocol.

I duly acknowledge the clergy and faletua for their faith in prayers which is the fountain to the prosperity of our constituency. This modest individual shall be your mouthpiece carrying the dignity which we are all proud of, into political affairs.

Mr Speaker and Members, I want to make note of our appreciation to the Hon Minister of Finance for the Appropriation tabled before the House. I applaud the Ministry of Finance and staff in the preparation of the Budget Report. Allow me now to convey my conviction on behalf of the people I represent on matters that need be improved at my community.

To the Hon Minister of Education, Sports and Culture I congratulate you on the developments of our school system, which you have prioritized. As long as our children do well the country will benefit. The school roll at my constituency is going on to 500 students with just 10 teachers. Compared to other schools with the same amount of students to about 40 teachers. I believe if teachers are accurately allocated around it will minimize the trend of students having to attend schools around town. My plea to the Minister is to kindly consider more teachers for our school.

The primary schools at Vaiee, Nuusuatia, Lotofaga, Sataoa, and Saanapu all have 6 teachers at each school. Currently 1 teacher is responsible for 2 classes. I appreciate the new school building but we need teachers for I believe that as long as there are enough teachers the our children will come right.

Hon Minister of Works, Transport and Infrastructure I commend you for the major developments seen, and the several demands from my constituency. I want to point out the road at Sataoa which leads to the seaside and heading inland. This is in a very poor condition particularly the way inland. If you visti the area cars can barely make it through this road, yet this leads to the majority of this community living around these parts.

This is the same situation with the access road at my village of Vaiee, it really needs upgrading. It is important for our people having farms and crops there for their livelihood.

Mr Speaker, with the road leading towards Sataoa there is a bridge crossing the river there. Due to climate change the water over flows its banks and flows right through to the village settlement. We will leave it to you minister but the bridge needs to be replace for a lot of families have been affected.

Hon Minister of Works, Transport and Infrastructure in regards to the road to Saanaputai where a movie is currently being shot. This is the third movie being done along here. One of the problems encountered by the overseas company is the terrible condition of the road which they do assist in maintaining it. It is vital that the road is maintained in good order for my community and tourist.

My village of Vaiee badly need street lights for it is very dark at night. It will also be beneficial for our college nearby to ensure the security of its properties and buildings.

Hon Minister of Health, I am delighted with the way things are going regarding the sub-center at Saanapu. It is like the hospital in town with a lot of people there. I believe this sub-center will be very busy with the Lefaga and Safata communities when it is complete. I trust you will look into its completion.

Hon Deputy Prime Minister, the Minister of Natural Resources and Environment, I understand there is a seawall in Sataoa, but it does not cover the whole village. This is amongst the largest village in my constituency. It is desirable that it is complete for a great part of the shore is without a seawall. This is a similar situation at Saanapu with its seawall not yet finish.

Mr Speaker such are my thoughts on our general services for the wellbeing of the public. Hon Minister of Education, education particularly primary level is very important. I have notice at our constituency children coming home from primary schools with their school reports being prepared by the teachers themselves. My suggestion is that the ministry prepares the same school reports for all primary schools. If you look at subjects like English and Mathematics students are given a straight mark. We are now in a time where these subjects are categorized and so marks should be given on that basis. For instance the reports shall specifically indicate the areas in which the child is at. The other striking thing I have notice is year 1, 2 and 3 has one teacher tutoring seven subjects. There are no class periods because there is only one teacher he or she does what she pleases. Once teachers are allocated to teach a single subject, be it English or Mathematics they would have better time management to teach. Perhaps this is why some students will excel in a single subject like Samoan and do really bad at other subjects. As long as primary level is well establish they would be well equip when they attend college. I know, as I worked at NUS and a year 13 came with very low standards. At one time there were criticisms aimed at the administration but the problem originated at primary level.

Mr Speaker the other subject matter I want to address is the rights of a child. Who knows, this could be the factor that is causing the poor performance at school. About 30 years ago the level of respect from children was above standards. But with rights now being exercise there is a lot of changes in behavior at schools especially university. Therefore it should be taken away if it unsuitable. Let us make our children of importance but as far as rights are concern, well we have seen a lot of fights going on at school.

Hon Minister I will now speak on the University of Samoa. I like the merging of the university and polytechnic which has been 10 years now. Is it not appropriate to set up a committee to look into its operation whether changes is necessary, my motives here is for the students to do well. With this in mind the program should be measured to the Australia apprenticeship program called APTC. The APTC program is a well-known Apprenticeship program in Australia and New Zealand, and they are located here in Samoa.

That is why we see the apprenticeship program in Samoa, because it is separate from the University. The partnership is necessary, and I am grateful for the partnership we have with them for 10 years now. I ask for your consideration Hon Minister in evaluating and making necessary changes for the benefit of our children. Apprenticeship is something our children can rely on, and I believe when they are well educated, the hiring of contract workers from abroad would not be necessary.

Thanks extended to the Samoa Qualification Authority. This past year they awarded \$300,000.00 to the National University of Samoa apprenticeship program. I am grateful to the Government in executing such organization to help qualified all forms of education on Island. It helps our children get the education they need and makes it easy for them to obtain a job overseas.

Mr Speaker and Hon Deputy Prime Minister Afioga Fiame I convey an opinion with the matter related to the signing of land contract with your Ministry. I understand the majority of this constituency village is part of it.

The agreements with the Ministry is first signed, and down the line the Samoa Tourism are in question of why a certain agreement was signed with specific Company before bringing it up to their understanding. I am stating....From my own understanding, the Office of Samoa Tourism Authority should be included. Because these are binding contracts with Samoa owned land, and I highly recommend the Ministry of Tourism to investigate overseas company who wishes to construct hotels on Island or any company with lots of money. Another aspect Hon Minister is the sand. Taking of sand from this constituency is a problem, would you look upon the matter with compassion in having a permit and how much an individual can take.

Hon Minister of Justice Courts and Administration, I acknowledge the Ministry for all the work done so far. I merely wish to recommend the process by which appeal cases waiting time. As a request, is it possible for the Ministry to speed up the process of appeal cases? Another aspect Hon Minister is the waiting time for court case decision. Some families wait for a year to hear the court decision, and this causes delay in family and land matters.

Hon Minister of Works, Transport and Infrastructure, I acknowledge the Ministry for all the work done to our roads. The road in Saanapu Hon Minister, part of the road is tar sealed and as if half tar sealed. This has an effect, with the other side being narrow and one being wide; it allows room for drivers to speed carelessly causing an incident.

This is the problem, but I will leave the matter to the Hon Minister to tar the whole road making it smooth for all to travel.

The registering of vehicles at the Land Transport authority, I am aware of how insufficient the spaces especially with the increased number of cars pass monthly. I ask the Hon Minister in considering allocating the task of passing vehicles to outside Company who are eligible for the job. Another aspect the machine is out of date. Nowadays there are new machine, I deem it will help with the work. Other times vehicle brakes are in good condition, somehow it comes back faulty.

Another aspect the taxi incident this passed Independence Day. Hon Minister I ask for your consideration in investigating reports on taxi drivers, for it brings shame to our nation. Luckily, it was not a tourist from off Island. I ask the Hon Minister of Police and Ministry for their thorough consideration on background checks before issuing a taxi driver license. This is the offender second crime; his license privilege should have been suspended. This matter is crucial Hon Minister, but I will leave it to your consideration.

The Hon Minister of Finance, I am grateful for the allocation of limited funds as seen in the Appropriation. Thank you for the Appropriation, I only have one question in mind to the Hon Minister of Finance in regards to the surplus seen in the budget year 2016/2017 in \$23million. Thank you Hon Minister for this surplus, a thought came to mind there should be a decrease in our loans with \$23 million in surplus. Another aspect with the surplus is it possible to allocate these funds for another Government development.

Mr Speaker, I take into account the work done by Hon Prime Minister and Cabinet in relations to developing our country and this constituency supports the Appropriation tabled before the House. With this I conclude, my dearest constituency I still remember the words Fonoti said to Toleafoa, even though my words are not heard anymore I will still speak in your name.

The respects put upon me I will cherish in my heart and will not forget. Whatever the struggles I will face, I do it in the spirit of God and together with the silent prayers of our constituency on decisions made for future development.

Susuga SEIULI UELIGITONE SEIULI (Sagaga le Usoga): Thank you Mr Speaker. I was waiting for the opposition to complete their speeches as this is the opportunity for maiden speeches. After all I made my maiden speech a while back. Since you want me to do another one I will gladly do so. I have received frequent text messages from my constituency, urging me to speak already. I fully recognize the support of Tutuila and Manua in all honorary saluation.

Talosaga and our children I do not care whether members will mock me but I want this parliament and the country to hear me thanking you my beloved and children. Whatever Gods will shall be done this maiden speech will be a testament to the government's eulogy of my expression of thankfulness to you and our children. For this has been a dream of mine, but with your support it has made this possible to achieve.

Last of my thanks is to my dearest mother Faimafili Moefaauouo Leleisiuao, thank you for your support and prayers. Your love is recognized, and your kindness is acknowledged. My heartfelt gratitude is beyond words to my constituency, and family for your trust in me.

I turn my attention now to voice concerns of this constituency to the Leader of the House and cabinet Ministers for this next parliamentary term.

Mr Speaker the explanation by the Hon Minister of Finance in regards to the Appropriation 2016/2017 "Strengthening the Foundations: Building for Tomorrow". This topic relates to the Main Estimates 2015/2016 which states "living within our means" emphasizing the importance of Appropriation 2016/2017 "Adjusting income and expenditure to create a solid economic foundation for the future."

Mr Speaker I do not intend to explain the situation of our economy, we do not have minerals or natural riches to sell in order to increase our revenue and to develop our country unlike other countries. This the reason I extend my appreciation, not only for the main estimate put forth to "strengthen our economic policies" and 'to prepare for tomorrow" with the purpose to fulfill the strategies laid out. Realistically speaking, the state of our economy cannot meet our needs, but we depend pretty much on God, through our Leaders, to lead to manage our demands accordingly, and to prioritize what needs to be done from time to time.

With this in mind, Palauli East will state its submissions to the Leader of the House, and Cabinet Ministers regarding the demands of my constituency for this next 5 years. Hon Minister of Finance, the constituency of Palauli East asks for your consideration in developing the township of Salelologa to create employment for the people of Savai'i. To avoid them from moving to Apia but remain in Savaii to cultivate the land for agricultural export and to finance their daily needs and support families and the church. Hon Minister of Works, Transport, and Infrastructure we request the upgrade of access roads for the villages of Vailoa, Vaitoomuli, and Faala.

I understand that exporting taro overseas is opened up once again. I trust that when these access roads are fixed, it will motivate people to work and cultivate instead of looking for work opportunity in Apia.

Access road in Afu Aau and beach road in Vailoa needs improvement for tourism purposes. It will not only provide income for families but also the economy.

The access road in Aganoa, Faala where there is great surf needs maintenance as well as street lights. It will be of great benefit to workers, tourist, and the local community when they commute.

Mr Speaker one last matter to the Hon Minister of Works, Transport and Infrastructure to take into consideration is the wharf in Vaitoomuli. When this structure was in operation it was very safe for travelling. We can also look at developing it for fisheries and tourism purposes.

To the Ministry of Education Sports and Culture, Mr Speaker every parent in Samoa shares the feeling of dismay with the problem occurring with students around Apia. The truth is any parent would be concern if their child is involved in a brawl. We as leaders are feeling distress at the disturbing scenes which is humiliating for our image as a country in the view of the outside world.

Mr Speaker I strongly support making the law that prohibits the corporal punishment of children void. I think we have all experience this from our parents, teachers and even the church ministers. Yet we are healthy and strong. There is big conflict with our beliefs and Christianity and this law that prohibits corporal punishment.

In Proverbs 13 verse 24 it reads "he that spareth his rod hateth his son: but he that love them him chasteneth him betimes." What is Proverbs teaching us? The principle is Chasteneth.

In schools children are more prone to misbehave towards teachers because of the no hitting concept. Hon Minister of Education, Sports and Culture Afioga i le Toetaufanua a le Malietoa, in the bible Mordecai spoke to Esther saying "who knoweth whether thou art come to the kingdom for such a time as this". I know you are not Esther, but what I'm stressing here is your serious consideration so as when this term is over the problem is no more because it is so humiliating to families, villages and the country.

The recommendation of Palauli East is to reintroduce the smacking of school children. I say this because 90% of our people are living in the true Samoan way in the rural areas and Savaii. and yet most of the children are living in this modern era of westernization whereby it allows them the freedom to do what they please. My other suggestion is to enforce the compulsory attendance of students at their college of residence, to avoid those attending schools in Apia. It is not only cheap for the parents but it is important that they are near their parents for direction and guidance rather than allowing them to Apia where they have no idea of what they get up to.

Mr Speaker I know the reason for parents to bring their children to attend schools in Apia due to the belief that all the good teachers are here particularly with science subjects. Our recommendation is why not establish a television for schooling. I recall back in the day, there were school programs on the radio every day that ran consecutively for different classes. This was done by Meki Stewart and Palagi Faasau and others. I would think that only a few of us in this House have not danced or sang along to the songs and mimicking the lessons that were taught then. I ask for your consideration in implementing similar programs to teach Science due to the limited number of teachers, that way, students in rural colleges and Savai'i can join in the learning. This is one way to handle the shortage of science teacher, and to keep children in their families, villages and constituency. It will also fulfill the purpose of the National broadband now in place.

Mr Speaker I now come to our demands in relation to schools and sports. First request is making the sports field at Palauli and Satupaitea College bigger like the ones in Apia in order to develop the talent and sport. Secondly is the construction of a Mini Gym to cater for sports such as netball, volleyball, and boxing since Palauli is where all college sports are held in Salafai. Thirdly, I ask for your reconsideration in opening up a school for those with special needs as there is currently no such school in Salafai and this constituency needs service. Fourthly, to the Ministry of Justice, Courts and Administration and Hon Minister of Justice I humbly ask for your consideration because families from Savaii have to travel to Apia for court hearings. This service was once in Savai'i. Some families have to find a place to stay when there matters go on for days and it is not cheap.

MR SPEAKER: Very well. The member has five more minutes.

Afioga TUIFAASISINA MISA LISATI LELEISIUAO PALEMENE: A situation that has become an issue is the constant delay of court cases and a lot of people are from overseas. Could a system be put in place to minimise the occurence of matters being put off to later dates since airfares are expensive.

MR SPEAKER: Did the member hear that he has five more minutes.

Afioga TUIFAASISINA MISA LISATI LELEISIUAO PALEMENE: Mr Speaker there are crucial general matters I wish to address. These are matters this Parliament must consider because of its effect and to ensuring peace and the development of our country. Collective rights verses individual rights: This matter was raised during a symposium we attended after being sworn in at the opening of this Parliamentary term. It was a matter in which there was an exchange between the Leader of the House and the Chief Justice.

What I gathered here was when a matter goes before the court decisions of village councils are never successful when it is in conflict with the right of an individual covered in the Constitution. The bulk of decisions made by village councils is for the benefit of the people within village communities. My immediate thoughts are, the Constitution prioritizes the individual rights rather than the collective rights. It has become a very challenging issue to me and it begs the question whether there is an avenue whereby the court will have equal consideration for both cases. So as to give a decision based on the reasons behind a final ruling by the village council. As of now there is no way a decision by a village council can win over an individual right. This is very similar to corporal punishment.

With 90% of our people living under the umbrella of our matai system and yet being dictated by foreign ways which prioritizes the individuals rights defeating consensus rule. Despite democratic system which our government is based on, there is regard for the right of the individual and the majority's will is done. It is similar to this parliament, although this opposition is not official our rights as members is uphold. When decisions are made consensus rule.

I will leave that with you hoping it will be thought provoking particularly in keeping the peace within village communities. The reality is the police will never be there in time, but it is the conviction of matais which ensures peace and tranquility keeping people safe. For that reason Palauli East supports the amendment of the Constitution to allow the court to view collective rights and the individuals in equal terms depending on the grounds of a decision.

Samoa is a Christian nation, and the conviction of the Leader o the House in regards to these matters, and also debate on the matter related to human rights of an individual has been made known. Mr Speaker a famous Samoan proverb – "E fua le kupa i le tai kupa, e saili le u i le tologa, ae fana le manu i le au-fue-ta." (work is measured by what happens from time to time).

MR SPEAKER: Very well. I ask that you conclude with your speech your time is finish.

Afioga TUIFAASISINA MISA LISATI LELEISIUAO PALEMENE: A famous saying by Napoleon Bonaparte the French military leader – "After analyzing the enemy then select your cavalry and measure the field." In truth, nothing comes to pass without a reason, and thoughts occur because of what has happen. Mr Speaker, this is where Peter reminds us as he has stated in 1 Peter chapter 5 verse 8 and 9 "Be sober, be vigilant; because your adversary the devil, as a roaring lion, walketh about, seeking whom he may devour, do resist knowing that the same afflictions are accomplished in your brethren that in the world."

Susuga Hon Laauli Polataivao Leuatea (Minister of Agriculture and Fisheries): Mr Speaker...

MR SPEAKER: Pardon the member for Palauli East, I call upon the Hon Minister for Agriculuture and Fisheries.

Susuga Hon Laauli Polataivao Leuatea: Mr Speaker I have no intention to interrupt the speech by the member. However out of sympathy to the Member he has stated his speech is also his eulogy. Therefore I move a motion, to extend the time of the member for a few more minutes to conclude his opinion.

This is the motion with respect.

MR SPEAKER: It is the intention of the Chair to prompt the work of the House, a motion has already been moved and seconded.

The House has not given unanimous consent to the motion.

MR SPEAKER: I advise the Member to conclude, for we have not yet reach Consideration of the Bill in which you will receive yet another half an hour, which is equivalent to two 15 minutes. I have regards to our deliberations and the fact that it is a maiden speech. No is above the rules stipulated in our Standing Orders. The thought is to our work, because it is a maiden speech. No one is above the law, but these are my thoughts put forth.

I apologize to the Member, your preparations is well organized but I am considering our work, but please do leave other matters for your two 15 minutes, I ask that you conclude.

With all due respect, thank you.

The floor is open to other Members who wish to speak. I recognize the Member of Faleata East who is also the Associate Minister of Health and it is his first Parliamentary term. All the best.

Afioga SALAUSA JOHN AH CHING (Faleata East): I stand with respect to the opportunity given. I will firstly acknowledge with awe and reverence our God in heaven in which Samoa is founded upon.

My compliments also to the clergy within the country for it are your solemn invocation to our Lord Savior which is evidence of the grace of the Almighty.

Mr Speaker I will now address the Appropriation now tabled before the House. First, I want to thank the Hon Minister of Finance and Government for preparations undertaken in putting together this information, I applaud the foresight and deep conviction that went into compiling this Appropriation 2016/2017. I also compliment the previous Government for your leadership; for it may have faltered the economy would be in a disaster. Yet our economic growth has surged by 1.7% within the last three years despite the effects of cyclone Evans. How wonderful is that? Now I am sure that we all desire our economy to continue in this manner and for us to commit to improving the economy every year. The guidelines set out by the Minister of Finance to regulate our economy in the coming year are simply great. As long as these guidelines will be on the same par as our dedication and also all government employees there should not be any obstacles to hinder our economic growth.

The report tabled by the Hon Minister of Finance on the 31<sup>st</sup> of May 2016 outlines the overall economy of Samoa. It seems our economy is doing well at the moment as well as our developments.

However, the state of our economy from time to time is deeply affected by global economic changes. A report from the International Monetary Fund will indicate the global economy to be slowing down in the 2016/2017 financial year. Therefore, we must prepare now, to protect ourselves from the effects of global fluctuations, so when it does happen we are prepared for it.

In saying that I congratulate the Hon Minister of Finance and the Government, for plans outlined to develop our economy so it may continue to grow. My view of the general preparations, it is appropriate for this time period, the quality of performance is measured by revenue, reducing unnecessary spending, encourage the development of private business and to improve the quality of government ministry services. Therefore, Mr Speaker, the Member for Faleata East gives its full support to the Appropriation 2016/2017 tabled. So what is the next step? We should all agree to commit to the strategies now in place. The motto that we should be harping on now is, perform, perform and perform. I like the intiative adopted by the Office of the Electoral in their public notices promoting their message to register and vote, register and vote, register and vote. I think it is the same spirit that we must follow now, plan and execute, plan and execute. This is the kind of motivation that should be shared within all Government Ministries and Corporations in light of the Corporate Plans and Strategic Plans, we will benefit from it if we carry out the work. There are times when there is too much planning then by the time it is executed the financial year is nearly over. There are also many other programs which have already been drafted and printed but it is put on hold because the person in charge will only launch it when he/she is satisfied. We cannot discipline the elite, Mr Speaker preparations are already in place within Government Sectors, which involves many stakeholders within each sector.

Therefore it is important to seriously hold regular stakeholder meetings within each Sector, to negotiate and implement all the planned activities, so that all matters are coordinated and in collaboration also to plan for better things in the future. We all know delaying what can be done now means further costs for future implementation. Every time a plan is implemented, that quality of service improves. The matter is for all of us to perform the public service as well as all the members, we have to be strong, our work is not easy also there is no one else we can be dependent on to do it, it is up to us. Now at the start of this new Parliamentary term there are less matters I want to comment on, especially for the development of our economy each year.

There are many Government developments but these are developments whereby the community and our economy's development is dependent on, which is our agriculture and tourism industry. I am aware that the Hon Minister and the Chief Executive are well aware and have the knowledge to tend to such developments. I just want to voice a word of encouragement and give blessings for the development of such areas, which is not easy, have faith and let us work together with the wisdom of God.

The development on our agriculture, Mr Speaker I know the Hon Minister of Agriculture and Fisheries have already implemented guidelines. Nevertheless I have a few recommendations I want to voice that can be used if not it is all right if they are returned. I know the initiative already took place and the answer was, it is quite difficult to carry out. Even though I know it is difficult but there is a reason why I have raised this matter again. If there is a chance to execute this matter this could mean another opportunity to revisit and consider this project. This is a reason, I talked with one of the elders from the western side of Upolu, he told me, we are very poor, and then I asked how about your land and your marine resources? He responded, 'we are not poor with food because we have a lot of food crops and fish.' The problem is, when I go and sell taro in front of the road there will be another person there selling his or her taro. Then we will both sit there and sell our taro together. The issue though if either one of us sells any taro one would have to exchange their taro for the others. This is the same if we were to sell fish; we really need the money so we can buy other goods needed for the family. We need to buy sugar, salt, soap, toothpaste, tooth brush also to pay school fees, cash power and for church donations. We cannot take a basket of taro to the church in exchange of money. We need money to give for such occasions for church and family obligations.

The main objective is, if the Government has a store or an organization where the farmers can go to sell their produce

The main perception is, if there was a Government store or any other organization where farmers could sell their crops, in return get their money, then the corporation can sell these produce locally and exported directly to overseas market.

I think previous discussions undertaken considered something called export authority but at that time the implementation of the matter was quite complex. There are a lot of new things now also the knowledge and skills of Government officials have greatly developed. How about changing this difficult situation to a much easier progress that will encourage farmers and fishermen to do such work, this will greatly assist us as well in increasing our foreign reserves.

The Ministry of Health first I want to thank the Minister, I apologize to Mr Speaker but there is one more matter I want to add to the matters mentioned for the Ministry of Agriculture and Fisheries.

MR SPEAKER: The member has five more minutes.

Afioga SALAUSA JOHN AH CHING: Another matter is our mobile abbatoirs to butcher cattle in a safe and hygienic environment. Our first market when this was done in the open was Tutuila. I believe we stopped the exporting cattle to Tutuila because of a Federal law and also because of the method used but now it is safer with these mobile abattoirs.

This is reason enough to review this matter and seek a market in Tutuila, which is close also with the exchange of the American dollars that will increase our foreign reserves. These minimal things will be added and eventually increase our foreign reserves. Let us not be tempted with bigger investments because if we add all these small profits it will accumulate to something big. The development of our health sector, first I want to thank the Hon Minister of Health, the Hon Prime Minister and Cabinet in choosing me as an Associate Minister for the Ministry. There are a number of new health systems that are being developed and if implemented, all will improve the quality of service especially in improving services of district hospitals. This includes first aid assistance be received within families and villages through programs such as primary health care. The main objective is to have the service close to where people reside. I am grateful to the Hon Minister and the Health Office on for initiating these plans all that is left to do is to implement these plans. One of the major problems seen within the services provided by the Ministry is the shortage of staff especially those with theknowledge such as nurses and doctors. This is the issue with such developments is the need for trained specialists also undertaking such courses takes up to seven years before you can become a doctor.

MR SPEAKER: I ask the member to conclude for your time is up.

Afioga SALAUSA JOHN AH CHING: Thank you. I will set aside the Ministry of Health. Lastly, to conclude I am grateful for the opportunity although I wanted to speak on our tourism sector but perhaps another day. I want to voice sincere thanks to some Ministers whereby some requests were voiced towards the Minister of Works...

MR SPEAKER: Thank you, it seems the Member took the floor to speak but unfortunately, the previous member has yet to finish. I ask the member to conclude his thoughts.

Afioga Aeau Peniamina Leavaiseeta: Is there an opportunity because this doctor...

MR SPEAKER: Pardon the member but there should be no interruption except from the Chair. This is the reason why the Chair is constantly trying to clarify but since you are the Associate Minister for Health, this is one reason why I was hasty. However, I ask that you conclude with respect the Associate Minister of Health. The member has spoken about the Ministry yet you are the Associate Minister.

Your time has concluded this is also why there have been queries made towards you. Therefore, with respect I humbly ask you now conclude.

Afioga SALAUSA JOHN AH CHING: Thank you Mr Speaker, I will now conclude. I will set aside these five papers for another day. I want to conclude with thanks to Mr Speaker and the whole of Parliament. I pray the Lord give you strength to administer this Parliament. I pray the Lord show his love to the Hon Prime Minister, Deputy Prime Minister and Cabinet, to all the duties that you will face each day. May the Lord show his love on the Parliament of Samoa, and hope to gain alot from this Parliamentary term and in future. Soifua.

Members of the House showed their appreciation by applause after the Member for Faleata East concluded his Maiden Speech.

MR SPEAKER: I thank the Member for his preparations voiced in his speech. Nevertheless it is important to note that each member is given a time of 30 minutes. Maiden speeches are carried out as a form of social etiquette, as for the orders of the day the first matter to consider is the Bill. Therefore I call on another member who wishes to speak. Perhaps we need two more members before we conclude with our time. Opportunities like this were usually pursued by senior members in the past, to speak last and then the next day at the start of the next sitting. These two opportunities are rare. Perhaps the Member for Salega East wants to take the floor.

Tofa Olo Fiti Afoa Vaai (Salega East): Mr Speaker the Finance Committee are silently showing its support and await the member to conclude his speech, then Salega East will take the floor.

MR SPEAKER: Alright I call upon the Hon Prime Minister.

Susuga Hon Tuilaepa Auelua Fatialofa Lupesoliai Lolofietele Aiono Neioti Galumalemana Dr. Sailele Malielegaoi: Mr Speaker we are trying to speed up the progress of our work since the country awaits the passing of the Appropriation so developments can be carried out. It would be best if the Chair chooses the member to speak, you have already called upon Salega, if he does not want to speak then his time is finish.

MR SPEAKER: Perhaps the Hon Prime Minister has reminded us of our Standing Orders, although nothing will restrict the Chair from making a decision to progress straight to the Government response and enough with member speeches, or the Chair choosing the member to take the floor.

I will give the opportunity to members I am concerned that I might change things but we should abide with our Standing Orders. It should be noted that this side of Parliament including Associate Ministers whether they speak or not they are all part of Government which is the Executive, and Board. After speeches are delivered it will make it easier for opinions to be referred to Government. I believe we only have the member for Falealili East left who seems to want to take the floor. I call upon the member for Falealili East.
