To my own belief, living in debt is free living. We Samoans can never be debtfree and I thank the Opposition Leader for the reminder because in order to live we must live an affordable life and that we must be able to repay our debts. That is...

MR SPEAKER: Pardon the speaking member, I recognize the Hon Prime Minister.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker, the member can take a rest whilst I say something briefly. Years ago when I was working in Europe, I went to make a loan to buy a vehicle to transport my family. I went with the mentality that if I wanted \$2000, the lady would say no \$1000 is enough. I would borrow knowing the vehicle I wanted to buy and the European would say how much borrowing do you want, I replied \$5000 because as commonwealth workers at the time, the duty fee was free compared to the value this vehicle is priced at \$15,000 for European people we worked together. I told the owner I wanted the vehicle for \$5000 and he would gazed at me shockingly, then he said that I would need to borrow some funds as the organization I was employed in had an account with their company. I asked if I can borrow USD\$200,000 he said no only \$5000. Therefore I do not have to loan \$100,000 that is unaffordable but \$5,000 is enough. The reason for sharing this talk is because the operations we have here is dissimilar to Europe. Never mind I wish to direct my talk to the statement of the Opposition Side and their reminder, no that is not true, the Opposition Side does not need to remind us as this is the Government's job, we make sure that we pay our debts. That is reason for this correction. We do not have to wait until we get the recommendations from the Opposition Side as we have policies in placeto guide us. That is the correction Mr Speaker.

MR SPEAKER: Well done, I give the Minister, Leader of the Opposition, I call the Hon Minister for Women...

Tofa Hon Tolofuaivalelei Falemoe Leiataua: Thank you Mr Speaker, the Hon Prime Minister has also highlighted some of the corrections in regards to the member's statement, nonetheless I know this member very well because he has affirmed his education and success such as his parents who told him to go and make the debt. Mind you the elders have more years about life, so they know about wise spending, if money is treasured in an old woman's box that means the money is there for a specific reason such as a funeral etc, whereas borrowing can be used in the meantime to survive.

So there is no reason to worry as the member's comment seems to derive from our viewpoints which means to say that he is faint-hearted about his debt when in my opinion, Paul is speaking directly about his book to Corrinthian when he was young and his transformation when he got old. Therefore the member's view is like that of a child and his given example which in this case, he is ineligible to give advise on economic distribution when he is a matured person who knows well and has money at home however, he lacks knowledge about wise spending because if all the money is spent and family matter arises, where then will he resort to? That is common sense, it can be done and debt repayment is going well. In my personal experience according to the story of the member, perhaps the store owner has a daughter whereby this lad is shy off. Otherwise, the member could be cheeky to the shop owner's spouse. Yes that is reality. This means that the member is not matured enough yet he has given an example when again he was told to go and make debt. That is the assistance, Lealailepule is my brother.

MR SPEAKER: Your viewpoint is well taken Hon Minister, did you want to say something Palusalue? Pardon me Lealailepule I give the chance to the Leader of the Opposition.

Afioga Hon Palusalue Faapo II: Thank you I second the opinion of the member is correct, even when he was small he still went and made debt which is something to be shy off whilst the statement of the Hon Prime Minister he rejects all the recommendations we give, that is what he said. But please the dumb can go on but it will come true, in the living testimony of Chronicles 1.1 and 2 million.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker that is why I prolonged my talk yesterday, if it's our borrowing, it will take 40 years of repayment. This is what the Opposition Side lacks even with debt's repayments that take 70 years. There is nothing to worry about and no one is talking about these things, even if you want to borrow from DBS which you could not, why? There is too much debt. As for the World Bank it is easier as evertime we want to loan from them, we can because there is enough. That is the intention but I do not reject your recommendations that are absolutely wrong. To be clear we do not wait for your recommendations, we already have set guidelines to follow and in accordance to government borrowings. This is the same guidelines that international governments comply with. But do not be hesitant. The problem with you Leader of the Opossition is that you cannot recall our exchanges, try and pick up the words we are saying.

Afioga Hon Palusalue Faapo II: Mr Speaker, I only wish to note down a few things because he (Prime Minister) is saying that the country is not affected.

What else is happening? People are seeing the Private Doctors and no one is complaining about it. *Although that is significantly high but nobody* is complaining, why complain when these are qualified professional practitioners who specialise in dental work

Afioga Hon Aeau Peniamina Leavaiseeta: Point of order, this is not a business it is the service to the people.

## Tofa LEALAILEPULE RIMONI AIAFI: Mr....

MR SPEAKER: I recognize Lealailepule.

Tofa LEALAILEPULE RIMONI AIAFI: Thank you for your interjections, if you can thoroughly receive my speech, it is wonderful. Even with our debts, I call it assistance that is to say it we cannot bypass it rather it must be affordable. The Hon Minister refers to it in a childish way but I do not intend to respond to it lest we deliberate on it. As for the example I gave about me and my parents, I am not ashamed of it, you see why I make loans lest something comes up yet. I have something in my account to fall back on because we did not have any lands before, we lived on a leased land, then we bought it, build a thatched house then a European house, bought a vehicle and all that. That is how a Samoan makes a living through a loan he makes. I have already talked with my mother, she said Lealailepule...

MR SPEAKER: I beg indulgence, I call the Hon Prime Minister.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Lest the member's intention is affected, no I too went through the same experience. Whenever I make a borrowing, I would be shameful to approach the daughter of the owner, so I too had that experience before. If I had to think deeply into that, the Minister is correct that you were also trying to attract girls attention whilst it is also correct that your parents had faith in you.

Rather these funds will help significantly with the country's developments and protection.

Mr Speaker, we must take heed of all this for our children and generations to come hence we must seek funds now for our protection and build roads to connect the two islands. We never know if time will tell when the island of Tokelau and Niue will come and live with us which means that our island could be a place of refuge for these tiny atolls like us.

Mr Speaker, we must also complete the Salelologa wharf. Most of the people from Savaii are moving in Upolu in search of jobs. We must ensure to create more job opportunites in Savaii to prevent people from traveling to and fro and to reduce the crime rate due to unemployment and issues like limited water supply, land and other requirements of life. Further on this Ministry, a lot have queried the forecast and the assumptions from one year to another. Everything is going well according to our set Government policies and procedures. In saying that, I speak specifically about our borrowings and expenditures. As such, I thank the Committee and the Opposition members for your courageous during our meetings and your support upon our requests through the Government heads and the Private Sector. I have also put up a request for our television coverage, water, roads etc. Never mind this five year term has gone really well.

Thank you Tuisugaletaua for the television telecast which has enabled us to watch the latest boxing match. Thank you also Hon Minister for Works for the water supply and the seawall area construction from Satitoa to Utufaalalafa and Saleaaumua.

Thank you also Hon Minister of Police for the new police vehicle that is often seen now in Lalomanu doing its petrol rounds for the district.

On to the Ministry of Education, I acknowledge Magele and the Chief Executive Offier Falanaipupu Matafeo for reviving our Faa-Samoa Cultural Programs and our tradition. I read an article last week by a very well-educated person on Christian and Chiefy values/beliefs which teaches our children not to talk back to their parents— and according to the belief of this author in last weeks' paper, the expression of a Christian and chiefly person is like that of Hitler or pictorial which means to say that children ought to learn how to talk back to their parents.

I have raised this very significant matter before, with respect, thank you to the Culture Division for reviving our old traditions which brings a very critical message which bears respect. I heed great appreciation to the Chief Executive Officer of the Ministry.

On to the Minister of Women, Community and Social Development, thank you specifically to those engaged with our fine mats weavers and the siapo making made from the u'a plant that is diffcult to grow in my village. Thank you also Faamoetauloa and the Natural Environment and surroundings in the country, the only request is the Lemafa road during heavy rain as some people are causing mud slides from the mountain causing huge rock slides burying the drainage and cuts on the road. That is the request if the Minister for Works can deal with this too, I heed that contractors must take good care of this to prevent anymore future problems with respect.

On to Afioga Lautafi, you have achieved one milestone and record set this morning, great job on the tents in our market witnessed this morning after 7 days which has lighten the burden for our market stall owners. I have received one question from one person on the highlights for this term.

MR SPEAKER: I recognize the interjection...

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: If you have observed, we have never interrupted your speeches, but we have no other time. This is the norm of the House. We must acknowledge those who must be thanked pursuant to our calling. If the Leader of the Opposition does not want to say a word of thanks that is fine, but I must say that some of these speeches have been well prepared. Therefore extending gratitude to the Constituencies is necessary for without the constituents we would not have made it to Parliament. There are times when we have our jokes but when it comes to expressing appreciation to our constituencies these speeches come directly from the heart hence we must not mock these speeches given our callings.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker no I do not mock these speeches, I said well done on all speeches because there are many significant issues in this Budget but I do not mock anyone, thank you.

Mr Speaker, as part of the Committee I only heed one thing and that is raising the pay for the Sui Tamaitai o nuu as this is what we have been raising as we draw towards the end of this term, the role of the Pulenuu is very vital and the duties they are performing is nothing compared to the salary they are getting.

Tofa Hon Tolofuaivalelei Falemoe Leiataua: Mr Speaker...

MR SPEAKER: I call the Minister of Women, Community and Social Development.

**Tofa Hon Tolofuaivalelei Falemoe Leiataua:** I heed appreciation to Mr Speaker, I rise with respect given the statement by the Opposition Leader on payments for sui o nuu.

I do not recall Palusalue speaking about the salary for sui o nuu or pulenuu. I wish to publicise the great response from the Sui o nuu and the alii ma faipule or pulenuu towards Government initiatives upon the awareness of new salary increment for the Sui Tamaitai o nuu. This reflects good governance for the sake of gender equality in the villages. The role of women or Sui o Nuu in the village is not light but critical. This is also the State's aim for both men and women to work collectively together although the salary of Pulenuu is still considered

higher.

For the information of the House for every special occasion such as Mother's Day or Father's Day, the Sui o Nuu and the Pulenuu would gather either here or Savaii to have a listen to Government's perspective from time to time. For this reason Leader of the Opposition, do not push the benefits for the sui o nuu or pulenuu. The Government attempts to balance up the work for both the Sui o Nuu and the Pulenuu based on their work and performance. We are therefore leaving no one aside as the support seen today is magnificent. The Government through its wise distribution will one day pour out blessings from God as the sun will rise again tomorrow upon each village communities who are engaged and developing themselves to lighten the burden for the State with due respect.

MR SPEAKER: Very well thank you, that is understandable.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker, that is...

MR SPEAKER: I call the Hon Prime Minister.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Well that is the clarification by the respective Hon Minister. I know what the member is referring to, this is corrupt practice at times like this and if I can recall the Women Council was only established 10 years ago which is nothing new.

This is Government principles such that pulenuu started it all off from the beginning although most of the work is also done by the women in the village. This is initially why the Women's Council was established like that of the Pulenuu. This is why we now have the Sui o le Malo in place with very small allowances in comparison to Pulenuu who have been in service for years perhaps since our colonial times under Germany whilst women council have just been set up yesterday to assist with women-related works and to assist with men's work and therefore, their work significantly contributed well to the village communities which had the decision to raise their allowance just a bit pursuant to the work they do, otherwise their allowance was never the same as the pulenuu, that is the explanation because according to your statement that is corrupt doing.

MR SPEAKER: I call the Leader of the Opposition.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker the meaning of my words is that I give gratitude for recognizing the women duties which is a raising level but we all know the role of Pulenuu which is not easy as they are the key network to the Government hence they play a very critical role. It is good to note that they (Pulenuu) will now have similar level or standard with that of women.

Susuga Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker, we do not need an order from the Opposition Leader. This is exactly what we call rubbish English but is married to a European. The Government is well aware of the Pulenuu payments and reward depends on the work that is achieved. We know what we are doing as we affiliate together, whilst you are trying from behind, that is how it is Mr Speaker...

Afioga Hon PALUSALUE FAAPO II: The reason for saying this is as the Pulenuu and I associate in the village community.

Susuga Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Why associate? Do you affiliate with the Pulenuu that is known as corruption.

MR SPEAKER: Very well, we now come to the end of our session, hence I ask the Leader of the Opposition, I will give you a chance but you must maintain order. The Prime Minister and the respective Minister have given their statements so that is final but until there is a different subjectmatter then you can carry on.

Afioga Hon PALUSALUE FAAPO II: Fine I will move on, but we do work together with the Pulenuu and the Sui Tamaitai o le Malo, so I understand this very well. Mr Speaker...

MR SPEAKER: Alright the Government has responded. Well.

Tofa Hon Tolofuaivalelei Falemoe Leiataua: Mr Speaker, the Leader of the Opposition's statement is quite harsh. It seems that he is collaborating with hundreds of pulenuu and sui o Tina ma Tamaitai for all village communities whilst he has only one Pulenuu and Sui Tamaitai for his village yet they should not be associating together. I heed the Prime Minister's statement that the Opposition Leader lacks insight of what he is talking about, that is called idle talk English. Despite you lacking knowledge however you still speak English conversely these are all hearsay which comes from the saying 'completely dead businesses'.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker the interjection is completely false, the reason for saying this is because I associate with the pulenuu and the Sui o tamaitai. I know what I am saying yet you are trying to insult my statements.

Tofa Hon Tolofuaivalelei Falemoe Leiataua: I note that the Leader of the Opposition is a mad person whilst the duties of the sui o nuu and the sui tamaitai o nuu is well laid out by the Ministry, that is their terms of reference and their job descriptions which is something you lack knowledge of. Secondly, these government positions were not made lightly, no we have Warrants of Appointment to be signed by the Minister and the Sui o Nuu and these certificates are kept well. Perhaps these certificates are much better than the Bachelors certificates. What for? This is Government recognition for the sui o nuu and the sui tamaitai which portrays the importance of their roles and duties. And nothing can breach this warrant except upon the advice by the Cabinet through the Minister.

Afioga Hon PALUSALUE FAAPO II: Pardon me Mr Speaker, I am not referring to any of this.

Afioga Hon PALUSALUE FAAPO II: The only thing I was correcting is that we collaborate together as member and Sui Tamaitai, I know it well.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker, I have eight matai titles from eight villages that is a total of eight pulenuu and eight Sui o Tamaitai whom we work together. In comparison to you, I know more than you. This is why it is good to have several matai titles.

Afioga Hon PALUSALUE FAAPO II: I will move away from this.

MR SPEAKER: Pardon me Hon Minister of Women, I am well aware of our discussion which refers to our recognition.....

**Tofa Hon Tolofuaivalelei Falemoe Leiataua:** I just want to assist the Leader of the Opposition who is my friend as I see that he is very heated. If I see Palusalue now, it is like looking at Nathan in the Philipines series. That lad is an irritating person only or unless he takes his pills with respect.

Afioga Hon PALUSALUE FAAPO II: You see these kind of interjections?

This is what our Parliament must consider for the next five years.

MR SPEAKER: I call the Hon Prime Minister.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Aiono Neioti Sailele Malielegaoi: Mr Speaker, not everyone is stupid. Despite you giving speeches like that, not everyone is dumb. Palusalue everyone is well aware of that doing, and they are used to it, and despite your attempts they will continue to do what they do. Despite your campaigns you will not earn any points from that.

Afioga Hon PALUSALUE FAAPO II: I will move on.

MR SPEAKER: Very well, that is the same advice from me move on.

Afioga Hon PALUSALUE FAAPO II: Thank you for the swift response on reopening new tents for the stall owners (at the market) this morning great job Hon Minister. I am in shock with the Prime Minister's statement about no funds for unforeseen expenditure. It has not been 6 months yet and now we are lacking funds.

MR SPEAKER: I will correct that matter. I call the Hon Prime Minister.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker, point of order. You see how you are part of the Finance Committee and yet you are now talking about it. This is very troubling what you have just publicized. You are simply making public information about the things you approve in your Committee which portrays your lack of knowledge and yet you continue to talk about it before our approval. I will....

Afioga Hon Palusalue Faapo II: Point of order..

MR SPEAKER: I will give you the chance afterwards.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: I will explain in further, the utilization of this 3% is allocated to Ministries on unforeseen expenditure that is the procedure in our Budget Statement. Now you officially restate it, what do you think is the intention of the country listening in? That is very disgusting, yet you started off by saying that you are part of this Committee. How can you sit in that Committee when I have given my statement yesterday? How can you be shocked? How can you be stunned when you are sitting in the Finance Committee? If I were you, I would conclude now before I make further mistakes.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker, The Main Estimates sets aside 3% for unforeseen expenditure which is equivalent to \$18million to \$20million. What about this fire. The Hon Prime Minister has made it clear that this is different from a Tsunami, cyclone, flooding and yet this was a fireblaze. It was an emergency.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: Mr Speaker, this is what you should have raised to get an insight. That is what the Ministry is working on and reason why you were appointed as Parliamentarian. This is why you were called into this Committee to spy on these things. You see how merciful we are because we have picked you to spy on Government undertakings and its problems. Whilst keeping an eyewatch on all this, we had allocated \$14million for unforeseen expenditure for all Ministries. That is it. The Minister has also laid aside fundings for natural disasters. You should have asked us, what is natural disaster? You respond to that.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker, you know the answer to that (.....) Hon Prime Minister.

MR SPEAKER: I advise the member, you should....

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: This is the only thing I cannot let the Opposition Leader bypass after accusing me of lying when I am talking about the Budget Statement under discussion.

It is best to say in Roman numeral under Section 1 which will discuss. The total regulated expenditure for the Main Estimates and the Appropriation is \$102million for all debts. \$487million for Proposed Expenditure and \$14million for unforeseen expenditure however only \$8.5million has already been approved and distributed from the Main Estimates. You see how troubling this is? If I was there I would have moved the motion, you are putting that Side into shame, and you should resign from your leadership role? How can you be a leader when you are mistaken?

It is upsetting for me to correct you when you are the Leader of the Opposition? Secondly, you are a former member of this Cabinet yet you should know better about these things.

Afioga Hon PALUSALUE FAAPO II: Mr Speaker I know that very well.

Susuga Hon Tuilaepa Fatialofa Auelua Lupesoliai Neioti Aiono Sailele Malielegaoi: No you do not get it. \$14million notes this because your constituency is listening in. This is very sad for your constituency, they are listening whist we are trying to correct you, when you are the Opposition Leader. This is very upsetting.

MR SPEAKER: Pardon me Palusalue let me make a statement. This matter has already been deliberated and broadcasted outside the House. For the records of the House, I think we ought to focus on the inside matters. I believe the word 'lie' should be removed from our Parliamentary transcripts as they are inappropriate to the hearing of the public.

I advise the Leader of the Opposition to move on as we must heed appreciation for the public's sake. I trust that Government response is final hence we cannot attempt to satisfy your want Palusalue. Your entire Committee took part in this too. Therefore I beg indulgence and your clarification is now well noted.

Afioga Hon PALUSALUE FAAPO II: I heed the Speaker and the Prime Minister about the withdrawn words which should also be applied to the words spoken by the Prime Minister otherwise, let the public judge as they need money, but thank you Hon Minister for the allotted \$1000 although this is not enough. In thought, allocate some funds for the public to loan from to start off their businesses.

MR SPEAKER: I call the Minister for land and market.

Afioga Hon Lautafi Fio Selafi Purcell (Minisita mo Galuega tau Alamanuia ma Atinae a le Malo): Interjecting the comment of the Opposition Leader. I have clarified this same statement during our meeting with the ones involved. However according to talks with Lealailepule earlier today, he affirmed that their Leader was not present buttook part on behalf of the Tautua. According to the explanation by the Prime Minister business operators can borrow from available funds secured under special terms and conditions by the collaborating efforts of the Ministry of Finance and the Development Bank of Samoa which you are not aware of, with respect.

That is the motion before we move on with our scheduled agenda.

Deliberations over the second reading of the Supplementary Appropriation Bill (No.1) 2015/2016 now resumed.

Susuga Hon TUILAEPA FATIALOFA AUELUA LUPESOLIAI NEIOTI AIONO SAILELE MALIELEGAOI: Mr Speaker I rise in accordance to normal proceedings of the House that I start before we carry on with Cabinet's responses in relation to the addressing matters.

Mr Speaker this is one of the unique Sittings we have today as it is the last one before Parliamentary dissolution. As such I have given my appreciation to all Parliamentarians for your great works this last five years through the State. For this, the State cannot do anything without the Budget and its Main Estimates. This is the only Sitting that is not limited to one's statement.

As such, this is Parliamentary freedom which speaks of the proverbial expression we are used to, *e le milia faauu upu o le Fono lenei*, meaning the words of this Parliament cannot be mixed together. This is the Sitting that discusses the Budget. Hence whatever mistakes the State makes the Opposition Side upstand to make corrections. That is Parliamentary norm as we also rise to make corrections and clarifications.

It is appropriate that we upstand as we are the decision-makers of the Government. The Opposition also plays their part in quering Government role which is the norm for any democratic state. It is freedom that expresses various thoughts to the State which is normal procedure. As for the Opposition for any raising matter you make, your freedom cannot be avoided. As for us we make correction and clarification as we speak of official transcript that is distributed amongst you as we are engaged with real life events and evidential records. The emphasis is for the public not to be misled by the State's doing. Whatever problems we have were not intended to occur as Sala did not order the Police to drive a vehicle to the fence. This is real life happenings at work such as the proverb to Faleata, 'e tetele a Pesega ae matua a i le oo. Whatever observations you have of us, we ask for your forgiveness and we shall do likewise.

That is why Samoa has a unique Parliament setting. I have visited and observed Parliamentary Proceedings in New Zealand and Australia which in contrast to us, we have our own culture and tradition as well as our Christian beliefs and values that upholds respect. Some Parliaments do not heed prayers anymore nor do they begin with a prayer, what about us? We cannot avoid our foundation as witnessed through God's merciful love through the several cyclones that struck us and have moved away all of a sudden. We have had two cyclones that hit us and suddenly moved towards the South. This is how we were saved as we see continuous raindrops bearing breadfruits and abundant food.

That is reason for our corrections as we heed the many blessings from God however I pity our own people who are saying we are poor which is not the case. The only result to this is a curse from God by which we will no longer bear breadfruits nor get any more rain.

Mr Speaker this evening we must heed forgiveness, the Members have started off with great aknowledgements for their callings as accorded by one of the members. Have you thought of going to Malua? It is great that some of you will make good pastors. Some of spoken in Samoan and English and this indicates indepth recommendation and knowledge you have got, well done and thank you for your comments.

Mr Speaker, earlier this morning we attended the lauching of the flea market and the Ministers have aleady been assigned to their duties hence whatever task given, that is up to the respective Minister and the Ministry responsible for a certain event.

Such is the appreciation to Lautafi and the staff given Cabinet's approval in executing all works through him and the corporations for this term and the several comments coming from within this House. This is appreciative to all those who are interested in this business ventures in the flea markets to seek wealth. Although they were given an allocation of \$1000, to note the Government has permitted a funding assistance of \$306,000 to the affected business operators at the flea market.

Since earlier today, the remaining balance is \$12,000 and the Hon Minister has also talked about negotiations with the Development Bank in carrying out this funding assistance. Notwithstanding the amount of \$200,000 that was spent on the entire project including the hiring and setting up of tents so that the setting was fixed swiftly. This amounts to over half a million of total expenditure. This is additional burden for the flea market operators to operate their businesses for the next two months.

This location was normal area for banana supplies the last 70 years that were taken to Matua and Tofua up until 1960, we were able to reach millions of tala from banana export before the beginning of the banana virus. This virus had affected our banana plantations greatly such as the taro plight we had and the rinocherous beetle that affected our coconut trees.

This is one of the talks we had with the Hon Minister of Agriculture to push for our coconuts which is one of Samoa's revenue earning in the future.

Mr Speaker, with the continuation of assistance for the flea market business operators, recalling back in 1989 when we had several store establishments and the many writings in the paper in 1982 when HRPP took over when all these outlets were scattered around within the vicinity of the town area, under pulu trees, in front of Morris Hedstrom store. During this time, the Ministry of Natural Resources and Environment was fully occupied in all sorts of engagement including so much waste which was an eyesore. This was the reason why we had an office setting opposite Morris that was easier to approach by the public. This was during Tofilau's time as Prime Minister and I would normally contact him for assistance upon the public. This was reason for the new market set up in Fugalei which was built specifically for agricultural products in 1989. From the old building to the new and current market solved the issue of floodings and waterflow given the lowlying location that we had before in Savalalo. Therefore the Savalalo market was then used mainly to display and sell handicrafts and items of that sort. The majority of our people would start small before they grow into bigger businesses on the belief that this is Government's intention to creating a Business Basis to train the business operators to grow their businesses other than the old business operators and before passing it down to their children especially those living in rural areas but have come to town to carry out their businesses. This is the commencement of business back in 1989 until now which started off in flea markets. This is reason the Government cannot avoid assistance for this type of development however some may take advantage of this doing by the Government and may end up burning the market again to obtain more monetary assistance from the State. That can happen as this world the seed grows together with theatres.

Mr Speaker that is the explanation of our work, we will begin with Sala before we will respond to further raising concerns. I then come to the motion to end my speech before we have our break as the time now is 7.00pm. For the appointments of the Council of Deputies we only have Afioga Tuimalealiifano on the list. The Government has long awaited and observed some of the paramount profiles in the country however, what is complicated is that the Ao o le Malo and the Council of Deputies have got to fulfill some of its duties given other engagements such as traveling abroad whilst the Chief Justice takes over when procedure has it that the Council of Deputies will only take over when His Higness O Le Ao o le Malo is out of the country. Such is reason that these positions must be filled given the Constitution as well as budget allocation for this paramount position.

This is reason that this Side has decided given its majority that this House has some of its senior members who can take over these notablesupremestatus and appointments from the two who will retire from their former positions as members of the Parliament of Samoa which is due time for them as pioneers of the Human Rights Protection Society for the past 37 years since the Fono Faavae and the establishment of this Party (HRPP). These are the most senior and last Jews of this Parliament who have served the Government and the country hence I now move the motion, that, the Legislative Assembly approves the Appointment of Tofa Honourable Tuiloma Lameko and Afioga Honourable Le Mamea Ropati to the Positions of the Council of Deputies.

Mr Speaker let that motion be approved before we have the official swearing in for the two Council of Deputies next week that is the official public notice to this

Parliament.

Mr Speaker, that is the motion.

Seconded by the Deputy Prime Minister, Minister of Commerce, Industry and Labour, Minister of Justice and Courts Administration, Minister of Works, Transport and Infrastructure, Minister of Communications and Information Technology.

The motion was approved.

The House showed appreciation by applauding, in accordance to the appointment of the Council of Deputies Tofa Hon Tuiloma Lameko ma le Afioga Hon Le Mamea Ropati.

Afioga Hon Palusalue Faapo II: Mr Speaker, any chance for me....

MR SPEAKER: Pardon me until we return from our break. We will now go to our evening break and resume our work pursuant to the motion.

I believe we have been re-energized from our break as we come to the final part of our session this evening. Such is the word of thanks to everyone, Hon Prime Minister and the Cabinet. During our break the Leader of the Opposition was speaking.

Afioga Hon PALUSALUE FAAPO II: Thank you Mr Speaker, respectfully I rise with dignity this morning. The House is well acknowledged with the presence of the Council of Deputies, Tofa Tuiloma and Afioga Le Mamea. Given the two appointed representatives and their services in Parliament, I heed appreciation Hon Prime Minister for your decision for them.

True is the saying, victorious successor. This is a new milestone which is similar to the appointment of the late Mataia. Well done. These two have taken over many dignified positions in Parliament including the Ministerial level. We pray for God's towards your calling may you find strength to take up your duties and roles in this Parliament.

Hon Minister of Police and Prisons, Chief in Command, I call upon you to start off with the Ministry's response.

Afioga Hon SALA FATA LISATI PINATI: Mr Speaker I rise on behalf of the Constituency of Gagaemauga No.1 to voice two comments given this last two Sittings, well done.

I am only a pathetic personalthough I assure you that everything I do is for the glory of God and most importantly our Constituency. As we near the elections I say we contribute and carry the heavy burden together. My only appeal is God's mercy to bind us together as I leave this seat but bear unity in mind, thank you.

MR SPEAKER: Very well thank you Hon Minister of Police and Prison. The House has heard all comments loud and clear. Well done on your works and perseverance for these past 5 years. We wish you well on the next Election.I wish the Hon Minister all the best and let us plead God's guidance for the upcoming Elections. We now come to the Hon Minister of Works, Transport and Infrastructure, Afioga Manualesagalala Enokati Posala it is now your turn..

Afioga Hon MANUALESAGALALA MATI TUIGAMALA ENOKATI POSALA (Minister of Works, Transport and Infrastructure): I see that the sun is about to set and so as the works of this Parliament. I wish to start off with the Water Authority and some of its huge undertaking projects since the beginning of this year with the assistance of the Government of Japan.

This project costs approximately \$36million including thedrainage for Tapatapao, Tanumapua, Falelauniu and other areas in Faleata. Other projects include the water pump in Alaoa so that water supply is sufficient for settlements in Magiagi, Moataa uta and Vaivase-uta. More improvement work continues for clean water catchment areas in Vailima, Tanugamanono and other areas in Motootua, Malifa and some parts in the town.

All this is for the purpose of improving water supply in the town area. This week the Bidders Committee submitted improved work for pipes installments from Aleisa to Faleasiu-uta, Fasitoo uta, Nofoalii uta and Leulumoega uta. Faleasiu Uta and Fasitoo-uta will have access to water supply from the fixed pipelines in their grounds. There is also hope that old pipeline connections will be reconnected from Aleisa to Lepale. This is the plan this year so that water is made available throughout the entire country.

Other ongoing projects incude the power supply generator at Samasoni, Fale o le fee and Alaoa. These locations were destructed in 2012 which had several assistance work done to it.On to solar energy has been under commencement. Government's target by 2017 is 100%. The works and negotiations of our solar energy companies is also being undertaken at the Faleolo area, similar to Tuanaimato. The same for Savaii solar systems, all negotiations have been undertaken. We have also dicussed the specific costs to power supply. This includes several other area like the restorage, battery restorage, which means that solar must be collected from the sun to be used in the night.

These are some of the ways that the Government has looked into in order to find cheap and accessible electricity given the price of oil that is now very expensive. Therefore it is not too long now before all this will come into existence. The improvement work for our Matautu wharf in conjuction with the Government of Japan will commence this year from 2016 to 2018. Government also has plans for the Vaiusu port in the future. The Shipping Services is also resuming its services in Tokelau, Manua andthe Cook Island. Well done on the undertakings for Mulifanua wharf and Salelologa wharf so the public could have better travelling between the two islands. The Land Transport Authority

MR SPEAKER: Pardon the Hon Minister, I allow the interjection of the member, I call Lealailepule.

Tofa Lealailepule Rimoni Aiafi: Thank you I give the Minister some rest but thank you for all the completed works and proposed projects as we move forward this year. The matter on Vaiusu wharf was relayed in our village meeting last Saturday. I request the government take heed of the village's intention so that both sides are insightful of this development and its progress. That is the plea with respect.

MR SPEAKER: Well done I get your comment. Pardon me Hon Minister I call Leaupepe

Afioga Hon Leaupepe Toleafoa Apulu Faafisi: Thank you I will be short and brief. I wish to extend sincere thanks to the Hon Minister, in the words of the Bible, it is in thought that you will the queen today as you will be the source of energy for the district. May God bless you and may you return after the election to resume your duties, Thank you.

MR SPEAKER: Well done.

Afioga Hon MANUALESAGALALA MATI TUIGAMALA ENOKATI POSALA: Mr Speaker...

MR SPEAKER: I call the Hon Minister to resume his speech.

Afioga Hon MANUALESAGALALA MATI TUIGAMALA ENOKATI POSALA: The raising concern by the member for Faleata West is not overlooked, when time is appropriate that is Government's intention. It is good to be transparent and accountable. Behind all this, we need more job opportunities and welfare by relying on Singapore for a separate try out. On to road upgrading, we are currently fixing a four lane road in Vaitele. As for the footpath area by the member for Faleata West, well we have conducted a survey in the past whereby one side is now being labeled a footpath area whilst the other side is specifically labelled for bus bay. Hence the other side is marked specifically for vehicles turns. With good labels and markings it should be clear for all. As for the bridge in Leone...

Tofa Lealailepule Rimoni Aiafi: Mr Speaker.....

MR SPEAKER: The member is not satisfied with the Minister's response.

Tofa Lealailepule Rimoni Aiafi: Very well, remember when a girl wears lipstick, both upper and lower lips are colored. Lest our work is a waste but note that this is located in the village opposite the church. I am not sure who did the survey but I should have been the one to do it. This is just like the train station in Shim Shuku that runs to and fro day and night. Remember the Catholic church starts services from morning at 5:00, 10:00 11:00 up to evening which is why these roads are always busy. This was questioned by the village this morning, so the road at Vaigaga is now upgraded on both sides. That is the request and hopefully the road in the village will be improved at another time.

MR SPEAKER: I get your comment.

Tofa Aveau Tuala Lepale Niko Palamo: Mr Speaker...

MR SPEAKER: Pardon the Minister I call Aveau...

**Tofa Aveau Tuala Lepale Niko Palamo**: I will be brief I wish to ask you if there is possibility in setting up a tricycle lane which is one way to avoid the busy traffic particularly for the areas from Vaitele to Apia.

Respectfully.

MR SPEAKER: Lest more issues is brought up but all those have been under consultations. The Minister has come across all that but safe is better than beauty. It is safer now. I too have raised the same. However as Aveau has made a mention - safety, therefore that is rightfully the footpath area for tricycles. I call the Hon Minister.

Afioga Hon MANUALESAGALALA MATI TUIGAMALA ENOKATI POSALA: Well thank you for the recommendations and we hope to carry all the executions up to the aiport area, which means that other recommendations will be left until a future time.

The Leone bridge will be closed on the 18th February for the contractors to begin constructions. The contractors has had several negotiations with the World Bank given that the project is single span and there are no columns below. Some of the criteria was seeing if a local contractor could take over the job however, the advertisement has gone abroad as we also need cranes to assist with this project. The deadline for this expression of interest is at the end of this month. The Vaiusu cross road is undertaking a layout design up to the airport and similarly, expression of interest for contractor to build is also in the pipeline. Similarly to Maliolio bridge, a review on a suitable company to take over this job is also underway. As recommended by the Prime Minister a better design must be drawn up to ensure an improved quality for this Maliolio road. The same goes for the cross island road. We have also completed improved works for pedestrian roads in Aleisa, Faleasiu, Fasitoo uta and Leauvaa. The Ministry will work towards completing all these unfixed undertakings. Mind you the Budget 2015/2016 is only 6 months now whilst normal works are currently being carried out for the roads. On to the Airport Authority, well you have witnessed the new undertakings that commenced last year for the passengers waiting area. There is hope that negotiations and assistance from the World Bank will presss through in order to carry out the landing area and parking area this year. As for the arrival area there is plans that this will take 18 months, hence these are all divided into phases. That is the plan for our airport.

As for the raising matter on grants and funding assistance, well that goes through the Ministry of Finance before it is being passed on to the Water Sector Budget Support that will help implement other developments like drainages etc. That is the overall objectives and developmental plans of the Government moving forward.

I also take this chance to thank the Government which is something my fellow member should have expressed given the achievements for our constituency. Never mind I will do it, I convey my gratitude to the Government Leader.

Afioga Hon Palusalue Faapo II: Mr Speaker.

MR SPEAKER: Go ahead.

Afioga Hon Palusalue Faapo II: I think the Minister has a problem with his hearing, you see how long I have noted a word of thanks to the Cabinet and the Prime Minister. We have served and worked together with these Members out of respect. How can you say that I have not given appreciation? The Prime Minister is well aware that I have expressed gratitude. I have not yet conveyed appreciation to the works held in the rural area but do not.....displeasing behaviour.

MR SPEAKER: Pardon me Leader of the Opposition. To save you time, I allow the deputy chairperson Tafua.

Afioga Tafua Maluelue Tafua (Aleipata Itupa i Lalo): Mr Speaker, pardon the Hon Minister. Mr Speaker I don't intend to interject your statement, but since we have five diseased from the road in Tiavea one by the adjacent road in Tiavea next to the Catholic church and four other on the same road. I am concerned that this matter has not been raised but we must be alert on these roads for the public's safety.

MR SPEAKER: I call the Hon Minister to resume his speech, pardon the Minister of Works, I callIfopo.

Susuga Ifopo Matia Filisi: Thank you Mr Speaker as we arrive to the end of this Parliamentary term. I wish to remind you that this Manono Tai road has been under survey but this is also not listed. I wish to remind the time for this project's completion as well as its commencement. Thank you.

Afioga Hon MANUALESAGALALA MATI TUIGAMALA ENOKATI POSALA: Thank you to everyone who have contributed today's discussion. The road at Tiavea is currently being improved and talks are underway to repair the bridge.

As soon as we received reports on this our engineers were on the task and conducted a survey. Temporary roads have been fixed for the public and according to the restructuring of this road, it must be fixed as according to the Engineers, the roads must be cemented well for the safety of the public. Bidding advertisement is also carried out for this Tiavea project to be constructed well, with respect.

For the wharf and infrastructure matter in Manono Tai, well anything before the House must have peseverence and patience. We cannot go back as continuing work is currently being undertaken, however we will look into better ways to implement this doing. We will not move any machines there rather there areother means of transport to Manono Tai.

Pardon the Leader of the Opposition as you were congratulating me when that is not enough, the Government has achieved so much for this term. This is why we should thank the Government.

Afioga Hon Palusalue Faapo II: Mr Speaker point of order, I wish not to complain as that is not new. If I am giving you thanks, then the same to the Hon Prime Minister and the Cabinet, you are too weak.

MR SPEAKER: I get you.

Afioga Hon Palusalue Faapo II: Our Constituency is noting how you are mistreating me, even you know that very well. Thank you Prime Miniser and the Cabinet, it is troubling that we are arguing in the House.

MR SPEAKER: I get you Leader of the Opposition. Very well, I recognize the Minister of Natural Resources and Environment.

Tofa Hon Faamoetauloa Lealaiauloto Ulaitino Faale Tumaalii: Thank you Mr Speaker, this seawall area is leased under the PPCR program as funding has already been used up to build the entire seawall up to the hotels. As for what you are referring to, it seems that it is affecting the coastal settlements. That is listed under another list as soon as the funding is available.

MR SPEAKER: Well done, I call the member for Faleata West.

**Tofa LEALAILEPULE RIMONI AIAFI:** My duty is to speak up in regards to anything involving Faleata. This is the first time I have heard two Members disputing against the developments of the district. By your permission Mr Speaker, is it alright if I could come sit next to my fellow member, we sit too far from each other but I want to assist and advise him with respect.

Afioga Hon Palusalue Faapo II: Mr Speaker the member is talking HRPP already.

Afioga Hon MANUALESAGALALA MATI TUIGAMALA ENOKATI POSALA: This was not mentioned in the member's statement which is the reason for the reminder lest he forgets the works that was executed by our Government. Thank you Hon Minister of Health for the Health Care Centre in Saanapu which is a good initiative as the constituency is now split into two. This is the centre for the constituents of Siumu, Safata East, Safata West, Salamumu and Lefaga. Government has further improvement works in the future, I also extend appreciation to the Hon Minister of Agriculture for the many farming development programs and farming methods the farmers have received such as wheelbarrows and tools to develop the lands. Thank you Hon Minister of Women for the independent water source in Sataoa, Lotofaga Niusuatia and Vaiee. These major projects were excuted during our term. Appreciation also to the Hon Prime Minister and the Government for the inner roads in Sataoa, Saanapu and Nuusuatia, Lefaga, Salamumu, Safata up to Siumu.

This is one area that is under beautification. A few water supply is found in Tafitoala, Saanapu under the Water Authority. Appreciation to the ongoing works for our electricity and roads.

I also appreciate my time under your leadership Hon Prime Minister for this term. Five years of sweat and education and the push for more developments and job creation for our country, thus thank you for being true to our country. Lest I forget the support of my Constituency in all your honorifics.

Thank you for having faith in me and all your support and prayers. Thank you God for this calling most particularly being under the Prime Minister's leadership. We have succeeded in this calling. I am only a weak and lowly person. I came across today's theme in the CCCS daily service program which says"The best is yet to come" in the book of Phillipians 3 there is a verse that goes, "Brethren, I do not count myself to have apprehended but one thing I do is forgetting those things that are behind, and reaching those things that are ahead." I think this is a very good challenge for this Parliament. I also heed appreciation to the Chairperson and the Board of Director, Chief Executive Officers and all staff I worked with.

To the Lands Transport Authority, Samoa Shipping Corporation, Samoa Ports Authority, the Electric Power Corporation, Samoa Water Authority, Ministry of Works, Transport and Infrastructure, great job on your peserverence and dedication. Today's message says it all, the best performance for tomorrow is doing your best today'. If today goes well then so is tomorrow. Well done to the government and its great plans for the future.

I also take this opportunity to extend great thanks to the Hon Speaker for the job well done. I believe God has all the strength and power to achieve all tasks and duties. Well done also to my fellow member, the Leader of the Opposition, Afioga Palusalue Faapo II of Safata. Well done Tautua. At times we have our tensions, I do not intend to sit and relax whilst you are struggling. But I do beg for your forgiveness. I have pleaded forgiveness many times in this House which is the main spirit, nonetheless I am still waiting for your respect in return.

May God bless everyone and our Sitting today. I recall the final words of Tuitele to Lilomaiava in the island of Salaia. "Come and go and may your path be blessed' God bless.

It is now passed 9.00 and therefore we should stop here. Let us plead God's mercy upon us so that we may reconvene tomorrow. I also heed Samoa's support and prayers upon this Parliament this time of the evening. This is why we were called to fulfill our duties for the betterment of Samoa tomorrow.

Thank you for your support. Thank you also everyone for your contributions today and hope that we will meet again tomorrow in good health and spirit.
