MR SPEAKER: I announce the dignity of the Legislative Assembly that I have received the Notice from the Political Party of the day to officially appoint Afioga Tuimalealiifano Vaaletoa Sualauvi II to the position of O Le Ao o le Malo.

Pursuant to Article 18 (5) (a) of the Constitution of the Independent State of Samoa, I table the Appointment Notice of the O Le Ao o le Malo before the Legislative Assembly.

Article 18 (1) of the Constitution provides the approval of the O Le Ao o le Malo by the Legislative Assembly, upon the advice of the Ruling Political Party of the State.

I put the Question before the House as follows: - Whether the Assembly approves the Notice for the Appointment of Afioga Tuimalealiifano Vaaletoa Sualauvi II to the position of O Le Ao o le Malo

Motion approved on the appointment of Afioga Hon Tuimalealiifano Vaaletoa Sualauvi II as the O Le Ao o le Malo by the Legislative Assembly for the next 5 years.

MINISTERIAL STATEMENT OF THE HON PRIME MINISTER SUSUGA HON TUILAEPA AUELUA FATIALOFA LUPESOLIAI LOLOFIETELE NEIOTI AIONO GALUMALEMANA Dr. SAILELE MALIELEGAOI

Susuga Hon TUILAEPA AUELUA FATIALOFA LUPESOLIAI LOLOFIETELE NEIOTI AIONO GALUMALEMANA Dr. SAILELE MALIELEGAOI (Prime Minister): Mr Speaker and distinguished Members of the Legislative Assembly of the Independent State of Samoa. I greet Samoa in all its honorific salutations. I greet and acknowledge the Governor of the Territorial State of Tutuila in all its honorific salutations. I further acknowledge the supporting prayers of the Servants of the Lord.

The appointment of Afioga Tui Aana as the O Le Ao o le Malo marks a new and significant chapter in the history of Samoa and the next. On behalf of the House, we wish to express our congratulations to Afioga Tuimalealiifano Vaaletoa for your appointment. He was a former Police Officer, a graduating lawyer and was later appointed as the Member of the Council of Deputies for over 20 years.

After the passing of Malietoa Tanumafili II in 2007, the appointment of the O Le Ao o le Malo had the name Tuimalealiifano twice in a row on the voting process from 2007 to 2012. However, it was unsuccessful, this was the will of God, to endure patience; you were not destined to undertake the role of O Le Ao o le Malo at the time. The main belief of this Parliament is that, all callings are from God. As such, he had endured patience and had continued this role as the Member of the Council of Deputies. Twice the time this House had approved the appointment of Afioga Tui Atua to undertake the role of the O Le Ao o le Malo of Samoa and this appointment expires on the 25th of this month. Based on the secret whisper and in accordance to the Constitution, God has called the decision of the Legislative Assembly and the Human Rights Protections Party.

I further acknowledge Afioga Tui Atua Tupua Tamasese for undertaking the O Le Ao o le Malo role and service with great dignity for the past 10 years. There is belief you still have the urge to serve our country through any way. Well done to you. No doubt you have served the Government of Samoa for many years through the various notable positions of the State, as a Member, Prime Minister, Member of Council of Deputy and O Le Ao o le Malo. Only God can bring Success through your country Samoa.

The O Le Ao o le Malo election process was conducted using the normal democratic practice. It was not an easy process given our small size and that all lineages are connected. It is no wonder everyone is related in Samoa.
