INTERNAL AFFAIRS AMENDMENT BILL 2021

Explanatory Memorandum

Summary:

The Bill seeks to amend the Internal Affairs Act 1995 ("Act"). The objects of the Bill are:

- (a) to remove the duty of consulting the village Fono on the removal of their Sui o le Nuu on grounds as listed in the Act but still required the Chief Executive of the Ministry to "inform" the relevant village Fono for the nomination of a Sui o le Nuu; and
- (b) to provide for the due process to be followed for the removal of a Sui o le Nuu under the Act. In particular, to provide for the principle of natural justice in the said process such as the right of a Sui o le Nuu to be heard on a question of the revocation of his appointment, and to provide a response to such question.

(b) providing for due process for the removal of a Sui o le Nuu under the Act. More specifically, the proposed amendment to section 14 of the Act provides that a Sui o le Nuu must be informed promptly of his or her removal from office and the reasons for such removal must also be provided. A Sui o le Nuu before his or her removal must also be given the opportunity to submit a response or reasons against his or her removal from office.

A BILL INTITULED

AN ACT to amend the Internal Affairs Act 1995 (Act).

BE IT ENACTED by the Legislative Assembly of Samoa in Parliament assembled as follows:

1. Short title and commencement:

This Act may be cited as the Internal Affairs Amendment Act 2021 and commences on the date of assent by the Head of State.

2. Section 14 amended:

In section 14 of the Act:

- (a) in subsection (3), for the *proviso* for "consult" substitute "inform"; and
- (b) after subsection (3), insert the following new subsection (3A):

"(3A) A Sui-o-le-Nuu who is removed from office must be:

- (a) informed promptly of his or her removal from office and the reasons for such removal; and
- (b) given the opportunity to submit a response or reasons against his or her removal from office and to have their case reviewed.".
