AN ACT to provide for amendments to Boards of Public Bodies and related purposes. [28th January 2020]

**BE IT ENACTED** by the Legislative Assembly of Samoa in Parliament assembled as follows:

### 2 Miscellaneous (Boards of Public Bodies) 2020, No.6 Amendment

### 1. Short title and commencement:

This Act may be cited as the Miscellaneous (Boards of Public Bodies) Amendment Act 2020 and commences on the date of assent by the Head of State.

### 3. Consequential amendment:

The Public Bodies (Performance and Accountability) Act 2001 is amended by inserting after section 15 the following new section:

### "15A. Board may request attendance:

A Board of a public trading body or a public beneficial body may request the attendance of a Chief Executive Officer or General Manager of a Government agency for the discussion of any matter before the Board.".

### 4. Transitional and savings provision:

(1) A person appointed as a member of a Board for a public body included in this Act is at the commencement of this Act considered a member for that Board until his or her term expires, or until he or she is replaced.

- (2) A person appointed as a member of a Board for a public body included in this Act is at the commencement of this Act entitled to any benefit promised to him or her at the commencement of the member's term of office when his or her term of office expires.
- (3) The commencement of this Act does not invalidate any decision of a Board made.
