2. Definition

REGULATIONS

- **1. Citation and commencement** These Regulations may be cited as the Casino and Gambling Control (Fees) Regulations 2013, and commence on the date they are signed by the Head of State.
- **2. Definition** In these Regulations, unless the context otherwise requires:
 - "associated person" means a person with significant influence who is a chief executive, senior manager or senior employee of the casino;
 - "certificate of approval" means a certificate of approval issued under regulation 3;
 - "employee" means an employee of a casino other than an associated person.
- **3. Certificate of approval**-(1) No person may be employed in a casino as an associated person unless the person has a certificate of approval issued, upon written application, by the Authority.
- (2) No person may be employed in a casino as an employee unless the person has a certificate of approval issued, upon written application, by the Authority.
- (3) A person who contravenes subsection (1) or (2) commits an offence and is liable on conviction:
 - (a) for an associated person, to a fine not exceeding 10 penalty units; and
 - (b) for an employee, to a fine not exceeding 5 penalty units.
- (4) A casino licensee that employs a person without a certificate of approval commits an offence and is liable to a fine not exceeding 50 penalty units.
- **4. Fees**-(1) Fees for the purpose of the Act are set out in the Schedule.
- (2) The casino licence fee is payable pursuant to section 36 of the Act.
