REGULATIONS

1. Citation and commencement - These Regulations may be cited as the Business Licence Amendment Regulations 2018 and commence on the date of assent.

- 2. Regulation 2 amended In regulation 2 of the Business Licence Regulations 2012 ("principal Regulations") insert in its alphabetical order the following new definition:
 - ""beneficial owner" means any natural person who ultimately owns or controls any person on whose behalf a transaction is being conducted and includes any person who exercises ultimate control over a legal person or an arrangement.".
- 3. Regulation 4 amended After regulation 4(d) of the principal Regulations, insert:
 - "(e) a person that has been issued a licence under regulation 3(b), (c), (d), (f), (g) must notify the Commissioner in writing when there has been a change of ownership to the company at least 14 days before the transfer takes place.".
- 4. New regulation 7 inserted After regulation 6 of the principal Regulations, insert:
 - "7. Business Licence Particulars The following particulars must be provided together with an application for a licence:
 - (a) Site map of business location;
 - (b) Legal form of identification with a photo of applicant, shareholders or directors where applicable;
 - (c) Beneficial Owner (ultimate owner) of the business;
 - (d) Bank account of business to show evidence of capital of funding of business;
 - (e) Company Certificate of Incorporation (if applicable);
 - (f) Partnership Agreement (if applicable);
 - (g) Deed of Trust (if applicable);
 - (h) Foreign Investment Certificate (if applicable);
 - (i) Applicable license fees;
 - (i) Health Compliance Certificate (for business involves fast - food and related activities);
 - (k) Samoa Tourism Authority Confirmation (for tourist accommodations and related activities);
 - (*l*) **Oualifications/Credentials** (for specialized professions);
 - (m) Ministry of Finance Licence to operate Petrol station (if applicable);

- (n) bingo licence issued under the Gaming Control Act 2017 to conduct bingo (if applicable).".
- **5. New Schedule inserted** After new regulation 7, insert:

6. Savings - Any business licence fee collected by the Ministry from 1 January 2018 is validated as if it were collected under these Regulations.
