#### I. WARRANT OF ELECTION

Pursuant to Section 84(2) of the Electoral Act, Mr Speaker read out the Warrant of Election signed by the O Le Ao o le Malo for the following members:

## II. Swearing in of New Members of Parliament

Mr. Speaker asked the Members to be upstanding while he reads out the Code of Parliamentary Ethics

## Standing Order 15. Code of Parliamentary Ethics:

#### STATEMENT OF INTENT:

It is the personal responsibility of every Member of Parliament to maintain the highest standards of ethical behaviour to protect and maintain the integrity of Parliament and to make every endeavour to uphold the principles of the Constitution. The following principles are intended to provide guidance to, and standards against which each Member of Parliament, individually and collectively should discharge their duties and responsibilities.

#### THE PRINCIPLES:

- (1) Loyalty to the nation and its people:
  - Every member shall uphold the contents of the Oath of Allegiance at all times and maintain the dignity and integrity of the Independent State of Samoa; its institutions and its people.
- (2) Respect for the Law:
  - Every member shall uphold the laws of Samoa and safeguard the principles contained in the Constitution.
- (3) Respect for all Persons: Every member shall treat other members, the public and officials with respect and dignity, honestly, fairness, and acting with integrity at all times.
- (4) Proper Exercise of Power:

Every member shall:

- a. Arrange their private affairs;
- b. Use any and all information obtained from their public office; and
- c. Exercise any influence or authority obtained from Public Office, only to advance the public interest and where any potential and actual conflict of interest arises whether in the member's private, financial, pecuniary or any interest the member shall be required to declare that interest and take any steps to remove the conflict or withdraw from the particular process of transaction.

## SPECIAL REQUIREMENTS FOR MINISTERS AND OTHER OFFICEHOLDERS:

Every member who holds Parliamentary office of any kind is required to adhere strictly to the principles outlined above and shall not under any circumstance undertake any decision or exert influence in any form whatsoever in respect of a matter in which the member will derive personal gain or benefit.

#### **SANCTIONS:**

Breaches of this Code maybe dealt with by the Privileges and Ethics Committee or as determined by Parliament.

The Speaker called upon the 3 Members to be upstanding as he reads aloud the Oath of Allegiance.

# III. OTHER ANNOUNCEMENTS BY MR SPEAKER

Mr. Speaker acknowledged the swearing in of the 3 Members then greeted the Cabinet and all Members of Parliament. He acknowledged all Government Ministries and Corporations as well as, all public servants for their service to the country. The Speaker also greeted the Ao o le Malo and his good lady, Council of Deputies and his good lady and Samoa in all its honorific salutations.

The Speaker touched on the Courts decision regarding the temporary suspension of the Members for Lepa and Faleata 3. He then highlighted that the court decided for both members to resume their duties as Members of Parliament to represent their respective constituencies. The Speaker noted that although the functions of the 3 Arms of Government do not overlap, Parliament respects the decision of the Judiciary. Mr Speaker mentioned that Parliament has appealed the matter as it requires thorough analysis, as it affects Parliamentary ethics and privileges. As such, this appeal is with the Court and it will be reviewed in the upcoming month. Therefore, until then this matter is with the Court and Parliament will touch on it once the appeal case is finalised.

Mr Speaker then acknowledged the delegation from the Parliament of Tasmania present in the House; the delegation is led by the President of the Upper House Hon. Craig Farrell, Speaker of the House of the Assembly, Hon. Mark Shelton and Hon Members of both Houses and the Clerk. He conveyed his appreciation to the delegation through Samoa and Tasmania's twin parliament partnership by assisting our Parliament with capacity building for Members as well as the Parliamentary staff, as well as assisting in various ways that have benefit Samoa's Parliament.

Mr. Speaker then addressed another matter, he stated that on 30th August 2023, he was made aware of charges against the Member for Sagaga 1, regarding a breach of Standing Orders, constitutional provisions and relevant sections of the Electoral Act 2019. Pursuant to Article 46 of the Constitution and Sections 141-143 of the Electoral Act 2019, Mr Speaker has reason to believe that the Member for Sagaga 1 has in fact breached the law when absent from proceedings of Parliament for a period of more than 3 consecutive days without proper excuse. Mr. Speaker Called upon the Member for Sagaga 1 to be upstanding to respond to the charge laid on him.

# Afioga Hon. LOAU Solamalemalo Keneti Sio, Member – RESPONSE

The Hon. Member Afioga Loau Solamalemalo Keneti Sio acknowledged Mr Speaker and the House, then responded by saying that he had already discussed the matter with Mr Speaker before, however, it seems, Mr Speaker is not satisfied with the reasons he had made known to him and that he has not moved on from this matter. Therefore, the Hon Member conveyed his heartfelt apologies for the situation and respectfully rejected the charges laid against him for the reasons which he had made known to the Speaker.

Mr. Speaker acknowledged the Member for his response and reminded the House about relevant Standing Orders that prohibits deliberations on such matters.

#### IV. OBITUARY SPEECH

Mr Speaker delivered an obituary speech for the former Member of HRPP, Lafaitele Patrick Leiataulesa who was first elected as a Member of Parliament during the 14th Parliamentary Term (2006-2011) and re-elected in the 15th Parliamentary Term (2011-2016) for the electoral constituency of Alataua West. He served Parliament as:

- Member for Education Committee in 2011
- Member for the Electoral Committee in 2006
- Member for Police etc Committee 2006-2011
- An Associate Minister for Minister for Revenue from 2011-2016

Mr Speaker then called upon the House to be upstanding and observe a minute of silence as a gesture of respect for the late member.
