		provided by third Parties and transactions on behalf of the
		State as set out in the First Schedule.
Clause 3:	-	authorises the reduction of \$294,120 earlier appropriated
		for particular Ministries and Departments as set out in the
		Second Schedule and re-appropriates such funds in the
		manner as set out in the First Schedule.

- **<u>First Schedule</u>:** provides the sums authorised to be expended in clause 2(1) as appropriated to the outputs or sub-outputs to be delivered by individual Ministries and Departments, outputs provided by third parties, and transactions on behalf of the State.
- **Second Schedule:** provides the outputs and sub-outputs from which amounts earlier appropriated are to be reduced and the outputs and sub-outputs to which amounts earlier appropriated are to be re-allocated.

A BILL INTITULED

AN ACT to authorise the issue and application of certain sums of money out of the Treasury Fund to Ministerial and Departmental outputs and sub-outputs, outputs provided by third parties and transactions on behalf of the State for the Financial Year ending on the 30th day of June 2022 ("Financial Year 2021/2022").

BE IT ENACTED by the Legislative Assembly of Samoa in Parliament assembled as follows:

1. Short title and commencement:

- This Act may be cited as the Supplementary Appropriation Act (No.2) 2021/2022 and is read together with and forms part of the Appropriation Act 2021/2022 ("Principal Act").
- (2) Section 2 and the Schedules relate to Departmental outputs and suboutputs, outputs provided by third parties and transactions on behalf of the State for the Financial Year 2021/2022.
- (3) This Act commences on the date of assent by the Head of State.

2. Grant and appropriation of \$11,600,000 out of the Treasury Fund:

(1) There may be issued out of the Treasury Fund and applied to outputs or sub-outputs to be delivered by individual Ministries and Departments, outputs provided by third parties and transactions on behalf of the State for the Financial Year 2021/2022, sums which do not exceed in aggregate the sum of \$11,600,000 inclusive of the amount appropriated under section 3. (2) The sums authorised to be expended under subsection (1) are separately appropriated according to the outputs or sub-outputs to be delivered by individual Ministries and Departments, outputs provided by third parties, and transactions on behalf of the State in the manner specified in the First Schedule.

3. Reduction of amounts earlier appropriated and re-allocation to other outputs and sub-outputs:

- (1) The Principal Act is amended by authorising the reduction of the amount of \$294,120 from the Ministries and Departments listed in according to the amounts set out in the Second Schedule.
- (2) The amount of \$294,120 is appropriated and re-allocated to the Departments and Outputs in the manner specified in the First Schedule and are in addition to the earlier appropriations.
