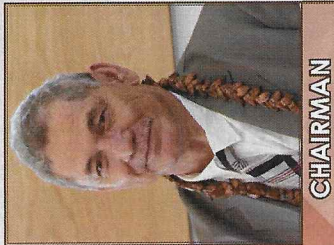

Responsible for the overall review of financial management in all Government Ministries and Public Bodies and Examine and report on the Public Account.

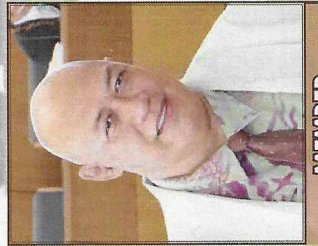

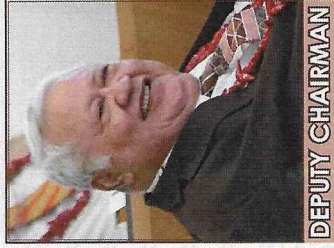
